EXECUTIVE DIRECTOR ELIZABETH LINT: Good
morning. This is the meeting of the Pole and Conduit Commission, 831 Mass. Ave, basement conference room, Thursday July 16, 2005 at 10:06.

Before you are Commissioners Chair Andrea

Jackson, Bill Dwyer, and Steve Lenkauskas.

The first two matters NSTAR, Eversource, are continued as they are unable to be here.

## PETITIONS (CONTINUED)

NSTAR - ALBANY STREET AND AMES STREET

SUPERINTENDENT OF STREETS WILLIAM DWYER:

There may be a representative.

BEN LAVERY: I'm here for Boston

```
Properties. I was waiting for them to come here
as well.
```

    EXECUTIVE DIRECTOR ELIZABETH LINT: They
    are not.
SUPERINTENDENT OF STREETS WILLIAM DWYER:
They are not going to make it. The
representative is not going make it from
Eversource.
EXECUTIVE DIRECTOR ELIZABETH LINT: I'm
sorry. I just found out.
BEN LAVERY: Thank you.
CITY ELECTRICIAN STEPHEN LENKAUSKAS: In
regards to that petition, we would be glad to
have it on the record.
CHAIR ANDREA JACKSON: If you could
please come forward, have a seat.
BEN LAVERY: I was asked to come and
support so $I$ don't have all the documentation.
CHAIR ANDREA JACKSON: State your name

BEN LAVERY: My name is Ben Lavery. Ben L-A-V-E-R-Y. And I'm with Boston Properties. The Ames Street temporary transformer relocation, if you will, is part of the enabling work for the Ames Street Residential Project.

And $I$ know that they wanted us to come,
but maybe I'll explain one thing in terms of the project as a whole. It is a project that
received Article 19 approval at the end of March,
and it is a project that involves a disposition
agreement from the city and quite a bit of
enabling work around the site. There are a
number of utilities that will go under what will
be the future building pad location.
For that reason we are moving forward
with some of the utility relocation work, I'll
call it, as a broad term, without getting into
all the specifics, in order to establish the

```
site, so the true building, construction, and
demolition can occur into the fall.
    And there will be more utility work that
occurs next spring when the weather is favorable
for that.
```

    And the project is really a 24-month
    project from March next year going forward.
So the petition really is to do the work
in the street, place the transformer out in the
public way. It is an early step for the enabling
work, it is really a primary step given the
location of the transformer, and just to mind
you, those who may not be familiar with the site,
the transformer is behind a serpentine wall, near
Mead Hall, so it is kind've tucked in the corner.
Beyond that, in the absence the
NSTAR/Eversource crew, I'm not sure I can offer a
whole lot more.

KOSTA JOVANOVIC: Good morning,

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Good morning.

KOSTA JOVANOVIC: Good morning, Ms. Lint.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The
first petition is for Node $N 017$ for an extension
of Verizon-leased conduit for manhole 26/36 on

Albany Street to Verizon manhole 26/36a, then
rising on an untagged pole, proceeding aerial to
and ending at the untagged pole at the
intersection of Albany Street and Cross Street and attachment of equipment on that tagged pole Node NO17.

KOSTA JOVANOVIC: What we were missing
the last time was the break-out from the Verizon
manhole to the pole to start the aerial run.

It is seven feet of trench. You can see
after we cross Mass. Ave, come out of the manhole 26/36a, go to pole 23, and then proceed down Albany Street to Cross Street.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That's not a riser pole on that 23 , is it?

Is there a pole survey for that one?

KOSTA JOVANOVIC: There is for 25. They
haven't put it on. They haven't put it on here.

I see it for pole 25.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I
would like to check that pole prior to -- I would
like to move to continue.

CHAIR ANDREA JACKSON: Motion's made to

abutter notifications. For this one, for Node 30, we had 35 abutter notifications.

CHAIR ANDREA JACKSON: Can $I$ see the ones
you have?

KOSTA JOVANOVIC: Uh-huh.

EXECUTIVE DIRECTOR ELIZABETH LINT: This
is not what we have in our packet. This must
belong to another one.

CHAIR ANDREA JACKSON: The Node numbers
at the top don't even match.

EXECUTIVE DIRECTOR ELIZABETH LINT: Yep.

This is for Node 79 in the packet.

KOSTA JOVANOVIC: There must have been a mix-up.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Was
it within the same packet?

do have that one as a smaller one.

KOSTA JOVANOVIC: This branch is
important because it feeds two other nodes that's also part of this petition.

Your package should have a sheet that has
a colored page.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We should have a site meeting prior to any approval on this one, Steve, to see how it lays out, if we have to go with the whole dig, to see how it lays out in the street.
Flagg Street and Putnam Ave, there's two
sewer manholes, one drain and one sewer manhole, and they are the deepest manholes in the city.
That's critical. And with the other work
going on right down the street and things of that
nature, $I$ would move to continue and do a little
bit of engineering on this and have a site
meeting out on the site.

CHAIR ANDREA JACKSON: That's your
motion?

feed for NOO1, NO51 and NO14, which is an
extension of existing aerial fiber from the
intersection of Hews and Callender street westerly
to pole 13, then a new conduit along callender Street, turning southerly on Putnam Ave, plus or minus 293 feet, then aerial for the length of Hingham Street, then northerly along Banks Street, then westerly on Akron Street to Memorial Drive. Have you gotten your approvals from DCR? KOSTA JOVANOVIC: We have been working
with them from September of last year and it
looks very favorable.
CITY ELECTRICIAN STEPHEN LENKAUSKAS: You
haven't received their approvals yet?
KOSTA JOVANOVIC: We responded to an RFP
that included statewide locations, five in this
project, and 23 in another project that we're
working on.
The latest is there was a delay on their side because they had a new commissioner and the last correspondence is they made their decision and moved it up to the commissioner for approval.

I have the underground portion of the larger.
And if you would like -- I was trying
adhere to the requirement of submitting

8-and-a-half-by-11, but if you would like the petition plans larger, $I$ can do 11-by-17.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I'm
fine with the 11 -- I mean the

8-and-a-half-by-11.

This being the first pole I'm concerned
about this being a primary riser. It looks like there's four conduits going up that pole on the pole On Hingham Street. Or, I'm sorry, not Hingham Street but the pole on Callender Street. Typically, it is the first -- I would like to move to continue. We need to check this out a little further, especially the first pole on Callender Street being a riser pole already having four conduits existing. KOSTA JOVANOVIC: Okay.

First petition, which has been continued from previous hearings Cambridgepark Drive and to place approximately 12 feet of underground conduit, 2, 4- inch PVCs from an existing Verizon manhole, No. 2697 to 165 Cambridgepark Drive for service to the new building. I believe this was continued to verify that all the proper permits had been pulled with DPW and other departments and also that there was a third one installed for the city.
EVERETTE BRYAN: I spoke with our
contractor work supervisor and he said he worked

already. So we couldn't go to the either of the
first two poles. He has to go to the third pole
