POLE AND CONDUIT COMMISSION MEETING

EXECUTIVE DIRECTOR ELIZABETH LINT: Okay.

We are going to get started.

It is a meeting of the Pole & Conduit Commission, Thursday July 21, 2016 at 10 a.m., in the Michael J. Lombardi Building, 831 Mass. Ave, Basement Conference Room.

Before you are the Commissioners Chair Nicole Murati Ferrer, Bill Dwyer and Steve Lenkauskas.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I make a motion to approve the minutes from the June hearing.

CHAIR NICOLE MURATI FERRER: Second.

SUPERINTENDENT OF STREETS BILL DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:
Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Aye.

The first petition is City of Cambridge
electrical department for Prospect Street, 299
Prospect Street. Come forward please.

Hold on one second.

Are there any residents that might want
to speak on any particular petition?

BETTY SACCOCCIO: On any particular
petition?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Yes.

BETTY SACCOCCIO: No. 28.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Want to come forward.

I'm sorry, Larry.

BETTY SACCOCCIO: I would also like to
speak on No. 27.

SAL DIDOMENICO: Sal Didomenico,
D-I-D-O-M-E-N-I-C-O.

CHAIR NICOLE MURATI FERRER: Is Mobilitie
here?

BRIAN GROSSMAN: Yes.

MOBILITIE

CHAIR NICOLE MURATI FERRER: State your
name for the record and spell it as well.

BRIAN GROSSMAN: Brian Grossman,
G-R-O-S-S-M-A-M. Counsel, Anderson Kreiger.

As you know, at the last meeting, the

board, obviously, put this on their agenda because you need to discuss in open public meeting, but our understanding from that meeting, and confirmed the other day, was that all the Mobilitie petitions may be discussed amongst the board members in terms of what types of information the Commission either felt would be needed and requested and further discussed at the August hearing.

I was here to monitor the discussions. I have my own notes so I could get a jump on what the Commission may request.

But based on our understanding from the Commission, that these would not be discussed in depth or substantively at this meeting.

CHAIR NICOLE MURATI FERRER: Yeah, I mean, my recollection of this is we thought it was premature because we didn't know if the city

had okayed the fact there were poles, isn't that right?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yeah, I did meet with the law office in the past week. In regards to the petitions, there was a number of them that were on city poles.

BRIAN GROSSMAN: Correct.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And with further discussion, it wouldn't be a decision from this Commission to allow you to put anything on a city-owned pole.

Prior to coming to us, there would be some sort of agreement with the city, before you come to us, for permission to install the equipment on the pole.

And that was for petition 16, 17, 18, 23, 24, 27, and 21 because those all involved city owned poles.

BRIAN GROSSMAN: I believe that's correct.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Then there was -- and the other petitions, which were 20, 21, 22 and 26, they were on wood poles, which are utility-owned poles and that would go through the normal procedure with talking to the utilities after you had come to us for permission to do so, and that would be discussed at the August hearing also.

And the one remaining one was on Granite Street, I believe, it was petition 19, and that was a request for an additional pole on -- in the public way, which would also be in the same category as the wood pole and would need to be discussed further.

BRIAN GROSSMAN: That's my recollection as well.

But our understanding was that all of that would be discussed at the August meeting.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Correct.

CHAIR NICOLE MURATI FERRER: Okay.

I mean, we'll hear from you since you are here but all of this, like we said -- we had put it back because we were going to get more information in terms of the city-owned poles and everything else, which is why it's on the agenda.

I mean, if you want to say something now, that's fine, but we'll hear the petitions in August.

SAL DIDOMENICO: I just want to show you a picture of one of the poles that he claims that is nice and sleek and beautiful.

This is the one on Marion Street. It is

not very sleek and handsome, some of the junk that's on there.

He showed us the other side -- when you take a picture, the way you want to take a picture, it looks very nice and clean. There's nothing clean about that one. That's a wooden pole.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That's a different type of installation.

I think the one that you were concerned was a metal pole.

SAL DIDOMENICO: Right, but I'm assuming it has to be the same equipment in order to do the same job.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That's what they're proposing but that needs to go through local -- you know, city hall, city manager, and some sort of agreement with -- if it

came to that point, with rent or lease of city property, and then it would come to us.

SAL DIDOMENICO: Oh.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This Commission can't approve rental of city property or lease of city property.

SAL DIDOMENICO: Okay. I just want to show you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yeah, that's a different installation, which is up and running now on a wood pole.

SAL DIDOMENICO: It is a wooden pole.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And

that would be the type of equipment, I believe that, or similar to it.

SAL DIDOMENICO: He claims -- whatever I saw in his picture, it looked like this wonderful pole that was all painted silver, pretty-pretty,

and all that good stuff. It's not pretty-pretty.
I'm not worried about pretty-pretty.

I'm concerned about what is radiating
from these little things on here because I have
grandchildren who live upstairs from me, which
are maybe -- maybe seven, eight feet from the
pole and that's where they sleep, right there,
right at the bedroom, right there, and I don't
want anything to happen to my -- I don't have any
extras, by the way.

CHAIR NICOLE MURATI FERRER: Thank you.

BETTY SACCOCCIO: And I would like to
comment on that also is the fact that we have
been having problems with getting approval from
the electric company regarding a pole that's
outside of our church to get the wires capped or
whatever so that we could have windows restored,
our historic windows and whatnot.

We didn't know when the city gave permission for the electrical company to do this with the big bucket and whatnot, but what we're finding is that any time anything needs to be moved, the burden goes on the owners of the property, the onus is ours even though the sidewalk permission is given by you people, that we can't even have anything fixed until we come up with funding to have this removed and then reinstalled and whatnot.

And this has been going on with Eversource and you people, and you know, at this point we're at a standstill for a historic preservation.

A lot of our housing in the area is under historic preservation, or should be, or we're requiring it to be, or requesting it to be, at this point.

And also there's a petition here, No. 27, which I am concerned about because the gentleman from the One First, which is the old Durant building, the candy factory, on Otis and First Street there, he said he doesn't want it outside his condos, so move it to Cambridge and Third where the bank is, so, therefore, then I look at it from Otis Street because I'm on the corner of Third and Otis.

So is this a question of big money talks to the city again and the little homeowners are really up the creek. So it's like we are trying to figure out what is happening with all these petitions. And yet, we haven't even been notified that there's a request to have something moved, so you know, where are we in this process?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Your -- you haven't received for a request for something to be moved on --

BETTY SACCOCCIO: It's Cambridge and Third. And the gentleman who came from One First, the LLC, from One First had said he didn't like this, this proposal, so it would be the burden of one of his condo owners to have it outside of his building. But why should it be the homeowners who have lived there all their lives and paid taxes to the city all their lives, why should it be our burden to see it?

And also, we're on some streets that really don't have that many wires and there are only a few of them, and I -- granted that part of Second Street doesn't have wires, other than maybe one or two, but then the next part of it is unbelievable with wires and same is true of Third Street but Otis Street is not that way.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Uh-huh.

BETTY SACCOCCIO: The part I live on.

And those wires are awful.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: In regards to that one petition that you are speaking about, that's a city-owned pole and that hasn't gone through the process yet.

This is all part of this process that we're talking about and we will listen to any concerns going forward.

When it does, and if and when it comes to us, after all the provisions have been made and the city, beyond this board, makes a decision to allow a company to attach stuff, if they, in fact, do attach something to a property or a city-owned pole. So if that person didn't agree with that being installed, even the movement --

they would need to send another notification and change of petition to move it to your location, or close to yours, and you would be notified to come and speak at the hearing in regards to that.

So it wouldn't be -- it wouldn't be a fact where they are going to move it here two blocks away and you wouldn't be notified. You would be notified if you are an abutter.

BETTY SACCOCCIO: Well, the city uses very loose terms for "abutters" also.

CHAIR NICOLE MURATI FERRER: With all due respect, I wouldn't call them loose terms. I would call them the legal terms.

BETTY SACCOCCIO: Well, no. The city decided their legal terms for abutters.

CHAIR NICOLE MURATI FERRER: No, I think Black's Law Dictionary decided it.

BETTY SACCOCCIO: No, no, no. And

although we are diagonally across from them, if there's another building, then, you know -- we are diagonally across from them so we should be notified.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Would these petitions --

CHAIR NICOLE MURATI FERRER: For these petitions, is legal abutters, which means any -- it means front, back and sides that is touching. So if they are diagonal and across the street, they don't get a notification.

BETTY SACCOCCIO: That's right.

CHAIR NICOLE MURATI FERRER: Thank you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Thank you.

CHAIR NICOLE MURATI FERRER: So my understanding is that we'll hear the petitions that are on the wooden poles in August. The ones

that are on city poles are tabled.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Until we get something back.

CHAIR NICOLE MURATI FERRER: Until we get something back from the city.

SAL DIDOMENICO: Would I be notified by mail?

CHAIR NICOLE MURATI FERRER: I'm not quite sure where you live, sir.

SAL DIDOMENICO: 720 Cambridge Street and my building in the back is 434 Cardinal Mederios.

CHAIR NICOLE MURATI FERRER: Isn't that --

BRIAN GROSSMAN: That's a steel lag pole.

CHAIR NICOLE MURATI FERRER: Yeah, so that one won't be discussed in August.

So none of the ones that relate to

city-owned poles will be discussed in August.

We don't -- if they get an agreement with the city, they will be discussed.

But at that point, based on the timeline, I'm assuming a new application would have to come in because now this application would be over three months old, so ...

SAL DIDOMENICO: I will be notified supposedly.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: If it is a new petition.

Just a quick question for Mobilitie.

In relation to the whole scheme of your project, I mean, if one or two of these are not allowed, does it makes sense to go forward with the others?

Or, do you need the whole network up and running?

SAL DIDOMENICO: No. Unlike some of the other proposals you've had where they are all interconnected by fiber, so one node relates to the other, while they're all working on a citywide problem, they are all, in terms of, from a network standpoint, they are standalone because of the way Mobilitie does its back call, so they are not interconnected by fiber. One does not depend on the other.

So the steel light pole nodes can be separated out from the other ones.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: If you were to get approval for one of these petitions, you could go forward and it would still be a benefit to your company.

BRIAN GROSSMAN: Correct.

CHAIR NICOLE MURATI FERRER: Thank you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

State your name.

JIM CLARKESON: Jim Clarkeson.

THE REPORTER: Sir, you have to spell your first and last name.

JIM CLARKESON: J-I-M C-L-A-R-K-E-S-O-N.

Representing One First 426, LLC, and I'm here -- I was at the last meeting about the poles.

I brought some pictures of the pole that impacts me. I don't know if that's any help to you.

CHAIR NICOLE MURATI FERRER: So I think you missed the beginning of the meeting.

We are not discussing these petitions today. We put them on the agenda because we need to discuss them at an open meeting.

I apologize if the agenda was not clear as to that.

But the ones that are not on city-owned

poles, the ones that are on wooden poles, or proposed to be on wooden poles, those will be discussed in August.

All the ones that relate to metal poles, which are city-owned poles, those have been tabled indefinitely until such time we get a determination from the city as to whether or not they are going to lease those to Mobilitie.

If the city leases them to Mobilitie, Mobilitie will submit an application and then we'll hear testimony on it. If the city does not lease it, then bye-bye.

JIM CLARKESON: So you are saying I would -- in that case, I would receive a notice.

CHAIR NICOLE MURATI FERRER: If you are a legal abutter you would receive a notice, if they do get a lease from the city on it.

JIM CLARKESON: Okay. Because I -- can I

just quickly show you pictures just. So you can see from the window, there's a city-owned pole. Here is the distance from the building.

CHAIR NICOLE MURATI FERRER: Yep. Yep.

JIM CLARKESON: The front of the building, a large building. And there's no way you wouldn't see or hear that because hear the sound they make is disturbing people. Another picture. And then I have a map to indicate there's a parking lot here, a fire station here, and there's a T station here. Lots of ways you could find a pole, probably a living pole but that would move this farther away from people. And I have this as well.

CHAIR NICOLE MURATI FERRER: Thank you. Thank you all very much.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Anymore residents that would like to speak on any

petition?

Seeing none, we'll call back the City of
Cambridge electrical department.

CITY OF CAMBRIDGE ELECTRICAL DEPARTMENT

PROSPECT STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

First petition is for Prospect Street, City of
Cambridge Electrical Department, saw cut
approximately 80 linear feet across Prospect
Street and sidewalk to excavate and install a
2-inch PVC conduit for a new fire alarm municipal
circuit to be installed at 299 Prospect Street.

SUPERINTENDENT OF STREETS BILL DWYER:

DPW is fine with this.

Typical conditions.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I
need to abstain.

CHAIR NICOLE MURATI FERRER: So motion to grant?

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CHAIR NICOLE MURATI FERRER: Granted with typical conditions.

EVERSOURCE - DONNELL STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Eversource?

This is the second petition on today's agenda. This is Donnell Street at Kelly Street and westerly from pole 215/3, a distance of 33 feet of conduit.

This work is necessary to supply power to 9 Donnell Street.

JACQUI DUFFY: So it is underground service across the street.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Okay. Are you doing the work or is the developer doing the work?

JACQUI DUFFY: We are.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

There's another petition coming up for Comcast later on. With proper separation, can they use the same trench?

SUSAN BARROSO: They can.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So coordinating with -- I make a motion to approve -- oh, I'm sorry.

SUPERINTENDENT OF STREETS BILL DWYER:

No. DPW, we met and we're fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I make a motion to approve with coordination with Comcast to use the same trench crossing street to the same pole.

SUPERINTENDENT OF STREETS BILL DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All

in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

CHAIR NICOLE MURATI FERRER: Do we want

to say the one with Comcast --

ANTHONY VATALARO: No. 12.

CHAIR NICOLE MURATI FERRER: No. 12. 426

East First Street.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No.

12 would be 9 Donnell.

Do you want to hear that?

CHAIR NICOLE MURATI FERRER: No, I meant

make sure to refer to it, petition No. 12.

EVERSOURCE - BRATTLE STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 3 for Eversource also.

This is Brattle Street easterly from manhole 2739 thence turning southerly approximately 30 feet east of Sparks Street, a distance of 35 feet of conduit.

This work is necessary to provide service to 134 Brattle Street.

JACQUI DUFFY: They have direct buried cable and we are upgrading the service of this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And that's all in the grass and in the crossing?

JACQUI DUFFY: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The grass strip on the sidewalk.

JACQUI DUFFY: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

There's nothing in the street?

SUPERINTENDENT OF STREETS BILL DWYER:

Public Works is fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: On
the motion to approve with typical conditions?

SUPERINTENDENT OF STREETS BILL DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

CHAIR NICOLE MURATI FERRER: And the
previous one also has typical conditions, right?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Correct.

EVERSOURCE - FIRST STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 4, which is Eversource for First Street at Linskey Way and northwesterly from manhole 2162 continuing on Linskey Way to manhole 29054, a distance of 425 feet of conduit.

This work is necessary to provide service to 50-60 Binney Street.

50-60 Binney, that's the building pretty much completed on the corner?

SUSAN BARROSO: That's 100 Binney Street. The other one is before. This got approved before. I guess it expired.

JACQUI DUFFY: We got approval in 2014, we had to reapply.

SUPERINTENDENT OF STREETS BILL DWYER: I don't believe there's any issues with this.

Public Works is fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
There are poles still on that street. I know there's some concerns getting those poles out of there.

SUSAN BARROSO: I think they are working on that now.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
There's work orders to do that?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Motion to approve with all typical conditions?

CHAIR NICOLE MURATI FERRER: Second.

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All

in favor?

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

EVERSOURCE - UPLAND ROAD

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 5 also Eversource for Upland Road, easterly from manhole 1230 and turning southerly approximately 110 feet west of Mass. Ave, a distance of about 20 feet of conduit.

This work is necessary to provide service to 1868 Mass. Ave.

This transformer is going on the property?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Right inside there?

JACQUI DUFFY: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Just the transformer or switches?

SUSAN BARROSO: Just the transformer.

SUPERINTENDENT OF STREETS BILL DWYER: We
need a landscape plan with this one?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

(Pause.)

SUSAN BARROSO: I think the building
would be built all the way to the property line
and the transformer will be in the corner in the
back.

SUPERINTENDENT OF STREETS BILL DWYER: In
back corner?

SUSAN BARROSO: Of the building, yeah.

SUPERINTENDENT OF STREETS BILL DWYER: We

are fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to approve with all typical conditions?

SUPERINTENDENT OF STREETS BILL DWYER:

Seconded.

CHAIR NICOLE MURATI FERRER: Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All

in favor?

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

EVERSOURCE - EDWIN H. LAND BOULEVARD

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 6, this is also Eversource. Edwin

Land Boulevard northeasterly from manhole 3297

approximately 250 feet northeast of Rogers Street, a distance of 175 feet of conduit.

This work is necessary as part of Crown Castle project.

This is DCR jurisdiction. I don't know that we can give -- grant a location but we typically would like locations.

SUPERINTENDENT OF STREETS BILL DWYER: We need notifications from DCR --

JACQUI DUFFY: Okay.

SUPERINTENDENT OF STREETS BILL DWYER: -- prior to our approval.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Motion to approve pending DCR permitting and authorization?

SUPERINTENDENT OF STREETS BILL DWYER: Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11

in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

EVERSOURCE - RINDGE AVENUE

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 7, also Eversource. Rindge Avenue at Clifton Street and west of manhole 2833, a distance of about six feet of conduit.

This work is necessary due to the relocation of the Cambridge Housing Authority entrance.

Is this for a traffic signal?

JACQUI DUFFY: Yes.

CHAIR NICOLE MURATI FERRER: For the

record the agenda says six feet but it is actually 16 feet of conduit, correct? On the agenda it says six.

JACQUI DUFFY: On the agenda it says six?

CHAIR NICOLE MURATI FERRER: Yeah. I want to confirm it is 16.

JACQUI DUFFY: Yes, 16.

CHAIR NICOLE MURATI FERRER: I just want to confirm.

JACQUI DUFFY: Yes, it should be 16.

CHAIR NICOLE MURATI FERRER: Okay. Thank you.

SUPERINTENDENT OF STREETS BILL DWYER: Public Works is fine with this one.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Do you require a -- typically require a disconnecter means before the traffic signal, a hand hole?

SUSAN BARROSO: What was the question?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Do you typically require a hand hole prior to the meter socket as a disconnect means?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: That would need to be installed by the contractor?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Prior to?

SUSAN BARROSO: Yes. Because we bring the cables to the hand hole and --

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And the meter socket is the owner's responsibility?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You need to make them aware of that. I believe the conduit is -- it doesn't show it.

There's also a streetlight that was relocated there, it has since been removed and cut off. And the city would like to re-feed that into that same hand hole if that's not an issue. It's just a streetlight.

SUSAN BARROSO: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Motion to approve with all typical conditions?

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:
Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Aye.

EVERSOURCE - LEE STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 8, Eversource, for Lee Street,
southerly from manhole 3078 approximately 100
feet north of West Street thence turning
southeast on West Street, a distance of 33 feet
of conduit.

JACQUI DUFFY: This one was approved. We
had to go down a little further down the building
and we just had to get it in.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So
this was approved other than the extension going
a little further down the street?

JACQUI DUFFY: Yes. Yes.

SUPERINTENDENT OF STREETS BILL DWYER:

Public Works is fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to approve?

CHAIR NICOLE MURATI FERRER: Second.

SUPERINTENDENT OF STREETS BILL DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

With all typical conditions. All in favor?

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

EVERSOURCE - BINNEY STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Petition No. 8, also Eversource, for Binney
Street.

CHAIR NICOLE MURATI FERRER: 9.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No.

9. I'm sorry. At Third Street and westerly from

manhole 3062, a distance of about 695 feet of conduit.

This work is necessary to provide service to 17 Cambridge Center.

CHAIR NICOLE MURATI FERRER: We got an email from the director of engineering services at Public Works that Eversource has been doing the work and had started three years ago and that you are currently in negotiations with MIT for, I guess, this area, and can we get a schedule update for the Binney Street is what they are looking for.

What is your schedule on this?

JACQUI DUFFY: I have no idea.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I think the jobs in question were the traffic signal at Binney Street and Second. The traffic signal at Binney Street and Third and I think it

was the overall finishing up of the work in that area.

SUSAN BARROSO: To the overheads on the ground?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The two traffic signal locations are temporarily fed and they are waiting for -- I believe there's work orders and they are waiting for a schedule to complete.

And then there are some poles on Rogers Street parallel to Third in that -- all in the same area of which this petition is being requested.

JACQUI DUFFY: What about the poles?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: They are waiting for them to be transferred or removed on Rogers between Third and Second.

And then I think there's just a concern

with all the construction in the area with Eversource finishing up what they got there first before moving forward. While we are hearing this petition, we wanted to make sure that stuff was moving along.

SUPERINTENDENT OF STREETS BILL DWYER:

This is Cambridge Center.

CHAIR NICOLE MURATI FERRER: Can you provide us an update with regard to the work schedule time?

JACQUI DUFFY: Yes.

SUPERINTENDENT OF STREETS BILL DWYER:

Some other work coming up in the area from -- one of the biomed companies in that area?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: 17.

SUSAN BARROSO: Biogen, station 8005.

SUPERINTENDENT OF STREETS BILL DWYER:

That's -- Biogen is part of 17.

SUSAN BARROSO: They go by different addresses. 17 Cambridge Center.

JACQUI DUFFY: 17 Cambridge Center. Building 9.

SUPERINTENDENT OF STREETS BILL DWYER: Is this the -- it's the same work that was -- the conversation we had two months ago maybe?

SUSAN BARROSO: Yes.

SUPERINTENDENT OF STREETS BILL DWYER: When that street was being paved and Biogen stopped by the job site?

SUSAN BARROSO: Same one.

SUPERINTENDENT OF STREETS BILL DWYER: And we discussed this and --

SUSAN BARROSO: They were paving that area.

SUPERINTENDENT OF STREETS BILL DWYER: I haven't heard back from Biogen, so I was

curious.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This is in regard to cogeneration of Biogen?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You are going down the sidewalk with this one?

SUSAN BARROSO: Yes. We were supposed to go all the way to Biogen but we found spares. So these are the only two sections. And we're gonna bring in lines from our station to there.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That includes the intersection of Third and Binney which was just redone.

I think the manholes and the gutter line on Third Street, they are proposing to go through, so you are cutting through the new intersection and newly remodeled -- they'll go right down there. Is that taking up all the

sidewalk?

JACQUI DUFFY: On Third? Is that what you are talking about?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Third and Binney is the intersection that you are looking to start from, which was just done, and it looks like you are looking to go down that sidewalk, so you are taking up the sidewalk and removing and replacing an entire sidewalk from Third all the way down beyond?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Between Fifth and Sixth.

SUPERINTENDENT OF STREETS BILL DWYER:

You said you found some available conduit?

SUSAN BARROSO: From here back to Kendall.

SUPERINTENDENT OF STREETS BILL DWYER:

Third Street back to Kendall?

SUSAN BARROSO: Yes.

SUPERINTENDENT OF STREETS BILL DWYER:

I'm not aware if with -- if there's any kind of site meeting with anybody from Public Works yet, that's why.

JACQUI DUFFY: If they'd come over on Mondays, you mean, to talk to you about it?

SUPERINTENDENT OF STREETS BILL DWYER:

Yes. I'm not familiar with this one.

JACQUI DUFFY: Okay.

SUPERINTENDENT OF STREETS BILL DWYER: I would like to get a feel for what else is going on in that area before we move ahead with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to continue?

SUPERINTENDENT OF STREETS BILL DWYER: I would like to continue this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: On
the motion to continue?

CHAIR NICOLE MURATI FERRER: Seconded.

SUPERINTENDENT OF STREETS BILL DWYER:
Second.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:
Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Aye.

SUSAN BARROSO: I'm assuming you guys are
familiar with -- I got a call from a customer
yesterday. And I think in the same area here, I
think, 14 acres of land they are going to
develop, but I don't know who is going to do it.
They have it out for bid. It is in the same

area.

SUPERINTENDENT OF STREETS BILL DWYER: I don't know about it. I'm listening to you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Is that the DOT property?

SUSAN BARROSO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I believe that's all of the Department of Transportation. It's probably the whole block bordering old Sixth Street walkway and Third Street?

SUSAN BARROSO: From Binney Street to Broadway, I think. I think it's in this area, too, next to Biogen.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: This conduit that you are proposing is gonna alleviate some of that or in need of or have you looked at that?

SUSAN BARROSO: No. I have not looked at that. Because they are looking for a lot of load too. I think they are saying 30 megawatts of load, so they are going to need some dedicated lines.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So these additional conduits in the previous petition will accommodate that?

SUSAN BARROSO: We can. Let's say on the other sections I might be in trouble.

SUPERINTENDENT OF STREETS BILL DWYER: You are not sure what you're gonna need with the requirement, what the need might be?

SUSAN BARROSO: Correct.

In this section it will be enough because I'm asking for six. Now, in the other areas ...

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You have been approached by the developer on that?

SUSAN BARROSO: It's the same -- well, in this case it was the same owner as this one 50-60 Binney Street, and they said they are going to bid. They are doing something and they gave me a heads up it was coming.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Thank you.

Comcast?

ANTHONY VATALARO: Good morning.

CHAIR NICOLE MURATI FERRER: For the people in the room, for the public open meeting laws, can you please state your name for the record please.

ANTHONY VATALARO: Anthony Vatalaro.
Comcast.

COMCAST - BANKS STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The

first petition for Comcast is 140 Banks Street from the existing pole 2, trench five feet easterly in the public way ending at the property line of 140 Banks Street installing 1, 2-inch PVC conduit. This will include the removal and replacement of one sidewalk panel. All work is to be performed by the property owner.

ANTHONY VATALARO: It is the -- they are building two new houses there and they renovated 136.

SUPERINTENDENT OF STREETS BILL DWYER: Do you know who the site contractor is?

ANTHONY VATALARO: I don't remember off the top of my head.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I believe the electric was in a few months back and they are going to the same pole.

SUPERINTENDENT OF STREETS BILL DWYER: We

can look into that, and they need to get a permit from us anyways.

ANTHONY VATALARO: I'm sure you know him. I recognized him from doing work with him before in Cambridge.

SUPERINTENDENT OF STREETS BILL DWYER:
Public Works is fine with this petition.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Motion to approve?

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

SUPERINTENDENT OF STREETS BILL DWYER:
Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Aye.

Typical conditions.

CHAIR NICOLE MURATI FERRER: The agenda says pole 2, but it is pole 22.

COMCAST - CHURCH STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also Comcast for 3-33 Church Street. Is that correct 3-33?

ANTHONY VATALARO: It's meaning all those buildings from the church -- the church is 3 and then we are going to go to 23, 27, 29, and 33.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So No. 1 from the existing manhole in front of 50 Church Street trench easterly 177 feet installing 1, 4-inch PVC conduit and one new Comcast manhole in front of 10/28 Church Street.

No. 2 would be from newly-placed manhole trench southerly 16 feet to 10/28 Church Street

installing 1, 4-inch PVC conduit and one new Comcast sidewalk vault.

And No. 3, from newly-placed manhole trench northerly 32 feet to 23 Church Street, basement, installing 1, 4-inch PVC conduit.

No. 4, from newly-placed manhole trench westerly thence northerly a total of 54 feet to the front of the Lizzy's Ice Cream installing 1, 4-inch PVC conduit and one new Comcast sidewalk vault.

Continue from new sidewalk vault northerly an additional 16 feet of southwest (sic) trench to 29 Church Street and 12 feet of sidewalk trench to 17 Church Street installing 1, 2-inch PVC conduit for each building.

No. 5, all four sidewalk locations, concrete and brick, will be restored to the same or better condition.

Digging out there?

ANTHONY VATALARO: Yeah.

So these businesses have been trying to get service there for a long time, and we've been locked out of it because the streets been paved new for the past five or six years.

I don't know when it was last paved, but it was four or five, six years ago. I'm not sure.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I believe so.

ANTHONY VATALARO: I did meet with Jaya out there just before I submitted this, and he suggested we would have to pave curb to curb in that area, which is fine because there will be no SPOF feed if we do the curb to curb.

CHAIR NICOLE MURATI FERRER: That's why your prices are so expensive. I mean.

ANTHONY VATALARO: There's a lot of upfront monies to get permitting.

CHAIR NICOLE MURATI FERRER: I can't believe it.

ANTHONY VATALARO: I'm glad you said it, not me.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I would think that you should also fill out a common trench portion of this and make sure you contact Verizon because they have a lot of issues up there with service also.

If they may want to join in the cost in the trenching while the street is being dug up again. That these other buildings, have you know, clear path, in case they want to give Verizon service.

What is your time frame?

ANTHONY VATALARO: To do it?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yes.

ANTHONY VATALARO: They are in a rush to do it.

But if we gotta do the common trench, that's fine too.

I would like to do it before the season is out. I would like to do it this season.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I would like to see the common trench portion filled out and contact the other utilities and you get a list from the License Commission, and you know the routine on that.

I make a motion to continue.

CHAIR NICOLE MURATI FERRER: Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All in favor?

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

COMCAST - DONNELL STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also Comcast petition 12 for 9 Donnell Street from existing pole 3 at the corner of Donnell Street and RC Kelly Street trench westerly 25 feet in the public way ending at the property of line of 9 Donnell Street installing 1, 2-inch PVC conduit. This will include the removal and replacement of the one sidewalk panel.

In the previous petition we heard earlier the developer is doing the work?

ANTHONY VATALARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So

the stipulation on this was to coordinate with Eversource to use the same trench?

ANTHONY VATALARO: Yeah.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I make a motion to approve.

SUPERINTENDENT OF STREETS BILL DWYER: Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: With typical conditions and coordination with Eversource.

SUPERINTENDENT OF STREETS BILL DWYER: Yep. Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All in favor?

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Aye.

SUPERINTENDENT OF STREETS BILL DWYER:

Aye.

COMCAST - HURON AVENUE

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also Comcast, petition No. 13, for 175 Huron Avenue. Place one new Comcast manhole over existing underground conduit on Huron Avenue at Manasses Avenue.

Trench northwesterly 52 feet to the sidewalk at 17 9 Huron Ave installing 1, 2-inch conduit and one new sidewalk vault.

The same trench, install 1, 4-inch conduit, 40 feet then turning easterly trenching an additional 52 feet and then turning southwesterly 11 feet to the sidewalk at 175 Huron Ave, installing 1, 4-inch conduit and one new sidewalk vault.

This will include a removal and

replacement of two sidewalk panels.

SUPERINTENDENT OF STREETS BILL DWYER:

Public Works is fine with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The only -- I would like to -- could you move that sidewalk vault for 175 down to the property line between 175 and 171 in case at some point they -- or do you already have service?

ANTHONY VATALARO: Yeah, I talked to that property owner about it.

Is that regarding the curb cut?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No. If in some time 171 wants --

ANTHONY VATALARO: I actually have a vault around the corner for Concord Avenue for them.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: That feeds the building?

ANTHONY VATALARO: Yes. 161, 163, 171
are all the same property owner so that vault on
Concord Avenue is to feed them.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The
new one you just installed?

ANTHONY VATALARO: I installed it before
they paved the road.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: 171
is already serviced, one property, one building?

ANTHONY VATALARO: Yes.

CHAIR NICOLE MURATI FERRER: You were
turning northwesterly to the sidewalk at 175,
right, not southwesterly?

ANTHONY VATALARO: For the vault
location?

CHAIR NICOLE MURATI FERRER: Yes.

ANTHONY VATALARO: Did I say
"southeasterly"?

CHAIR NICOLE MURATI FERRER: No. I think our Chair said it.

ANTHONY VATALARO: It is going northwesterly.

CHAIR NICOLE MURATI FERRER: I wanted to clarify that for the record. Thank you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Motion to approve?

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
Aye. Aye.

SUPERINTENDENT OF STREETS BILL DWYER:
Aye.

With typical conditions.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

With typical conditions.

ANTHONY VATALARO: Thank you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Crown Castle?

KATHLEEN SARNACCHIARO: Good morning, my
name is Kathleen Sarnacchiaro: I'm with Crown
Castle.

CHAIR NICOLE MURATI FERRER: How do you
spell your last name?

KATHLEEN SARNACCHIARO:
S-A-R-N-A-C-C-H-I-A-R-O.

CHAIR NICOLE MURATI FERRER: Thank you.

CROWN CASTLE - MOUNT AUBURN STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This is for petition No. 14 for Crown Castle.

This is for Mt. Auburn Street at the

intersection of Mt. Auburn Street and Banks Street from an untagged pole extending northwesterly approximately 81 feet in two new 4-inch conduits to a Verizon manhole 26/210 on Mt. Auburn Street and on Mt. Auburn Street from Verizon manhole 26/212 extending easterly approximately 18 feet in two new 4-inch conduits to a proposed vault at the intersection of Mt. Auburn Street and DeWolfe Street, intercepting an existing Harvard University conduit and at the intersection of Bow Street and Arrow Street from an existing Harvard University manhole extending easterly approximately 49 feet and two 4-inch conduits to an existing Verizon manhole 26/575.

And on JFK Street from Verizon manhole 26/373 extending southeasterly approximately 243 feet in four new inch-and-a-quarter and 1, 4-inch conduit to the intersection of JFK Street and

South Street continuing southeasterly approximately 22 feet to pole No. 10 on South Street for node N044. Also, approximately 11 feet of 4 inch -- 1, 4-inch new -- I'm sorry. Four new inch-and-a-quarter conduits as a lateral connection to No. 60 JFK Street.

KATHLEEN SARNACCHIARO: So this petition was originally heard by the Commission in January. And at that time, it was decided to table it while we worked out our agreement with Harvard.

So we did work out an agreement with Harvard, and I don't know which way you want to tackle this because it is a large swath.

The plans I circulated is an overview map that may be helpful to look at when reviewing the petitions and kinda get a sense of everything together.

The red signifies the new digs and the blue is existing conduit.

So we're utilizing Verizon -- existing Verizon conduit and also Harvard conduit and then continue with Verizon's.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I do remember this petition earlier.

And I believe the earlier proposal was to dig from South Street to Mt. Auburn Street and then down Mt. Auburn Street and then we requested to search out other means.

KATHLEEN SARNACCHIARO: Yes.

The primary change is along DeWolfe Street, so in utilizing the existing Harvard conduit, we're able to eliminate 264 feet of digging that the previous petition had.

SUPERINTENDENT OF STREETS BILL DWYER: I didn't hear all of -- the complete, the entire

presentation.

Could you repeat what is -- what will be excavated or lines utilized, what existing conduit will be utilized?

KATHLEEN SARNACCHIARO: So along Mt. Auburn Street, if you start -- I'm sorry. I have this all marked up.

In the corner here, if we start there, there's a small dig from the aerial fiber to an untagged pole, a small dig into existing Verizon conduit down Mt. Auburn Street, and then at the corner of DeWolfe and Mt. Auburn Street, another small dig into existing Harvard conduit.

SUPERINTENDENT OF STREETS BILL DWYER: So the red indicates --

KATHLEEN SARNACCHIARO: New digs, yes.

SUPERINTENDENT OF STREETS BILL DWYER:

Thank you.

KATHLEEN SARNACCHIARO: And a new dig into Verizon all the way down to Mt. Auburn Street to JFK and then down to that red new dig down to South Street.

CHAIR NICOLE MURATI FERRER: What is the green?

KATHLEEN SARNACCHIARO: The green is aerial fiber, so that's attached to an untagged pole.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Which is existing?

KATHLEEN SARNACCHIARO: Yes.

One item to note, unfortunately, on the previous petition that was submitted and heard in January, there was occlusion of that node 44, included installation of new equipment on that pole, and this most recent petition, that wasn't included, it was an error on our part that it

wasn't included, so I did include, under the overview map, there's no profiles for node 44. If you are not able to include that into this petition, we understand if it needs to be repetitioned, just let us know and we'll take care of that.

I wanted to explain the change from the initial petition had included node 44's equipment -- well, revised petition, I guess, for today.

That was left off in error, so I have the pole profiles for you. If it can't be included in today, we understand and we'll repetition.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So this petition includes all the digging and fiber but it doesn't include the actual attachment of the node on pole 10 on South Street?

KATHLEEN SARNACCHIARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I would think you would need the petition for the node attachment.

KATHLEEN SARNACCHIARO: We understand. Sorry about that.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Okay.

Here's two digs here. Digs at Banks and here.

SUPERINTENDENT OF STREETS BILL DWYER: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It is all to reach from Banks to --

SUPERINTENDENT OF STREETS BILL DWYER: We need a little more homework on that.

I will request a continuance.

CHAIR NICOLE MURATI FERRER: Can I suggest something?

The node is basically part of this application, you have to reapply, so why don't we -- why don't you withdraw this and just reapply with everything and that will give us time to do homework. So if you reapply for next meeting, which is August, right, we are in July already, that will give us time to look at what we need to look at.

It will give you time to re-edit this and submit it properly with the node and everything and that way we can take it in one swoop rather than two different ones in case some abutters want to come and talk about it and we have everything in one letter.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So the motion would be to withdraw the petition?

CHAIR NICOLE MURATI FERRER: Well, it would be -- are you withdrawing the petition at

this point and resubmitting in August?

KATHLEEN SARNACCHIARO: We'll withdraw
and resubmit and give you time with these
plans.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
From the request that Crown Castle to withdraw?

SUPERINTENDENT OF STREETS BILL DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

CROWN CASTLE - SIDNEY STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also for Crown Castle, this is Sidney Street. On Sidney Street from pole 7 extending approximately 170 feet southeasterly in four inch-and-a-quarter conduits to a steel guy pole proposed node N012 on Sidney Street.

KATHLEEN SARNACCHIARO: This node was discussed at the last month's hearing.

It had been previously gone before the board. It was on private property.

So we identified a guy pole across from the previous location, and I believe the board approved that pole last hearing.

So this is just for the conduit that goes to the guy pole in relation to that project.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You are connecting to aerial fiber at Allston and Sidney?

KATHLEEN SARNACCHIARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Then extending it underground to the guy pole?

KATHLEEN SARNACCHIARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Which already has been approved.

KATHLEEN SARNACCHIARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This is the excavation. Your original request was to go over to a pole that was in a park --

KATHLEEN SARNACCHIARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

-- which we asked to -- told them it was not allowed to, so they picked the guy pole.

SUPERINTENDENT OF STREETS BILL DWYER:

I'm not familiar with, as far as any site meeting that's taken place, so I would suggest we move this to the next one.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A

motion to continue?

CHAIR NICOLE MURATI FERRER: Second.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All
in favor?

SUPERINTENDENT OF STREETS BILL DWYER:

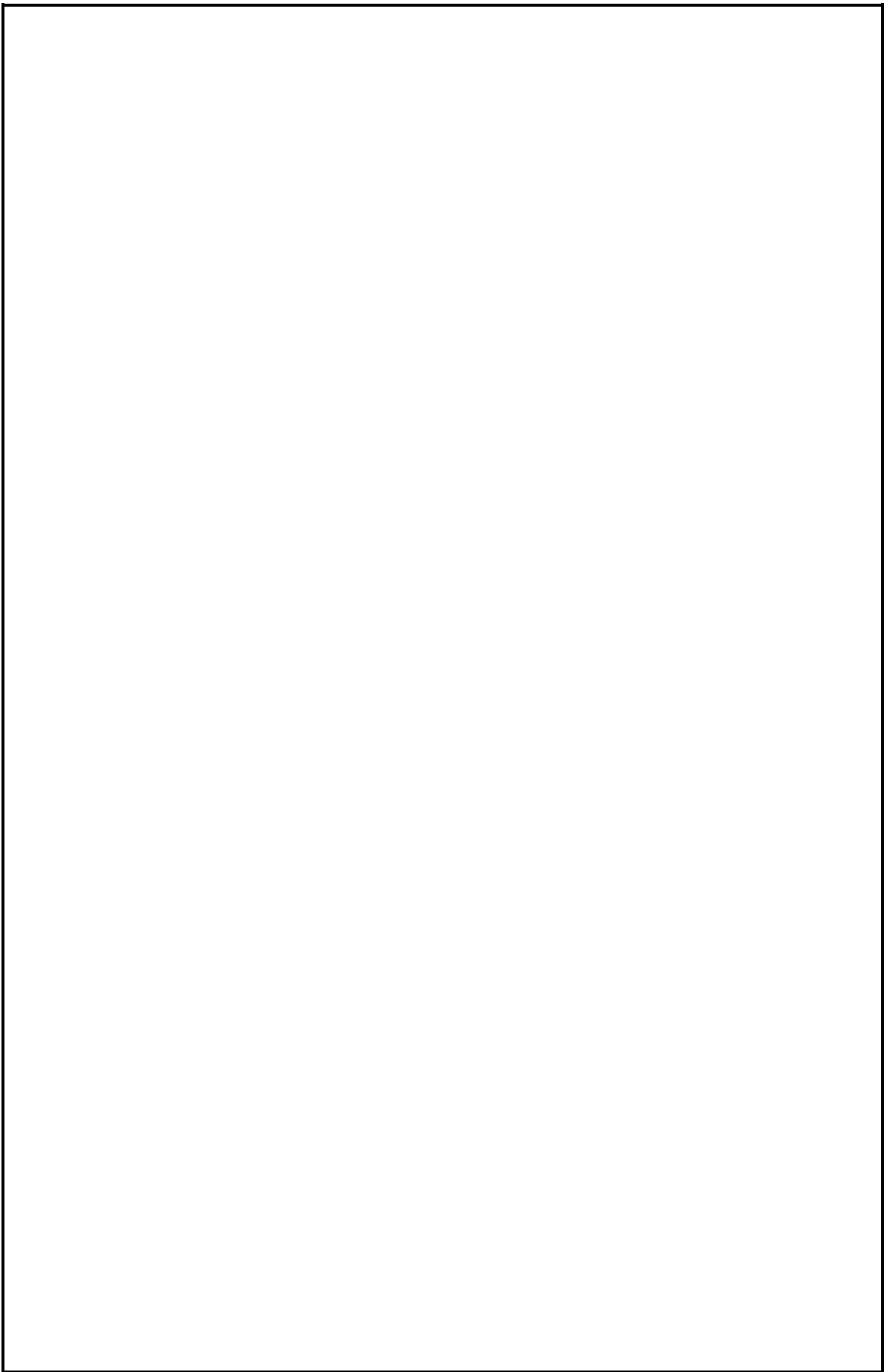
