POLE AND CONDUIT COMMISSION MEETING

CONTINUED PETITION FROM DECEMBER 15, 2016

COMCAST - CARDINAL MEDEIROS AVENUE

Comcast, which is petition No. 5. This is continued from last month for Cardinal Medeiros Avenue.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

I think there was a request to explore the existing conduit and place to that building.

ANTHONY VATALARO: Yeah. They are still working on getting permission to use that conduit.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Okay. So continue?

ANTHONY VATALARO: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to continue?

SUPERINTENDENT OF STREETS WILLIAM DWYER:
Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER: Aye.

CHAIR NICOLE MURATI FERRER: Yes.

NEW PETITION

COMCAST - CONCORD AVENUE

This is for 665 Concord Avenue, install new 3-by-3 manhole over existing conduit, trench 22 feet easterly in the public way/bicycle lane to property line of 665 Concord Avenue.

This will include the removal and replacement of one and a half sidewalk panels.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
Public Works has no issue with this.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You are adding a hand hole there?

ANTHONY VATALARO: Yeah.

It will be -- it is a driveway, so it will be a whole frame and cover.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And then you are going down the driveway of 665?

ANTHONY VATALARO: Yes.

city Electrician Stephen Lenkauskas: The only thing I would request the hand hole be placed on the property line. There will be a development going in there, and see those two lots will be leveled and there will be affordable housing there and I'm sure they will need service.

Can you stub a conduit?

ANTHONY VATALARO: When you say put the

manhole on the property line, meaning the property line 671 and --

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You install your hand hole and you bring two conduits underneath that sidewalk panel and leave one stub at the property line for the future, so when they come in to look, they will have to pick it up.

ANTHONY VATALARO: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Other than that, motion to approve with all
typical conditions?

SUPERINTENDENT OF STREETS WILLIAM DWYER: Seconded.

CHAIR NICOLE MURATI FERRER: Seconded.

And also with what you just said.

With my additional comments.

was going to say this petition that has been
continued a few months back and everything that's
been requested at this point has been met.

There's discussion going on with small cell in general which we'll be discussing further but at this time, I don't -- I move to approve this petition.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
I agree.

I think we have to, as a Commission, come together and I think we agreed on a date to sit down and come up with a sort of guidelines for us per se and for other people to know in general how exactly and how many of these we are going to allow in the future.

But I think Verizon Wireless presented a strong case for the need to service and to add this, so I have no problem with it.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So on the motion to approve? Any comment?

SUPERINTENDENT OF STREETS WILLIAM DWYER:
No comment.

CHAIR NICOLE MURATI FERRER: Just, we have not received any issues with legal with regard to allowing these at these locations.

Legal is aware of what we're working on and they are -- they are working with us going forward to determine the best way to handle the small cell.

Mobilitie, which is petition No. 8. This is the -- state your name for the record.

ATTY BRIAN GROSSMAN: Brian Grossman,

G-R-O-S-S-M-A-N. Anderson & Kreiger on behalf of

Mobilitie.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The first petition is No. 8 on the agenda. This is for Palermo Street and this has been continued for a few months back.

There were some still -- we are still waiting for you -- are waiting for license and walkthrough?

ATTY BRIAN GROSSMAN: Correct.

I think that's correct on this. Of the three petitions we have one that has a license and two are just about ready to have them issued.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Does this one have your license in for that pole?

ATTY BRIAN GROSSMAN: I don't believe so.

I think that's one of the other ones.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: If we take one at a time. No. 8, you are still waiting on licensing and if you could check it.

ATTY BRIAN GROSSMAN: That's correct.

SUPERINTENDENT OF STREETS WILLIAM DWYER: Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

PETITION CONTINUED FROM JUNE 16, 2016

MOBILITIE - LAMBERT STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS: No.

10 on the agenda is 27 Lambert Street and I do

have -- that first pole we had discussed, which

was a riser pole?

ATTY BRIAN GROSSMAN: That's correct.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And

I'm surprised you got a license for that pole where it being a riser pole, first pole up.

Do you have licensing agreements?

ATTY BRIAN GROSSMAN: I don't have it with me, but I believe it is the one we have the license for, and we discussed that this morning with another person from Mobilitie, who is unfortunately not here. But we raised that concern repeatedly and you raised it early on and it is not something new to us and so they vetted that and so far no one has raised any issue in terms of being able to utilize that pole, and I have been working with the utility, so I -- it comes as a little bit of a surprise, but right now we asked the question repeatedly and we have been told we'll have access.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And no make-ready work is necessary for that pole?

They are not changing the pole out or anything

else?

ATTY BRIAN GROSSMAN: I don't believe a pole change will be necessary but we'll confirm that for you next month.

CHAIR NICOLE MURATI FERRER: Should we continue waiting for answers to those questions?

city electrician stephen lenkauskas: I would like to see licensing first and whether or not pole is going to be replaced or not prior to, so that all conditions are met. Other than that, I would say we continue it.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
Agree. Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CROWN CASTLE - EDWIN H. LAND BOULEVARD

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Crown Castle?

COSTA JOVANOVIC: Costa Jovanovic from Crown Castle.

RYAN MARTIN: Ryan Martin from Crown Castle.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I believe this was continued also. It may have been a question of property lines for Cambridge and the State maybe and DCR permits.

RYAN MARTIN: Yeah, I have a copy of an email today from Shawn Casey (phonetic) saying the permit is granted and they have no issue with it. I can submit it to you. So with that, it was a conditional permit of -- the permit was to provide confirmation of approval of from DCR.

So that said, we want to get the approval from you guys so we can move forward with DCR as soon as they give us a permit in hand.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Do you have a copy for the record?

RYAN MARTIN: I do.

EXECUTIVE DIRECTOR ELIZABETH LINT: You

emailed it to Dana?

RYAN MARTIN: I emailed to Dana.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Anything else?

I would just still do the typical conditions,
just -- we need to have an idea -- we need to
know what work is going on with the city, so we
can coordinate with other developments and other
utility companies and so forth and so on and city
works.

I would say move forward with the typical conditions, and we'll still be -- they still will be required here as far as scheduling and coordination.

RYAN MARTIN: Understood.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to approve?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All

in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yes.

EVERSOURCE - FERN STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Eversource?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Good morning.

JACQUI DUFFY: Jacqui Duffy, Jill's

friend.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The

first petition on the hearing is for Fern Street,

Eversource, northwesterly side, approximately 40 feet north of Concord Avenue, relocate one joint-owned pole No. 2, install one new anchor guy.

Also on Fern Street, northwesterly side, approximately 340 feet north of Concord Avenue, install one new anchor guy at joint-owned pole 6.

This work is necessary per the request of the City of Cambridge.

This is a straight guy down to the ground? We don't typically approve those in Cambridge.

JACQUI DUFFY: New pole, yeah. And an anchor guy.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

There's a new pole there. I believe the pole has been set already. Is that one being moved?

JACQUI DUFFY: It is being moved to 602, and they are going to remove that one and put it

on the left-hand side.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The new pole is being moved, the one you just set?

Was it set in the wrong place?

JACQUI DUFFY: Hold on one second.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Sure.

Because right now there's an old pole No.

2 that's currently there and there's a second

pole in the ground now, which I believe is new.

My larger question is the guy, the guy anchors.

JACQUI DUFFY: On both of them?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yeah. Yep. Into the public way down -- if you go straight up and it is protected but if it is down at an angle.

JACQUI DUFFY: You want us to change that?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yeah. If you are relocating the pole, then I don't have an issue with relocating that pole that's previously put in.

But the guy and anchor, have you discussed that with Public Works?

JACQUI DUFFY: I have no idea.

would have further discussion with Public Works.

That's an art area. They have some public art

going there, and to have a guy wire going down

to the ground, I think maybe we can look at

something a little bit.

JACQUI DUFFY: Changing the anchor?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Changing the anchor, yeah, if you need it at all.

Just look at it a little closer.

JACQUI DUFFY: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I would approve this contingent -- approve the

pole relocation and not the guy anchors until we have further discussion with Public Works and myself.

CHAIR NICOLE MURATI FERRER: Do we just want to -- do we just want to continue it and do it all at once or do you?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

There's a time restraint there with that project that's been rather -- I would rather let the pole go.

JACQUI DUFFY: And check on the anchors.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Check on the anchors because they won't impact construction.

JACQUI DUFFY: I doubt it.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to approve with the conditions just check
on the anchors?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

NEW PETITION

EVERSOURCE - FERN STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Second one for Fern Street, southerly from pole

No. 2 approximately 40 feet north of Concord

Avenue, a distance of 12 feet of conduit.

This is to move that pole?

JACQUI DUFFY: Right.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Just picking up the existing conduits, it looks

like?

JACQUI DUFFY: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Picking them up in the public way, and I have no issues with that.

Motion to approve?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: All

in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

NEW PETITION

EVERSOURCE - RESERVOIR STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The

third petition, Eversource on Reservoir Street, southeasterly from pole No. 6, approximately 125 feet south of Highland Street, thence turning northeasterly, a distance of about 187 feet of conduit.

This work is necessary to supply power to 26 Reservoir Street.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
State your name and your affiliation.

My name is Dan McLaughlin,

M-C-L-A-U-G-H-L-I-N. I work for S&H

Construction. We are the general contractors

building that residence.

ANTHONY LAMPASONA. I'm Anthony

Lampasona, L-A-M-P-A-S-O-N-A. I'm from Lampasona

& Bloomer. B-L-O-O-M-E-R Electric. I'm the

electrician on site.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Is this a primary feeder.

ANTHONY LAMPASONA: Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Why down two poles from the residence at that corner and not to the pole No. 7.

JACQUI DUFFY: I think that's the only free one they had.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

What is going on the pole? Just a switch?

JACQUI DUFFY: Let's see. Yes.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

There's an existing conduit going up pole No. 7, was that for the same project?

ANTHONY LAMPASONA: No.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Any idea what that was for?

ANTHONY LAMPASONA: It has to be serving one of the other homes in the other area.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Nothing yet?

ANTHONY LAMPASONA: There's nothing to this house now.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I think both poles are equally --

JACQUI DUFFY: That's what the designer picked.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
There's a conduit available on that pole 7. It
is right in front of the property. It is logical
to utilize that conduit.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

These sidewalks were done on both corners and at pole 6 recently.

I would move to continue this.

JACQUI DUFFY: See if we go on 7?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: Go on 7. I don't believe it is any more congested than any other pole.

JACQUI DUFFY: If they can get it on 7,

can they get approval before the next meeting since it is right in front of the property?

If we can get you a sketch going to pole 7.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I myself would be fine if you went to pole 7 with the switch on pole 7.

JACQUI DUFFY: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That way there will be no impact on that. That

was just paved with a binder, but still, when you

are excavating, I would much rather see that.

That's quite a distance.

ANTHONY LAMPASONA: I don't think they can go on that because it is a transition pole.

I think it goes in two directions.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I would like to hear that from Eversource.

Whatever the reason, we would like to hear that first before.

I would approve the dig to 7. It is only two or three feet.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So we move to approve it to pole 7, not to pole 6.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And if that can't be done, it would need to come back before us as a continuation.

JACQUI DUFFY: What would you need from

me, another plan?

You -- for 7 another plan for the record. And then otherwise bring it back next week for discussion on 6.

JACQUI DUFFY: Next month you mean?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Next month I mean. If you are unable for whatever reason to go to 7, then you should come back to us and explain the details of that where you want to go to No. 6.

JACQUI DUFFY: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It is not going to impact any construction. Paving is not happening any time soon.

ANTHONY LAMPASONA: This house is almost done and we have been at this with Eversource for well over a year now, so.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

This is the first we've seen it.

ANTHONY LAMPASONA: Okay. Thank you.

4, and this is for Rindge Avenue. I believe it

JACQUI DUFFY: It has been approved.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It has been approved previously?

JACQUI DUFFY: It has been approved and the piece from manhole 2032T was approved back in November, but now we're going from pole 54 down.

It was going from 56 over A, which is a private way, so now we are going on Rindge into there. So that other piece is on here but it shouldn't be approved.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:
State your name for the record.

GARRETT ANDERSON: My name is Garrett Anderson. A-N-D-E-R-S-O-N, with Cambridge Housing Authority.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I am aware of this.

The one contingency I want on this.

There's a pole right next to pole 54, which it

may be 54 and a half, there's nothing --

JACQUI DUFFY: 52 and a half. That's what is shown on the plan.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The one on Rindge Ave.

JACQUI DUFFY: Yep. He has 54 and 52 and a half.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I don't see 52 and a half.

I believe the pole went up, rather than going to a private way, 54, which is on Rindge Ave. There's a pole about six feet away from 54 to the west, I believe. That's nothing -- nothing's on it, just a pole, nothing's on it. Stripped. I would like that removed.

JACQUI DUFFY: There's a 54 and a half, you think?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I believe it is 54 and a half. Six feet away from

that.

Nothing's on it. It's been there much too long and it needs to be removed unless there's a reason why. No risers on it. Just to clean up that area while you're working on those poles, I would request that pole be removed.
