## EXECUTIVE DIRECTOR ELIZABETH LINT: We

would like to get started. This is the meeting of a Pole and Conduit Commission, Thursday, July 20, 2017. It is 10:07. We are in the Michael J. Lombardi Building at 831 Mass. Ave, basement conference room.

> Before you are the commissioners Chair

Nicole Murati Ferrer, Superintendent of Streets William Dwyer, and City Electrician Stephen Lenkauskas.

CHAIR NICOLE MURATI FERRER: Good
morning. If anyone has a cell phone, if you can please silence it.

And do we have any residents to speak on any of the petitions before us today?

CAROL FIPPIN: Yes.

CHAIR NICOLE MURATI FERRER: Which petition is that, ma'am?

CAROL FIPPIN: 12 Bow Street.

It is the Harvard petition for fiber
optic conduit on Bow Street, Arrow Street and Plympton Street.

CHAIR NICOLE MURATI FERRER: No. 14.

We'11 start with that petition first.

Any other residents to speak on any other petitions?
(No response.)

CHAIR NICOLE MURATI FERRER: Harvard

University can come up. And, ma'am, you as wel1, take a seat. Thank you.

Good morning. Please state and spell
your names for the record?

MARK O'BRIEN: Mark O'Brien. Harvard

University. $\quad \mathrm{M}-\mathrm{A}-\mathrm{R}-\mathrm{K} \quad \mathrm{O}-\mathrm{B}-\mathrm{R}-\mathrm{I}-\mathrm{E}-\mathrm{N}$.

CHAIR NICOLE MURATI FERRER: Sir?

TERRY TOLOSKO: Terry Tolosko T-E-R-R-Y

T-O-L-O-S-K-O, from Bristol Engineering on behalf of Harvard.

CHAIR NICOLE MURATI FERRER: Mr. Tolosko,
keep your voice up because it is kind of loud over here with the fans. It would be great.

Thank you.

CAROL FIPPIN: Carol Fippin, F-I-P-P-I-N, trustee, 12 Bow Street, Cambridge, Mass.

CHAIR NICOLE MURATI FERRER: Thank you.

So why don't we start with the petition and then.

NEW PETITION

HARVARD UNIVERSITY - BOW STREET

PLYMPTON STREET, ARROW STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS: For

Harvard University to construct approximately 40
feet, two, four-inch, schedule 40 PVC conduits
encased within an existing alley for 53 Bow

Street off Plympton Street. The duct bank will be constructed from an existing utility pole to the right of way on Plympton Street.

On Plympton Street, construct
approximately 110 feet of two inch -- two,
four-inch, schedule 40 PVC conduits, concrete
encased duct bank within Plympton Street from the utility for 53 Bow Street to 22 Plympton Street.

Also this is Harvard private property.

This would not pertain to us. That's within the parking lot area on private property.

On Bow Street, construct approximately 30
feet of two, four-inch, schedule 40 PVC conduit, concrete encased duct bank on Bow Street from the right-of-way at the driveway entrance to 9 Bow

Street to the east side of Bow Street to an
existing Harvard University Information

Technology underground duct bank system.

A new manhole will be constructed on the east side of Bow Street across from 9 Bow Street on the existing duct bank to connect the new duct bank to the Harvard University duct bank.

On Arrow Street, construct 260 feet of
two, four-inch, schedule 40 PVC conduit, concrete encased duct bank in Arrow Street from existing Harvard University manhole at the intersection of Bow Street and Arrow Street to an existing Comcast manhole adjacent to 1168 Mass Ave.

So what were your concerns in regards to this petition?

CAROL FIPPIN: We actually met ten years ago when Harvard did the first fiber optic Quincy across Mass Ave, whatever, and Mr. O'Brien was assigned as sort of advocate for our property residents, whatever.

We're really just the only kind of
private property on Bow Street, so everything
else is Harvard or owned by.

We had a hearing here, $I$ think we had a
couple, and there was follow-up and the deal was
the Commission asked that - at that time

Comcast, whatever it was called, Verizon,
whatever they were called, everybody get together so when the street was excavated everybody do
their work so it didn't close, open; close, open; close, open. I don't know what happened, I don't know if that happened, but the work got done and the promise was from the Commissioner, and Mr. O'Brien verified it, was that Harvard would guaranty that the street would be repaired.

Ten years later, it is not. The street
is in deplorable condition, Bow Street particularly, Bow Street into DeWolfe.

The sidewalks are cracking and the curbs are breaking up. There are sink holes. There's potholes. It's a mess. And nothing has
happened.

The street has been open probably three or four times since the Harvard fiber optic was initiated, which was the largest work, and there's been no -- nothing from anyone, the City or -- just zero. So that's our concern.

CHAIR NICOLE MURATI FERRER: Your concern
is that the street and the sidewalks remain in this condition and they continue opening them? CAROL FIPPIN: Exact1y.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: The
original paving wasn't done from the original agreement?

CAROL FIPPIN: No. Quincy was done.

Quincy was done up to Mass Ave, but -- and when that happened, we thought, they really are going to do it but it stopped at Mass Ave and that was the end. So it didn't continue. So -SUPERINTENDENT OF STREETS WILLIAM DWYER:

You mean -- okay. Across Harvard Street onto Mass Ave?

CAROL FIPPIN: Yes.

So Quincy is pristine and has been since that fiber optic installation ten years ago, but when it got to Mass Ave, it just stopped and there was no restoration of our part.

Obviously, this work is disruptive to our

1ittle building and my tenants. We have a cafe and there's seating. The first floor is a psychotherapist seeing patients. I mean, it's tough, it's dirty and messy, but the worst part is that our street is falling apart.

So the suggestion is that Harvard guaranty a bond of $X$ miliions of dollars that the street will be repaired this time.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That usually happens with a permit, for Harvard to pull a permit.

CAROL FIPPIN: Mr. O'Brien just told me that this morning, but then where is the money? SUPERINTENDENT OF STREETS WILLIAM DWYER:

Sometimes it is related to -- if they do a trench patch, and then there's a mitigation fee they pay, which could go into -- it goes into a general fund for free sidewalk repair. Or it could be the agreement to repave the whole street over. That would be -- it wouldn't be worked on right here but it would be worked on when it comes to the permit, the street opening permit. CAROL FIPPIN: There were a lot of people. The hearings were large.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That may have been Eversource when they ran their coil oil 1 ine from the other side of town through Quincy up Mass Ave and then down through Putnam Avenue. That was done.

Harvard and the gas company and the other
people have dug Bow Street and Arrow Street in the past ten years. No doubt about that.

CAROL FIPPIN: Okay, I was out of town, and there's a certified letter and I opened it up and I said "Oh, not again." And so I'm -- I have taken the time this morning to come and it is public hearing and I'm trying to make a statement the City has 1 et us down.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

I know you gave your name and address.

Any chance you could 1 eave an email so we could contact you and set up an on-site meeting?

CAROL FIPPIN: Sure. I would love that.

Who do $I$ give that to?

CHAIR NICOLE MURATI FERRER: Ms. Lint
over there.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Thank you.

CAROL FIPPIN: Are you done with me? Go
away.
(Laughter.)

CITY ELECTRICIAN STEPHEN LENKAUSKAS: We
heard you loud and clear.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We are going to meet with you. We don't want you to go away. We want you to stick around.

CHAIR NICOLE MURATI FERRER: So other
than what you've expressed, you don't have a particular objection to the work that Harvard is trying to do?

CAROL FIPPIN: Sure we objected, you
know, it is a mess. It is horrible. I can't
stop it. They are a lot bigger than me, so
that's -- could they do it on the other side of
the street? On their side of the street?

I know that's impossible. I'm being
facetious.

CHAIR NICOLE MURATI FERRER: Why are you
doing it on this side of the street?

MARK O'BRIEN: We're trying to tie into the conduits on that side of the street.

CAROL FIPPIN: They didn't run it on their side, that was a -

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That may be the on 1 y coridor at the time on the street.

## EXECUTIVE DIRECTOR ELIZABETH LINT: I

 have a very vivid memory of this from back then and that was the issue.MARK O'BRIEN: Verizon is inside our side and Comcast there.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

The gas company is in there too.

CAROL FIPPIN: That's also where the
subway work was done a couple hundred years ago.

Not that long ago, but when they extended the Red Line.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Back in the '80s.
CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Your property is which building?

CAROL FIPPIN: 12 Bow Street. Across
from Saint Paul's.

TERRY TOLOSKO: If you can see, I marked
it in red. Same side of the street as the manhole, mid-block.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: In
regards to this petition, the only excavation you are doing is you are installing a manhole over your conduit base a ittle bit down and then going directly into your alleyway.

TERRY TOLOSKO: That's the 30 feet.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And
then at the corner right at the church you are going directly down along the curb line to a Comcast manhole.

TERRY TOLOSKO: Yes.
CITY ELECTRICIAN STEPHEN LENKAUSKAS: But
it is the whole street.

CAROL FIPPIN: Yeah, it is not like it is right in front of us this time, but there are -I mean, they did 20 feet of excavation yesterday from the corner of Arrow Street back, and they told me it was this. I said that it can't be because there's --

## CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That was Crown Castle.

MARK O'BRIEN: They are doing their work now.

CAROL FLIPPIN: So you get six trucks, police details, barricades, and whatever. Even though it is not in front of us, it is -- it was hell. It was filthy. You should go right now and look at it. It was just incredibly disruptive. That's what it is. It is not two
guys with a shovel. This is heavy-duty
equipment.

So there's -- in the letter there's no
schedule. There's no timeline. There's no -- so

I don't know.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It
wouldn't be until it comes before us and then
they have 60 days to get it started.
CAROL FIPPIN: Okay.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And
then 90 days to have it completed.

CAROL FIPPIN: So at some point I assume
they produce a schedule and tell you we're going to be there for five minutes, five days, five weeks, five months.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

When they get the electrical, and DPW permit, street opening permit, it is scheduled with that.

MARK O'BRIEN: In the past, if I -- if
the memory is still good, we conversed quite a bit back then.

We had the whole Harvard Square Business Association that we talked to and -- because it was a six-week schedule and it rained every day.

CAROL FIPPIN: It was about three months,

I would say.

MARK O'BRIEN: It went on for quite a
while. We tried to give everybody updates as to what we were doing construction-wise.

CAROL FIPPIN: You also have winter to deal with.

MARK O'BRIEN: Well, the goal would be to be done before wintertime.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
Probably get to -- probably get the work done while your cafe is having people come and visit it.

CAROL FIPPIN: But you al 1 know Bow

Street?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Uh-huh.

CAROL FIPPIN: It is the buses, the Fire Department, that's their route.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It
is well-traveled.

CAROL FIPPIN: Very well-traveled.

And all of Harvard (inaudible ) that park
in front of it, fire hydrants. That's another conversation.

CHAIR NICOLE MURATI FERRER: Traffic and

Parking.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Thank you for bringing that to our attention.

Public Works will get people out there.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: If
this is approved, it will go through the process.

They will request a permit from the
electrical department, which we'11 refer to

Public Works for scheduling, and then at some point in between, $I$ think, you will be notified.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We'11 have a conversation or an email each week.

TERRY TOLOSKO: If you give us your card,
we can reach out to you independently.

CAROL FIPPIN: That would be fine.
TERRY TOLOSKO: And give you updates.

CAROL FIPPIN: I'm not faulting the
participants here.

We had a very good, I think, talking
relationship during that, but ten years later, we are getting tired.

## CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Thank you.

So in regards to the petition, as far as the conduit going down Arrow Street, would the City have space in that? I know you are running
two, four-inch, are they both for you?

MARK O'BRIEN: Yes.

TERRY TOLOSKO: Yeah. After you and I
met, $I$ talked to Mark and we can run an
inch-and-a-quarter for you. Everything we're doing here with the exception --

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I
mean, you can put an innerduct. If we need
something at some point we'd like to have space
in either one, we would just want to put
innerduct in one or an inch-and-a-quarter.

Either way.

MARK O'BRIEN: Sure.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: And
that's for that section that would connect those two.

Other than that, the section on Plympton

Street, I don't have any issues with that.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We've already had several site meetings out there and so Public Works is ready to sign-off on this. We are fine with this.

TERRY TOLOSKO: Plympton Street, just to answer your question, when we were walking, it was paved in August of 2011.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: You
are outside of the five year.

TERRY TOLOSKO: Yeah.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11
right. That would be a motion to approve with typical conditions and further on-site meetings and communications with the business owners.

CHAIR NICOLE MURATI FERRER: Seconded.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11
in favor?

CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

## CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

That's one way to skip to the front of
the line, bring a resident. Thank you.
Eversource?

CONTINUED
EVERSOURCE - DECATUR STREET
City electrician stephen Lenkauskas:
This first petition was continued from last month
in regards to Decatur Street and the request was not to run down the street, to go directly in
from the pole, and I did get the revised application reflecting that.

The only added thing is that's a double pole there right now.

JACQUI DUFFY: You want --
CITY ELECTRICIAN STEPHEN LENKAUSKAS: It needs to be removed before any conduit.

Unfortunately, this is the third time I requested this.

The one on Rindge Ave is not done as well as Francis Ave.

JACQUI DUFFY: I sent the request. I'11 do it again.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So
other than that, it may affect the permit going forward because the permit will not be issued until that pole is removed.

JACQUI DUFFY: This pole or the other two?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11
of them.

CHAIR NICOLE MURATI FERRER: A11 of them.

JACQUI DUFFY: (D) al 1 of the above?

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Yeah. They have all been conditions of previous grants of locations.

## EXECUTIVE DIRECTOR ELIZABETH LINT: It's

Rindge and what are the other two?
CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Rindge, Francis Ave and this current one would be Decatur Street. All directiy related to the installation.

EXECUTIVE DIRECTOR ELIZABETH LINT: Thank you.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Other than that.

CHAIR NICOLE MURATI FERRER: So would you hold the electrical permit?

CITY ELECTRICIAN STEPHEN LENKAUSKAS: I
will hold the electrical permit until all three are completed.

JACQUI DUFFY: It is approved pending --

CITY ELECTRICIAN STEPHEN LENKAUSKAS: It
wil1 be approved -- it will be approved but the permit, the actual permit won't be accepted or
approved until those three conditions are met and the conditions of each petition.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Agree with that.

CHAIR NICOLE MURATI FERRER: Second.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11
in favor?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

CHAIR NICOLE MURATI FERRER: Aye.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

NEW PETITION

EVERSOURCE - ALBANY STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also Eversource for Albany Street at Mass Ave and northeasterly from manhole 3498 to manhole 3503, a distance of 479 feet of conduit. Also on

Albany Street at Mass Ave and northeasterly from manhole 3499 to 3503 , a distance of 560 feet of conduit. Did you explore going down the railway behind Albany Street?

SUSAN BARROSO: Yeah. The other half was approved last month because MIT is going to pave the whole Albany Street and we decided to do the half from Albany Street all the way to Mass. Ave. That's the way we're coming in.

SUPERINTENDENT OF STREETS WILLIAM DWYER:
But if you go down the railway, the paving of Albany Street, wouldn't make a difference anyway. SUSAN BARROSO: Correct. SUPERINTENDENT OF STREETS WILLIAM DWYER:

You gotta tie back anyway. It would be less pressure on the City, less disturbance of traffic and pedestrians and the whole idea of that, if you went down the railway. But going down the railway would take time to do the research,
right?

SUSAN BARROSO: Yeah.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

You're going up to 6 inch PVC?

SUSAN BARROSO: Supposed to be 5 inch.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

If MIT wasn't paving Albany Street, Eversource wouldn't have come forward this, so they would have come forward at some other point.

SUSAN BARROSO: We asked them because
they are looking for a certain load and all our circuits are coming from station 831 , which is coming this way on Albany Street, on this side, and we have to go in a big circle all the way around.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So you are going directly on top of an existing duct bank?

SUSAN BARROSO: Yes. Now, they have a
station halfway on Albany Street, but now they expand it and going down 230 feet or 300 feet and expanding to a new station, and that's how we have to get from here to there. And because they are going to pave the whole street, we're putting more conduits on the first half.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: So
you are using the same corridor and staking on top of an existing duct bank?

SUSAN BARROSO: Yes.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Any idea what the depth is? It says here you have to maintain three feet.

SUSAN BARROSO: They can stack them.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

They will be able to stack them?

SUSAN BARROSO: Yes.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

I'm not -- forgetting the schedule for the MIT
paving. I don't think -- it is not planned this summer.

SUSAN BARROSO: I don't think so.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

I propose we continue.

CHAIR NICOLE MURATI FERRER: I second.

CITY ELECTRICIAN STEPHEN LENKAUSKAS: A11
in favor?
CHAIR NICOLE MURATI FERRER: Aye.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Aye.

## CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Aye.

JACQUI DUFFY: Continue it on what basis?

Do we have to go back and bring you something or --

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We need to do a little more extensive review on DPW. There may be some more questions on site
when $I$ bring one of the engineers that $I$ usually bring.

JACQUI DUFFY: Okay, I didn't know if we
had to bring back something.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Not yet.

SUSAN BARROSO: Do you need a copy of
this?

SUPERINTENDENT OF STREETS WILLIAM DWYER:

That would be helpful. To your point, Jacqui, we can contact whoever we got to meet out there, whether it be -- it won't be you two, right.

JACQUI DUFFY: No. Conduit. Billy

Marchant (phonetic).

SUPERINTENDENT OF STREETS WILLIAM DWYER:

Bil 1.

JACQUI DUFFY: Carol or Matt.

SUPERINTENDENT OF STREETS WILLIAM DWYER:

We do a lot of work with Matt, and we' 11 meet him
out there and then we'11 have questions and he can bring it back to you, if we need to.

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

That's a typo. Correct the 6 to 5. The submitted drawings call for 6 inch.

SUSAN BARROSO: We'11 change it to 5 .

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Motion to continue?

CHAIR NICOLE MURATI FERRER: Yup. We already voted.

NEW PETITION

## EVERSOURCE - EDUCATION STREET

CITY ELECTRICIAN STEPHEN LENKAUSKAS:

Also Eversource for Education Street. Northerly from manhole 3333, approximately 30 feet northeast of North Point Boulevard, a distance of about 22 feet of conduit.

Is that actually in the intersection of

North Point Boulevard and Education Street?
I went out there and couldn't figure out
where this was.
SUSAN BARROSO: I think so.
CITY ELECTRICIAN STEPHEN LENKAUSKAS:
That's right in the middle of the intersection and it is going into the MWRA facility?

SUSAN BARROSO: Yes. The MWRA right now
it is near the bridge and they are moving it down
to the other end.
Supposedly a new building is coming on
this location where the MWRA is.
CITY ELECTRICIAN STEPHEN LENKAUSKAS: You
are missing something -- I see 3333 is on here.
SUSAN BARROSO: I think it is near the
tracks, that's where they are moving them.
SUPERINTENDENT OF STREETS WILLIAM DWYER:

SUSAN BARROSO: No. The poles are in the middle -- I think the way the poles are out there it's in the middle -- on the driveway right now but they want to extend the driveway so it will come in the middle and they have to move the poles next to the fencing and we have to put new conduit to the poles and then remove the other one.
