Board of License Commissioners Board Members Present: Nicole Murati Ferrer and Gerard Mahoney.

Staff Present: Elizabeth Y. Lint, Executive Director.

Public Testimony Matters:

Although matters were called in the order listed in the posted agenda, some matters required a second call due to the absence of the relevant parties when the matters were called. The matters are in the same order as listed in the posted Meeting Agenda, and if they required a second call, designation of the audio time stamp for both calls are listed.

1. Cancellation The Elephant Walk Restaurant Group, Inc. d/b/a The Elephant Walk, holder of a Common Victualler All Alcohol License linked to 2067 Massachusetts Avenue pursuant to M. G. L. c. 138, §§ 64 and 77 for non-use of said license.

Present: Gerard Lopez, Owner/licensee.

Documents Considered: Hearing notice and documents contained in file.

Summary: This hearing had been scheduled for 9/13/17 but no one showed up. The Board did not take action and reschedule the hearing due to the fact that the notice went to the business email address and did not go to the attorney that had represented the licensee at the last hearing.

Mr. Lopez testified the business closed on 1/1/2016, and there was a Purchase and Sale Agreement in place but the sale fell through. Mr. Lopez testified there had been some other negotiations with other buyers but none resulted in a sale. He is actively pursuing buyers to buy the business/license. He intends to renew the license.

Decision: Board voted (2-0) to hold a cancellation hearing for non-use in February 2018.

2. Violation Landscape Collaborative of NE, holder of Leaf Blower Permit #10039, due to alleged violation of Cambridge Municipal Code 8.16.081.2(a)- operating during a prohibited period- on August 30, 2017 at 9:06 a.m. at 74 Sparks Street.

Present: None. Landscape Collaborative filed a Waiver of Violation Hearing.

Documents Considered: Hearing notice and attachments thereto, file, and waiver of hearing.

Summary: The company had the same issue on 7/26/17. The Board heard that violation on 8/16/17 and issued a \$300 fine to be held in abeyance until 9/15/17; if no other violations were committed during that time, the fine would not have to be paid.

Decision: Board found (2-0) a violation and issued a \$300.00 fine. In addition, based on the violation occurring prior to 9/15/17, the \$300.00 fine that was held in abeyance would also have to be paid.

3. Violation Anahid Mikirditsian and Vahe Karagueuzian at 112-C Inman Street due to alleged violation of Cambridge Municipal Code 8.16.060(E)- measured noise disturbance.

Hearing date was changed to December 16, 2017.

4. Violation Landscape Gardening & Design, holder of Leaf Blower Permit #10018, due to alleged violation of Cambridge Municipal Code 8.16.081.2(a)- operating during a prohibited period- on July 19, 2017 at 9:06 a.m. at 43 Appleton Street.

Present: Michael Hanlon for Landscape Gardening; Andrea Boyer on behalf of the License Commission.

Documents Considered: E-mail from complainant, Virginia Coleman, violation notice, and file.

Summary: Ms. Boyer stated she received a complainant that on July 19, 2017 Landscape Gardening was using a leaf blower at 43 Appleton Street. Sometime later she received a call from the owner of the property asking if leaf blowers could be used and she was told "not at this time." Ms. Boyer testified the homeowner confirmed Landscape Gardening provides landscaping services to her property. The owner did not state that Landscape Gardening was using leaf blowers. Ms. Boyer stated that this company has not had any violations in the past. The complainant did not appear at the hearing.

Mr. Hanlon denied his employees were using a leaf blower at the location on the stated date and time. He explained the City was repairing the sidewalks in that area and it could have been the City the ones using the blowers.

Decision: Board found (2-0) no violation.

5. Application PPF OFF 200 Cambridgepark Drive, LLC, holder of a Garage and Flammables License at 200 Cambridgepark Drive has applied to amend their license to include additional flammables storage of: 1,885 gallons of Class I; 1,265 gallons of Class II; 815 gallons of Class III, and 251 CF of Gases.

Present: Michael Diminico on behalf of the building owner; and Jonathan Eisenberg on behalf of King Street Properties.

Documents Considered: Application and documents submitted therewith.

Summary: Mr. Eisenberg stated that this is a multi-use building. There is a new tenant coming in that requires a higher quantity of flammables. The changes are only on the 5th and 6th floors. All necessary sign-offs have been obtained.

Decision: Granted (2-0).

6. Application Colwen Management, Inc. d/b/a AC Hotels by Marriott Cambridge, holder of an All Alcohol Innholder License at 10 Acorn Park Drive has applied for a Change of Manager to Mark Fischer.

Present: Attorney James Rafferty; Mark Fisher, proposed manager.

Documents Considered: Application and documents submitted therewith.

Summary: Clarification was made that Mr. Fisher has been a manager of record on a liquor license before (the ABCC application submitted said he had not been). Mr. Fisher confirmed knowledge of the rules and regulations.

Decision: Granted (2-0) — Board will send notation with approval to ABCC regarding Mr. Fisher being a previously approved manager of record.

7. Application Dip Dog, Inc. d/b/a Café Du Pays, holder of a Common Victualler All Alcohol License at 233 Cardinal Medeiros Avenue has applied for a Pledge of License to Marotta Family Hldgs., LLC and an Alteration of Premise to: 1,600 SF on the first floor with 1 entrance and 2 exits, 2 dining rooms, bar, kitchen, and bathrooms. 800 SF in basement.

Present: Attorney John Shinn; John Kessen, owner; Rachel Miller Munzer, owner.

Documents Considered: Application and documents submitted therewith.

Summary: The request is due to the moving of the bar to allow for an accessible bathroom. There are no changes to capacity or the business.

8. Application Bon Me Foods, LLC d/b/a Bon Me, holder of a Common Victualler License at 60 Binney Street has applied to add Malt Only Beverages License at said address. Ayzhamal Sayakbaeva as Proposed Manager of Record of a premise described as: 2,097 SF ground floor space. Storage and food prep area; customer queuing and seating space, and restrooms. 600 SF outdoor seating on private property. Proposed seating capacity of 45 inside and 48 seasonal patio seats on private property, and proposed hours of 10:30 a.m. to 8:00 p.m. all days.

Present: Michael Feeney, Operations Manager and Patrick Lynch, CEO and Managing Partner of LLC. Proposed manager not present.

Documents Considered: Application and documents submitted therewith.

Summary: Received CV license approval in August and opened a week ago. Although they did not originally intend to serve alcohol, and they don't in any other location, based on customer's requests they believe this would be a valuable amenity for the customers. Ayzhamal Sayakbaeva took 21 Proof training along with staff that will be serving beer. Customers will order and get served at the counter. The closing hour for their current common victualler is 9 p.m. – the request was made to align the hours with the common victualler license. In the future, they would like to serve alcohol outside and will separate the area with stations. Finally, the restaurant does not currently have an entertainment license but play music at background level.

Decision: Granted (2-0) with 9:00 p.m. closing hour and an entertainment license for background music below conversation level.

9. Application John Harvard, LLC has applied for an Open Air Parking Lot License at 1-3 Langdon Street for 21 parking spaces.

Present: Attorney Walter Sullivan; Peter Poras, president of Chestnut Hill Realty Trust; Gordon Moore, resident abutter.

Documents Considered: Application and documents attached thereto, and photographs submitted during hearing.

Summary: Mr. Sullivan represented that these are pre-existing parking spaces. Two have been removed to make space for twelve long storage bike facilities. There was a significant issue regarding safety of bikes leaving the lot on to Massachusetts Avenue. Therefore, the bike storage was moved to 15 Langdon Street. This makes it safer for the bikes. This is strictly for the residents.

Gordon Moore spoke about his concern that there be space for the trash cans. One quarter of the perimeter is covered barrels. Sometimes they overflow and he had to call the management company, who have been responsive. He understands they want to resolve the problem.

10. Application Massachusetts Institute of Technology, holder of a Garage and Flammables License at 32 Vassar Street has applied to amend their existing license to add an additional 136 parking spaces and 1,360 gallons of gasoline in the tanks of autos only.

Present: Kelly Brown, Senior Campus Planner at MIT.

Documents Considered: Application and documents attached thereto.

Summary: Proposed parking spaces for the MIT staff and faculty. It is not open to the public on a fee basis.

Decision: Granted (2-0).

11. Application Highgate Hotels L.P. d/b/a Courtyard Boston Cambridge, holder of an All Alcohol Innholder's License at 777 Memorial Drive has applied for a Change of Manager from Robert Rosenblatt to Lindsey Samuels.

Present: Lindsey Samuels, proposed manager.

Documents Considered: Application and documents attached thereto.

Summary: Ms. Samuels has not been the manager on a liquor license before. She has worked for Hyatt for about nine years and has been in the industry since she was 19. She has been responsible for food and beverage in the hotel clubs, as well as the manager on duty running food and beverage. She has been at the hotel since April and has been managing the food and beverages since then. She will also be the manager on the entertainment license. She has not been TIPS or 21 Proof certified.

Decision: Granted (2-0), Ms. Samuels must submit proof of 21 Proof, TIPS training, or similar safe serve training.

12. Application Wholesome Fresh MA, Corp. d/b/a Hello Fresh, has applied for a Common Victualler License at 60 Church Street with a seating capacity of 20 and proposed hours of 24 hours per day. Chris Cha as proposed manager of record of a premise described as: approximately 5,195 SF on the ground floor with 2 entrances. 1,500 +/- SF kitchen space.

Present: Chris Cha, owner and proposed manager; Attorney Sean Hope; Mark Kim, Vice President; Phil Cunningham, representative for the landlord.

Documents Considered: Application and documents attached thereto.

Summary: No changes to interior of space. Same concept as currently exists – 24-hour market with a package store license. The proposed owners have another location in Providence, RI. Both

owners have been in the industry for about 20 years. The d/b/a on the application should be Wholesome Fresh and not Hello Fresh.

Currently at this location there is an active and fully operational common victualler with a package store license. The landlord has a Court issued judgment for possession which has not been executed/exercised. The landlord has not taken steps to evict the market. They intend to work with current business for a smooth transition. The landlord does not have possession of the premises.

Decision: Board deferred (2-0) action on the application to further review the documents submitted, consider the representations made during the hearing, and because it found the application to be premature as there is a current license holder operating and with a right to operate at the premises.

13. Application Henry A. Sisco, Jr. has applied for a new Cambridge Hackney Driver's License.

Present: None.

Decision: No action.

5. Samantha Lombardo, on behalf of Jean Brooks Landscapes, Permit #LEF10022, has filed a Waiver of Disciplinary Hearing for Violation of Cambridge Municipal Code 8.16.081.2(a) operating during a prohibited time period on September 1, 2017.

Documents considered by the Board: Hearing notice, waiver of hearing filed by Jean Brooks Landscape, and file.

Summary: Landscaping company filed a significantly detailed response to the violation. The response includes steps taken by the company to avoid any future violations.

Decision: Board found (2-0) a violation and issued a \$300.00 fine to be held in abeyance for one year.

6. Ben Lavery, on behalf of Mitimco, has applied for an extension to his special noise variance until 12/31/17 from 7AM until 8PM.

Decision: Granted (2-0).
