#### **MEETING MINUTES**

## Meeting Started at 3:02PM

**Board of License Commissioners Board Members Present:** Nicole Murati Ferrer, Branville G. Bard, and Gerard E. Mahoney.

Staff Member Present: Elizabeth Y. Lint, Executive Director.

Note: Unless otherwise indicated, all votes were 3-0.

## **Public Testimony Matters:**

1. Disciplinary Lamplighter Brewing Co, LLC d/b/a Lamplighter Brewing, holder of a Malt Only Pub Brewery License at 284 Broadway, due to allegedly Permitting a disorder, disturbance, or illegality on a licensed premise, to wit, Overcapacity in violation of M. G. L. c. 138 §§ 23 and 64 and Rules and Regulations of the City of Cambridge Board of License Commissioners Rule 9.

**Present:** Andrew Jones, owner; Tyler Bubenik, Licensing Investigator; Capt. Arsenault, Fire Prevention; Deputy Chief Peter Donovan; Officer Benny Szeto; and Brian McMahon, Inspectional Services.

**Documents Considered:** Violation notice and documents attached thereto; current establishment floor plan; and file.

Summary: A Task Force Investigation was conducted on February 9, 2018. Mr. Bubenik testified that a head count showed there were 96 patrons in front room, which was below the capacity of 120, and the back room had 129 which was over the capacity of 80. Deputy Donovan testified that there were coats blocking the emergency egress. Mr. McMahon confirmed the backroom had been recently opened and the flow of persons had not yet been established. Since the inspection, ISD has amended the certificate of inspection to provide a capacity of 160 in the front room and 135 in the back room. Although the premises has a maximum potential capacity of 295, based on the sanitary code the maximum total is 200. Mr. Jones did not contest the facts as presented by the City's staff. The licensee will now have a person in the front room and one in the back room keeping count.

**Decision:** Violation for overcrowding and issued a one-day suspension to be held in abeyance for 6 months. The Board will review the capacity at next week's hearing due to issues raised during the hearing.

2. Appeal Kesner Noel, holder of Cambridge Hackney Driver's License # 21318, is appealing the decision of Hackney Officer Szeto due to a complaint received by a customer regarding service and fees.

**Decision:** The matter was continued prior to the hearing to April 11, 2018 at the request of the driver.

3. Gustazo-Cuban Café, LLC d/b/a Gustazo Cuban Cafe, has applied for a Common Victualler All Alcohol License at 2067 Massachusetts Avenue. Patricia Estorino as Proposed Manager of Record of a premise described as: Approximately 2,927 SF on street level with one dining room, bar and kitchen; Approximately 4,260 SF on lower level with two dining rooms, bar, auxiliary kitchen and storage; patio seating on public property. The proposed hours of operation are 11:00 a.m. to 1:00 p.m. seven days per week and closed between 3:00 p.m. and 5:00 p.m.

**Present:** Patricia Estorino Lojos, owner and proposed manager of record; Adolfo De La Vega, business partner; David Cagle, business owner; and Melissa Champness, business owner.

**Documents Considered**: Application and documents attached thereto; letter in support of application.

Summary: This is a Cuban restaurant and would be the first of its kind in the City of Cambridge. There are not that many Cuban restaurants in the state and this operation is meant to fill a void in this type of cuisine in Cambridge. There is an intent to offer live entertainment of a jazz trio and typical Cuban music to compliment the atmosphere. There is one Gustazo in Waltham, Massachusetts that has an alcohol license but is significantly smaller than this operation. Ms. Patricia Estorino Lojos is the sole beneficial interest holder, sole LLC member and proposed manager of record; Mr. De La Vega is a business partner. Ms. Estorino Lojos has been TIPS certified, is the approved manager of record at Waltham and has had no disciplinary issues with the Waltham Local Board or ABCC. There will be 253 seats inside total occupancy of 263 and 16 on the patio on public property. The CV application does not have lunch checked but they intend to be open for lunch.

The applicant needs to submit a signed lease. Also informed that if there is an intent to serve alcohol on the patio, they would have to sign an agreement with the City Manager. Councilor Toomey submitted a letter in support of the application. Mr. Cagle, a current licensee, spoke in support of the application, the food and the applicants as small business owners. Ms. Champness also spoke in favor of the petition.

Decision: Granted.

4. Application Give 'Em Enough Rope, LLC d/b/a The Automatic, holder of a Common Victualler All Alcohol License and Entertainment License at 50 Hampshire Street has applied to amend the Entertainment License to include: DJ and Live Musical instruments and/or vocalists with amplification.

Present: David Cagle; and Melissa Champness.

**Documents Considered:** Application submitted and documents attached thereto.

**Summary:** Zoning only permits live music or DJ at this location one time per week. This would mostly be used for special events or to enhance a slow evening. It is intended to be used during the regular business hours.

**Decision:** Granted with the condition that the entertainment be 1 time per week only due to zoning restrictions, with the same hours of operation as are on the current license.

5. Application Colwen Management, Inc. d/b/a Fairfield inn & Suites, holder of an All Alcohol Hotel License at 209-215 Monsignor O'Brien Highway, has applied for a Change of Manager to David Michael Laurent.

**Present:** David Laurent, proposed manager; Rashi Mangaliet; and Chris Moulton.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Mr. Laurent was the manager of record of an innholder with alcohol in Needham and did not have disciplinary issues with the local board or ABCC. He is currently TIPS certified.

**Decision:** Granted.

## **ADMINISTRATIVE MATTERS**

All the below listed matters are considered and voted upon by the Board without public testimony. Unless otherwise indicated, all the matters are decided upon by the individual review of the papers/applications before the Board members and each member votes upon the matter. The summary of what is considered by the Board, unless otherwise indicated, is the identifying information of the matter as listed on the agenda.

6. Tim Stein, on behalf of Brookline Bank, has notified the License Commission that Medallion 249A [sic] has satisfied their loan agreement with the bank and the lien has been released.

**Summary:** This actually relates to medallion # 252A.

**Decision:** Acknowledged.

7. Tim Stein, on behalf of Brookline Bank, has notified the License Commission that Medallion 257G has satisfied their loan agreement with the bank and the lien has been released.

**Decision:** Acknowledged.

8. Commonwealth Restaurant has advised the License Commission that although they generally close at 10:00 p.m., they would like to keep their permitted closing hour at 1:00 a.m. for occasions when they have private events.

**Summary:** Rule 6.1 states that licensees are expected to operate in accordance with the terms and hours of each of the issued licenses. When the Rule was implemented, the Board was comprised of other members. In the past, the Rule has been construed narrowly. The Board recognizes that the previous Board used to have a stricter view of Rule 6.1 but allowing a business the flexibility to work within the hours granted is important for businesses to survive. The business has a duty to be transparent with the public and post operating hours on website and door.

**Decision:** Acknowledged and granted. The business must post operating hours on website and door.

9. The Board of License Commissioners will discuss whether to create new rules and regulations for self-driving taxi cabs.

**Summary:** At this time, considering any change regarding self-driving vehicles would be premature. There needs to be more testing done for commercial purposes.

**Decision:** No changes at this time.

10. The Board of License Commissioners will consider waiving renewal fees for existing medallions and hackney drivers for FY19.

**Summary:** The decline in the taxi industry is palpable. For the last couple of fiscal years, the renewal fees have been waived to provide some type of relief and support to the industry. Seeing how the industry is still in peril it would be beneficial to waive fees.

**Decision:** Fees waived only for the renewal of medallions (a/k/a the inspection fee) and renewal of hackney driver's licenses, considering the current state and consistent with the last 2 years. Livery inspection and license renewal fees are not waived.

11. Himalayan Arts & Crafts, 8 Bow Street, was approved for a second-hand goods/antiques license on July 25, 2017. Investigation reveals that this license is not needed as they only sell new items.

Decision: Acknowledged - license cancelled and file closed.

12. Tomolly, Inc. d/b/a Charlie's Kitchen and the Red House, holder of a common victualler all alcohol license at 10 Eliot Street, has applied for a change to their entertainment license to include karaoke on Tuesdays from 10:00 pm until 12:30 AM and Trivia Sunday and Wednesdays from 8:00 PM until 10:00 PM.

**Summary:** Applicant already has live music/entertainment on their license.

**Decision:** Acknowledged and granted.

13. Museum Market has notified the License Commission that they ceased operating on February 25, 2018.

**Summary:** This is the holder of an all alcoholic package store beverages license. They have ceased operating and have listed the license with a broker with an intent to sell and transfer the license.

**Decision:** Acknowledged.

14. One Broadway Donuts, LLC d/b/a Dunkin Donuts, holder of a Common Victualler License at One Broadway/380 Third Street is requesting to relocate the existing CV from 1 Broadway side of building to 3<sup>rd</sup> Street side of building (380 Third Street).

**Summary:** The business is relocating within the same building based on the remodeling of the building.

Decision: Acknowledged and granted.

15. Cupcake City, LLC d/b/a Cupcake City has applied for a hawker peddler license to be exercised on Tuesday's [sic] at 3<sup>rd</sup> and Binney Streets from April 2 through November 23, 2018.

Summary: The request is actually to exercise on Thursdays at the proposed location.

**Decision:** Granted for Thursdays, as requested.

16. Gurbani Jasmine d/b/a Tandoor and Curry on Wheels has applied for a hawker/peddler license to be exercised on Wednesday's at 3<sup>rd</sup> and Binney Streets from April 4 through November 24, 2018.

Summary & Decision: This request was granted through the renewal process.

18. Al Vatour on behalf of John Moriarty and Assoc. has applied for a Special Noise Variance to be exercised on March 23 through March 25, 2018 [sic] from 7:00 AM to 9:00 AM for dismantle of a crane tower at 35 Cambridgepark Drive.

**Summary:** After the original submission, the applicant requested the variance dates change to April 6-8.

Decision: Granted for April 6 through April 8.

**Decision:** Granted, subject to making monthly payments to Traffic, Parking and Transportation for the special permit.
