## MINUTES FOR THE BOARD OF LICENSE COMMISSIONERS MEETING OF MONDAY, JUNE 29, 2020 At 5:00 p.m.

This meeting was held by remote participation through Zoom, pursuant to Governor Baker's Executive Order of March 10, 2020, suspending certain provisions of M.G.L. ch. 30A.

1. Application #75851 Colwen Management, Inc. d/b/a Fairfield Inn and Suites, 209 Monsignor O'Brien Highway, All Alcohol Innholder License #10760, for a Change of Manager to Robert Michael Ayers.

Present: Attorney Rashi Mangalick; and Robert Ayers.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Mr. Ayers stated that he has been working at the hotel since March. He has managed a hotel before but has not been the manager of record on a liquor license. He also stated that he will update his TIPS certification and upload the certificate to the record.

**Summary:** The Board received a legal opinion from the Law Department that a renewal fee cannot be waived. The Board also did not think it was appropriate to waive or reduce the fee considering this is an essential business that has been operating. However, considering the general effects COVID-199 has had on all businesses, the Board discussed extending the renewal fee deadline as it had done so for other types of businesses as well.

**Decision:** The Board voted 2-0, by roll call vote, to deny the request. However, by roll call vote, the Board voted 2-0 to extend the deadline of the waste hauler license renewal fee until the end of July.

Must inform abutters at least 48 hours prior to commencing the work.
