#### **Applicant/Licensee Testimony Matters**

1) Disciplinary S.L.W. & P. Hong Kong Rest., Inc., d/b/a Hong Kong Restaurant, 1238 Massachusetts Avenue, Common Victualler All Alcohol License #11688, for allegation of employee making improper bodily contact with a patron on December 6, 2019, in violation G. L. c. 138, §§ 23 and 64, and Board's Rules 2, 2.5, 5.1 and 8.1. [Time Stamp: 01:05]

Summary: Testimony elicited at the hearing was that Hong Kong staff called the police on December 6, 2019 as a patron and a bouncer having an altercation. Investigation revealed that the patron was trying to leave without paying his bill. The patron became argumentative and threatening. The patron pushed and punched Mr. Parks, the bar manager, and he was then taken to the ground. Hong Kong staff stated that thy did not feel he was intoxicated, but that there was something wrong with him. When police arrived, they found the patron to be uncooperative and agitated. Officer Burke stated that the patron stated his friend had died that day and he appeared to be looking for a fight. They found a metal pipe in his bag. Officer Burke stated further that the Hong Kong staff acted reasonably under the circumstances. He asked Mr. Parks if he wanted to press charges and he said he did not.
