BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES Thursday, December 9, 2021, 10:30 a.m. Held Via Zoom

This meeting was held remotely in accordance with Section 20 of Chapter 20 of the Acts of 2021, signed into law on June 16, 2021.

Decisions: All votes were by roll call vote, 3-0, unless otherwise stated.

Public Testimony Matters

1. **Application # 148564** Star Markets Company, Inc. d/b/a Star Market, 699 Mount Auburn Street, Package Store License #11306, change of officers/directors.

Present: Nicholas Zozula, attorney.

Documents Considered: Application and documents attached thereto.

Summary: This is a top-tier change, no other changes to the operation. One of the listed directors has retired and been replaced by another who is a MA resident; the other is an officer that has left the company, and was just removed from the business.

Decision: Granted.

Summary: There is a presumption of need for a license at this location. This would be a full-

service seafood restaurant, with a d/b/a name change to Moeca, to cater to the neighborhood's needs and compliment what is there already. Would want to start operating at 11 a.m. for lunch. There will be cosmetic changes to the space, and gas operated cooking facilities. Will not be using a wood fire grill. Ernani Michael Pagliarini has extensive experience in the industry with no disciplinary issues.

Applicants stressed they are opening a dining establishment not a bar. The hours sought are to provide flexibility and ultimate hours will be structured once the demand of the niehgborhood is determined. The operators' experience has provided them the opportunity to navigate the concerns raised by neighbors and they are confident they will enhance the quality of life of residents and neighbors.

Decision: Granted with the amended d/b/a of Moeca and amended opening hour of 11:00 p.m.

The updated request is to operate 2:00 p.m. – 5:00 a.m. Thursday-Saturday, although the "classes" would not be late at night.

Present: James Rafferty, attorney; Julien Vazquez; and Jose Zamora. Persons who spoke in support of application: Diego Torres; Hichem Benyamina; and Payum Noshiravan.

Documents Considered: Application and documents attached thereto; website; business plan; and correspondence regarding application.

Summary: [Testimony from October 19, 2021 referenced/discussed]. Admission would be to members and students only and only for entertainment purposes. There would be a DJ and dancing by patrons. The structure behind the business is to have students perfect their skills in more traditional nightclub setting. They would operate 7 days a week with hours of 2:00 p.m. - 1:00 a.m. Sunday through Wednesday and 2:00 p.m. - 5:00 a.m. Thursday through Saturday. Their classes would not be all the time properly Monday - Thursday 6:00 p.m. - 9:00 p.m. They are trying to support a culture of experimental/underground house, dance and techno music.

There was discussion on how the plan seems to be "all over the place" and how they would control the food traffic and the no service of food or alcohol. However, the hands-on teaching method/approached was supported and understood as something unique. From 2015 to date, the membership has been between 50-100. They would ensure there is no re-entry and classes would be for groups of 4-6 people. The area is commercial and no residents abut the location. The applicants must submit a floor plan which is stamped by an architect or engineer to ensure the capacity and load requested is sustainable.

Minimizing impacts to pedestrian and vehicular traffic are an additional consideration.
