BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA Wednesday, April 28, 2021, 1:00 p.m. By Remote Participation

The meeting was held by remote participation through Zoom, pursuant to Governor Baker's Executive Order of March 12, 2020, suspending certain provisions of M.G.L. c. 30A, due to the COVID-19 Pandemic. Meeting started at approximately 1:00 p.m.

Board members in attendance: Chair Nicole Murati Ferrer (present); Commissioner Branville Bard (present); and Chief Gerard Mahoney (present).

Staff member in attendance: Elizabeth Y Lint.

Note: All decisions/votes were by roll call vote, and 3-0, unless otherwise specified.

1) Informational Coleman Murray, Inc. d/b/a The Field, 20 Prospect Street, Common Victualler All Alcohol License #11677, for non-use pursuant to, but not limited to, M. G. L. c. 138, §§ 23, 64, and 77.

Present: Jeremiah Coleman was expected to appear for The Field, but he did not appear.

Documents considered: Hearing notice, and file.

Summary: Board was aware that the previous time Coleman did not show up was due to medical issues. The Board discussed just providing the 6 months that are required per the current case law or reaching out to the licensee and obtaining an update.

Decision: Deferred – the Board, through the License Commission staff, will reach out to the licensee and obtain an update.

2) Application #107483 Juicy Peach, LLC d/b/a Viale, 502 Massachusetts Avenue, Common Victualler All Alcohol License #11506, has applied for Change of LLC Managers, Change of Beneficial Interest, and Change of Manager to Greg Reeves.

Present: Greg Reeves and Attorney Matthew Solomon.

Documents considered: Application and documents attached thereto.

Summary: Buying out Mark Young, nothing in terms of the operation is changing. Licensee reminded that the 85% remainder of the renewal fee will need to be paid by May 31, 2021. Reeves has never been the manager of record on a liquor license but has extensive experience and has managed

this location collectively with Young. Reeves is familiar with the rules, regulations, and laws regarding the sale and service of alcohol. Will provide certificate of training, 21 Proof.

Decision: Granted.

3) Application #111658 Tomolly, Inc. d/b/a Charlie's Kitchen/The Red House Restaurant, 10 Eliot Street, Common Victualler All Alcohol License #11679, for an Alteration of Premises, Change of Manager to Jacobus Overgaag, and Change of d/b/a to Charlie's Kitchen. The proposed premises description is: Approximately 4,000 square feet including First floor dining area with bar and bathrooms; Second floor dining area with bar and bathrooms; Ground floor patio on public property; Beer garden on private property.

Present: James Rafferty, attorney, and applicants Paul and Jaap Overgaag.

Documents considered: Application and documents attached thereto; file.

Summary: Application interrelated with next one on the agenda. Jacobus Overgaag has managed the business collectively with Paul, has extensive experience in the business, and is familiar with the rules, regulations, and laws regarding the sale and service of alcohol. Will provide certificate of training, 21 Proof. The intent is to continue operating Charlie's as is and there will be no changes to the operation.

Decision: Granted.

4) Application #111650 Overlind Industries, LLC d/b/a The Red House, 98 Winthrop Street, has applied for a new Common Victualler All Alcohol License with proposed hours of operation of 10:00 a.m. to 11:00 p.m. all days with proposed seating for 44 inside, an occupancy of 50, and 50 outdoor seats on public and private property. Molly Overgaag as Proposed Manager of Record of a premises described as: First Floor: 2 dining rooms and a bar, kitchen, bathroom and outdoor patio on public and private property. Second floor: storage space and bathroom.

Present: James Rafferty, attorney, and applicant Molly Overgaag.

Summary: Molly Overgaag, will be taking over the operation along with her husband. They will have their own kitchen. Has never been the manager of record but she has been around the restaurant for many years, has experience working at the restaurant, and is familiar with the rules, regulations, and laws regarding the sale and service of alcohol. Has provided proof of training in alcohol service.

Decision: Granted.

5) Application #111632 Devonshire Restaurant Group, LLC d/b/a Drifter's Tale, 1281 Cambridge Street, has applied for a new Common Victualler All Alcohol License with proposed hours of operation of 8:00 a.m. to 1:00 a.m. Monday through Wednesday, 8:00 a.m. to 2:00 a.m. Thursday through Saturday, and 10:00 a.m. to 1:00 a.m. Sunday with proposed seating for 99 and an occupancy of 99. as Proposed Manager of Record of a premises described as: Approximately 2,400 square feet on ground level. Main entrance/exit on street level; one dining room with kitchen. Separate bar area. Approximately 2,000 square foot basement for storage.

Present: Attorney Peter Pasciucco, and applicants Jairo Dominguez, Barry Rafferty and Aron Freeman.

Documents considered: Application and documents attached thereto.

Summary: This is a global comfort food and gastro bar tavern. The location used to be occupied by Bukowski. Barry Rafferty and Jairo Dominguez have over 20 years of experience in the industry. Aron Freeman has been manager of record on a liquor license for approximately 7 years with no disciplinary issues. Freeman is familiar with the rules, laws and regulations regarding the sale and service of alcohol and provided proof of alcohol training certification.

Decision: Granted.

6) Application #112519 Season to Taste Catering, LLC d/b/a Season to Taste, 2447 Massachusetts Avenue, Common Victualler Wine and Malt Beverages License #11427, for an Alteration of Premise to increase the patio from 160 square feet to 265 square feet. The proposed premises description is: Approximately 1,000 square feet that has an open kitchen, one bathroom and a rear emergency exit to a private back alley area that connects to the street. Approximately 265 square foot patio on the public sidewalk.

Present: Robert Harris.

Documents considered: Application and documents attached thereto; file.

Summary: Going from 8 seats to 20 seats. Harris represented he had been provided a sidewalk business use permit. The area to which Harris is seeking to expand is the same as the one approved through the temporary extension.

Decision: Granted, pending confirmation of sidewalk obstruction permit for the use of the area.

Decision: Granted pending submission of Certificate of Inspection and proof of workers' compensation insurance.

9) Application #116511 Mary Morilla, on behalf of Odyssey PropCo, LLC d/b/a Holiday Inn Express Cambridge, 250 Monsignor Obrien Highway, has applied for a garage and flammables license for 9 parking spaces. This is new ownership of a previously licensed location.

Decision: Granted.
