## BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA Friday, July 23, 2021, 9:00 a.m. By Remote Participation Via Zoom

This meeting was held remotely in accordance with Section 20 of Chapter 20 of the Acts of 2021, signed into law on June 16, 2021.

#### **Public Testimony Matters**

1. Application #74610 The Boiling Crab Restaurant Group, LLC d/b/a The Boiling Crab Restaurant, 96 Winthrop Street, has applied for a new Common Victualler All Alcohol Beverages License. The proposed hours of operation are 3:00 p.m. to 10:00 p.m. Monday through Friday and 12:00 p.m. to 10:00 p.m. Saturday and Sunday with proposed seating for 218. Randall Nuguid as Proposed Manager of Record of a premise described as: 6,024 square feet on three floors with 2 Entrances, 2 Exits. Lower Level Dining Room w/ one unisex accessible restroom, kitchen, and elevator to access upper level (except for the employee only Mezzanine). Upper level dining with 2 restrooms and employee only Mezzanine and employee restroom. Number of rooms with public access: 2 rooms not including 3 restrooms. Kitchen located on the main level. Freezer & Cooler located on the lower level.

**Present:** David Nguyen and Andrew Upton attorney.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This is a nation-wide operation with over 20 locations with liquor licenses, with no disciplinary issues. This will be a full-service restaurant with a unique concept of communal tables and boiled shellfish based on the Texas Louisiana area – you eat with your hands, it is the crab boil experience. They have a policy to card all persons regardless of appearance. David Nguyen has extensive experience, especially with this company. He will be the "placeholder" manager until they open in December and hire a new general manager. He has signed up for TIPS. This location had a liquor license before, so there is a presumption of public need.

Erin Bashllari as Proposed Manager of Record of a premises described as: 1750 sq. Ft, 1floor For kitchen, bar and dine-in, patio area with seats in summer. basement used for storage. public access only in 1st floor and Patio. 1main entrance, 3 safety exits, 1 door to access to the patio, 1 door in Patio to exit property. Speakers In the dine in for background music and band for music in the Patio area in summer time.

**Summary:** The club has always operated music for its members, it was not aware it did not have the proper licensing. This is meant to provide the amenity as part of their culture to experience music with their food. It is not meant to open up the club for others. This is for the members, the older crowd, nothing too amplificated and it is meant to be cultural, light dance music. The concerns regarding trash – they have someone that cleans inside and outside every day. However, nips and scratch tickets come from the patrons of the nearby liquor store. They will sound proof the door. They were also informed to be pro-active and reach to their neighbors so that the neighbors feel free to contact them with any noise or other disruptive issues.

Beer is the perfect accompaniment of fried hot chicken. All servers will be TIPS certified. Alex Nystedt has experience and is working on his TIPS certification.

**Decision:** Granted.

The issue with that is that although less noisy and disruptive, once you start you cannot stop. They do not intend to pour until 10 p.m. but it can be an issue. This variance is needed as it rises to a safety issue with the construction.
