# **BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA**

### **Public Testimony Matters**

1. Application #121737 PlantPub (Kendall), LLC d/b/a PlantPub, 675 West Kendall Street, has applied for a new Common Victualler Wine and Malt Beverages License with proposed hours of operation of 11:00 a.m. to 9:00 p.m. all days with seating for 15. Mary Dumont as Proposed Manager of Record of a premises described as: On first floor consisting of 1,519 square feet with kitchen, one (1) restroom, storage, dining area, counter for ordering and pick up, and grab and go refrigerator. There is one entrance into public retail space of premises, one doorway from retail area to hallway containing the restroom.

**Present:** Marci Costa, Patrick McAuley, Mary Dumont.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Applicants are trying to redefine pub food and bring a modern feel – sustainability – recreating classic pub fare, better for us and planet – 100% plant based. Creating it in an atmosphere that is approachable and sustainable, also offering local craft beer and wines. Seeking for a total capacity of 18. Mary Dumont, has been an approved manager of record with no issues other than administrative. Has been trained before and scheduled to update it.

**Decision:** Granted.

2. Application #123613 Vester, LLC d/b/a Vester, 75 Ames Street, Common Victualler Wine and Malt License, has applied for an Alteration of Premises to include approximately 320 square feet of patio space on the public sidewalk.

**Summary:** Seeking a total of 24 seats (8 of which are on private property against the building). Acknowledged letters received in support of application.

**Decision:** Granted.

3. Application #122792 Shack Foods of Harvard Square, LLC d/b/a Summer Shack, 20 University Drive, has applied for a new Common Victualler All Alcohol License with proposed hours of operation of 4:00 p.m. to 11:00 p.m. Monday through Friday and 11:00 a.m. to 11:00 p.m. Saturday and Sunday with seating for 110 and an occupancy of 130. Carlos Eduardo Almeida as Proposed Manager of Record of a premises described as: Approximately 1,000 square foot patio on private property with tables, bar, service station, and kitchen. Applicant is also applying for an Entertainment License to include live music without amplification to cease at 9:00 p.m.

**Present:** Attorney James Rafferty, Patrick Lyons, and Carlos Almeida.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This was the space that was previously occupied by Legal's (presumption of public need) and which the Summer Shack operated as last summer (this operation would also be weather permitting). The tables at the plan are all for four people each. Therefore, 96 seats at tables and 30 at bar. Total capacity would be 126 seats with 20 standing. Carlos Eduardo Almeida, has been with Summer Shack for more than 10 years and his work experience there has trained him for this position. Has TIPS certification.

**Decision:** Granted with 126 seats and 20 standing.

4. Application #124523 Charles Fine Dining, LLC b/d/a Bar-Enza, One Bennett Street, has applied to transfer the Common Victualler All Alcohol License held by Benedetto, Inc. d/b/a Benedetto, One Bennet Street. The proposed hours of operation are 4:00 p.m. to 1:00 a.m. Monday through Friday and 10:30 a.m. to 1:00 a.m. Saturday and Sunday with seating for 201 inside, inside occupancy of 240 and 29 patio seats on private property with an outside occupancy of 40. Gabriela Choate as proposed Manager of Record of a premises described as: Restaurant on second floor consisting of two dining rooms, bar and lounge (approximately 5,300 sf) and outdoor dining on terrace (approximately 1,000 sf). Applicant is also applying for an Entertainment License to include: recorded music above conversation level; live music with amplification; and DJ.

**Present:** Attorney James Rafferty, Patrick Lyons, Gabreila Choate.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Since this is a transfer, there is a presumption of public need for the license. The Chef is Mark Ladner (Italian Chef in NY with Michelin star award). Chef Mark was born and

raised in Belmont. The intent is to satisfy the needs of the hotel and Harvard Square neighborhood – not changing the space but for cosmetics. Different seating – nooks, booths, post pandemic world – paint, paper, furniture and fixtures and change the vibe and feeling of the space – physical stays the same, generally speaking seating capacity also the same. This would be similar to the Scampo concept which has a broad range of plates and options – popular prices \$25-75/person, depending on needs. They are going for a high quality experience.

An updated plan for the entertainment was supplied.

Gabriela Choate, has extensive experience, previously approved manager of record without disciplinary issues. Booked for new TIPS certification.

**Decision:** Granted, inclusive of both floor plans.

5. Application #122805 Sargent Hospitality, Inc. d/b/a Si Cara, 425 Massachusetts Avenue, has applied for a new Common Victualler All Alcohol License with proposed hours of 11:00 a.m. to 2:00 a.m. Monday through Saturday and 10:00 a.m. to 2:00 a.m. Sunday with seating for 59 inside, an inside occupancy of 90, 32 patio seats on private property, and an outside occupancy of 40. Michael Lombardi as proposed Manager of Record of a premises described as: 1,486 square feet of interior space on a single floor and 470 square feet of patio space, for a combined square footage of 1,956 square feet. There are two entrances/exits for public use and an additional service/employee entrance/exit. The space sits on the ground floor of a multi-story building.

**Present:** Attorney Elizabeth Lashway, Michael Lombardi.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Proposed first class pizza restaurants – first floor of a new multi floor building. The outdoor area is fenced off on private property on the front. There is a significant buildout in the space, and therefore the capacity numbers are estimates at this time. With that said, the estimation is that the indoor seats are 55, and 32 outdoor seats on private patio. Total occupancy of 90 inside, and 40 outside. The public need is based on urban area primarily commercial, and MIT. There is a traffic increase in the area. They intend to subsidize train passes and provide blue bikes memberships for the employees. They will install sound buffers and provide good acoustics. The track record, based on previous operations, including SRV, is exemplary. Michael Lombardi, is TIPS certified.

**Decision:** Granted.

Monday through Saturday and seating for 14 and an occupancy of 18. Nicholas Zappia as proposed Manager of Record of a premises described as: Two floors; first floor is 847 sf with entrance from street level on Huron Ave and has service / coffee counter, kitchen area, bathroom, speakers for background music and second egress on Gurney Street side of the building. Basement level is 790 sf for storage and office. The applicant is also seeking an Entertainment License for recorded music above conversation level with amplification.

Present: Nick Zappia, Igor Ivanovic. Members from the public who spoke in support.

**Summary:** Seeking for common victualler and entertainment to be 7AM-10PM all days, and alcohol 4PM-10PM all days. This concept is an off shoot of what Iggy's has been; there is a coffee shop need in that neighborhood that has not been served. Line of coffee, butter, bread, and additional service that Formaggio does not have and neighborhood very vocal, after work on way to dinner, casual and comfortable setting. Nicholas Zappia, has extensive experience, been approved manager of record with no issues. Has TIPS certification. Acknowledged letters in support as well as extensive testimony from the public in support of the application.

Sam Stern - great idea. Eli Gurock – Magic Beans, across the street very much in favor of this idea, no cup of coffee, employees would love it. Doug Brown – great idea and fills some holes – lives a couple of yards away and co-chair of Fresh Pond alliance. Checks 2 boxes, not a lot of options first thing in the morning and nothing in evening hours get away from kids to catch up.

SNV Application #124636 Bill Wilbur on behalf of John Moriarty and Associates for 7/3/21 – 10/2/21 (Alt. 7/10/21 – 10/9/21) at 350 Water Street, from 7:00 a.m. to 6:00 p.m. on Saturdays only, to perform facade element detailing and roofing installation using swing staging and a lull. The variance is being requested to extend the workday to compensate for time lost to COVID 19 restrictions.

Present: Bill Wilbur, Investigator Tyler Bubenik.

**Summary:** The need is to elongate – working daily during the week until 6 p.m. Saturdays tend to be longer days – to support the materials catch up with schedule – the façade has dwindle down. Roof at 15 story – elongated delivery.

SNV Application #121436 Bill Czerepak on behalf of the MBTA for 7/30/21 – 1/5/22 (Alt. 8/1/21 – 1/5/22) at 131 Cambridge Street, from 6:00 p.m. – 6:00 a.m. Work is anticipated to occur on four to five days out of the week, for three weeks a month. The work will repair and rehabilitate the East Cambridge Viaduct using air compressors, pressure washers, drills, rivet busters, jack hammers, concrete saws, cranes, manlifts, lulls, concrete trucks, concrete/grout pumps, impact guns, light plants, sand blaster, grinders, and hand tools. The variance is sought to extend the work day and accelerate the construction schedule to complete the viaduct structural rehabilitation work coordinated with the GLX Project Green Line shut down period.

**Present:** Bill Czerepak, Horace Cooper, Diane Stokes, DPW, Investigator Tyler Bubenik.

**Summary:** The variance seeks to extend the current noise variance to the completion – flexibility to complete construction work. **Summary:** The main issue on this one had been that the capacity listed on the application did not match the floor plan. We finally got an updated floor plan and updated capacities. This is for 17 seats and maximum total occupancy of 32.

**Decision:** Granted with 17 seats and 32 total occupancy.

**18. COVID-19 Recovery Measures.** City has approved use of public way space for temporary extensions through January 1, 2022 (thinking of NYE). Board vote of May was through December 31, 2021. Consideration to extend through January 1, 2022.

**Summary:** This is only an issue as to temporary that have a combination of previously approved patios v. new patios since we closed the temporary patios at 11 p.m. per Board vote. When renewals come around, the Board will consider the request to operate beyond 11pm at that time.

**Decision:** Granted, the temporary extensions will expire on 1/1/22.
