BOARD OF LICENSE COMMISSIONERS' MINUTES

Thursday, September 29, 2022, 10:00 a.m. By Remote Participation

This meeting was held remotely in accordance with Chapter 107 of the Acts of 2022 signed into law on July 16, 2022.

Board Members (All Present): Nicole Murati Ferrer, Christine A. Elow, and Thomas Cahill.

Staff Member Present: Chris O'Neil, Administrative Assistant.

Decisions: All votes were by roll call vote, 3-0, unless otherwise stated.

Public Testimony Matters

1. **Application #185290** Boston Ramen Company, LLC, d/b/a Boston Ramen Company, 24 Holyoke Street, Common Victualler Wine & Malt License #130027, has applied for an Alteration of Premises to include an outdoor patio on public property in the parking lane. The proposed premises description is: Restaurant on first floor of building consisting of approx. 1,670 sq. ft. with dining room, kitchen, storage, and two bathrooms. One means of ingress and two means of egress. Approximately 267 sq. ft. patio on public property in the parking lane. Applicant is also applying for a Change of d/b/a to Bosso Ramen Tavern.

Present: Yasuhiro Sasago. Mark Mscisz.

Documents Considered: Application and documents attached thereto; and letter in opposition.

Summary: A lot of customers coming to the restaurant and they need the area to accommodate them more. This is a new outdoor area, in front of the parking lane, 267 sq. ft., 22 seats, with intended hours as those inside. The long table is visible from the inside. The d/b/a change is just name convention no changes to the business operation. The Sidewalk Street Business Use Permit ("SSBU") has issued.

Per the City's dining policy, two spaces are allocated and only if the patio will encumber upon the front of another business will they require input from abutters. Since this one does not, the City did not require notice from abutters. We provided the correspondence in opposition to the City but the City remains unchanged in their position, they still approve the area for use.

Mscisz opposed to the patio and only supported it if his business also received a dedicated parking area for the Andover Shop clients. Mscisz was referred to the traffic department but he confirmed the issue had already been raised with them and they did not approve his request.

Decision: Granted (2-1, Commissioner Cahill denied).

2. **Application #157532** C&A Investments LLC d/b/a Locke Bar & Restaurant, 6 Broad Canal Way, has applied for a New Common Victualler All Alcoholic Beverages License with proposed hours of 11:00 a.m. to 1:00 a.m. Monday through Wednesday, 11:00 a.m. to 2:00 a.m. Thursday through Saturday, and 9:00 a.m. to 11:00 p.m. on Sunday with alcohol sales starting after 10:00 a.m. with seating for 111 inside, an inside occupancy of 180, 69 patio seats on private property, with an outside occupancy of 90. Peter Lydon as proposed Manager of Record of a premises described as Ground floor 3,278 sq. ft. with 1,100 sq. ft. kitchen and storage and the remainder is bar and restaurant space. Outdoor patio on private property of approximately 600 sq. ft. Applicant is also applying for an Entertainment License to include: music above conversation; DJ; dancing by patrons; live music; trivia; and 5 TV's.

Present: Connor Brennan; and Peter Lydon.

Documents Considered: Application and documents attached thereto.

Summary: This would be part of the overall neighborhood building in Kendall Square; this would be located in the last condo in the linear building. This condominium will bring about 200 new residents to the area. This would serve the public need for all the new residents and visitors that will be injected into the area. The total square footage of the outdoor area is 600 sq. ft. There is a drink and food rail where people can either sit and stand; the bar is not at the window. The occupancy will be updated with the numbers as listed on the updated plan as the numbers have changed with the construction.

Peter Lydon has experience in the food and beverage industry and has been the manager of record on a liquor license before with o disciplinary issues with the local board or ABCC. Also is familiar with the rules, regulations and law regarding the sale and service of alcohol and has TIPS certification.

Decision: Granted, capacity will be set with final plans.

3. **Application 193948** Shojo Cambridge LLC d/b/a Shojo, has applied to transfer the Common Victualler All Alcoholic Beverages License currently held by Shojo Central, Inc. d/b/a Shojo, to the same location, 425 Massachusetts Avenue. The proposed hours of operation are 10:00 a.m. to 2:00 a.m. all days with seating for 50 inside, an inside occupancy of 66, 44 patio seats on private property, with an outside occupancy of 60. Brian Moy as proposed Manager of Record of a premises described as: Approximately 1,500 sq. ft. on ground floor with main entrance on Massachusetts Avenue; bar area and dining area seating with kitchen and storage in rear of premises. Seasonal outdoor seating on private property. Applicant is also applying for an Entertainment License to include: DJ; dancing by patrons; dancing by entertainers; theatrical exhibitions; comedy show; live music; juke box; and 6 TV's.

Present: Attorney Kristen Scanlon; and Brian Moy.

Documents Considered: Application and documents attached thereto.

Summary: This was a new license approved in March 2021 but has not issued, it has been in the final stages of approvals. Brian Moy, one of the original approved holders, bought out the other two original holders, became the majority beneficial interest holder and brought in two new members. One

of the previous members, Tran, passed away. The share distribution (the consideration) was received by his sister. The Board will require an affidavit from the sister to confirm the conclusion of the transaction. The same type of operation. Hence, the testimony as to the previous matter was incorporated by reference.

Moy explained there were general contracting delays but the construction is on way and they hope to open by November. They have 1,500 sq. ft. inside with 52 seats and maximum occupancy for 56. Still working with the architect for standing capacity. They have 900 sq. ft. on outside with roughly 90 seats. Updated floor plans will be needed and one that shows where the dancing, DJ and live music, jukebox will be located.

Moy is an approved manager of record with no disciplinary issues with the local board or the ABCC. Moy is familiar with the rules and regulations, and laws regarding the sale and service of alcohol and has TIPS certification.

Decision: Granted pending submission of the Affidavit from Tran's sister showing finalization of the transfer of stock/beneficial interest. Capacity will be updated per updated plans.

4. **Application #191438** Cambridge Cuisine, LLC d/b/a Puritan & Company, 1166 Cambridge Street, Common Victualler All Alcohol License #11463, to increase the seating capacity from 110 to 130 inside, and add an additional 20 standing.

Present: Will Gilson.

Documents Considered: Application and documents attached thereto.

Summary: Have added a restroom to be able to accommodate the additional capacity being sought. The additional capacity is needed to accommodate the public need and want for this location. The indoor capacity would change to 30 seats at the bar area, 40 seats in the private dining room, and 60 in the main room, for a total seating capacity inside of 130. Inside they are also adding 20 standing room. Total proposed indoor occupancy is 150. The outdoor capacity would remain the same at 20 seats.

Decision: Granted.

5. **Application #192236** Life Alive Café, LLC d/b/a Life Alive, 415 Main Street, Common Victualler License #164851, to add an approximately 500 sq. ft. patio with 24 seats on the public sidewalk.

Present: Daniel Brennan.

Documents Considered: Application and documents attached thereto.

Summary: This is a new outdoor area with patio on the sidewalk against the building due to the bus station and bike racks which would prevent the area from being against the curb. The hours of operation are meant to be the same as the indoor hours. The SSBU has issued.

Decision: Granted with amendment on premises description to show that the patio is against the building.

6. **Application #193932** Slawdog, LLC d/b/a State Park, One Kendall Square #300, Common Victualler All Alcohol License #11490, has applied to add Dancing by Patrons to their Entertainment License.

Summary/Decision: Removed from the agenda. This was a category already approved to be part of their license. During renewals at the height of COVID, they had requested it be removed so that they would not have to pay. The Board did not remove the category, and therefore, it was added back to their license as it was an already approved category.

7. **Application #194690** Mass Ave Wine, Inc. d/b/a Social Wines, 196 Massachusetts Avenue, Wine and Malt Package Store License #22271, for a Pledge of License, Stock, and Inventory to Middlesex Federal Savings, F.A.

Present: Attorney James Rudser.

Documents Considered: Application and documents attached thereto.

Summary: Pledge documents/promissory note attached to the application are unsigned and are meant to be signed upon approval. The applicant has provided an affidavit stating the promissory note, and pledge agreement/closing will happen once get they get final approval. There will be no changes to the operation, this is just to refinance some of the existing debt.

Decision: Granted.

8. **Disciplinary** John's Landscape Service, Leaf Blower Permit #10678, for alleged violations of CMC 8.16.081.2(a) – operating a leaf blower during a prohibited period, on September 10, 2022, at approximately 11:30 a.m., at 334 Harvard Street, and at approximately 1:52 p.m., at 56 Concord Avenue.

Present: Investigator Tyler Bubenik; and John Tighe.

Documents Considered: Hearing notice and documents attached thereto; and files.

Summary: Email from resident with multiple videos showing one employee operating a leaf blower. The second video shows the employee operating at the side of building. Tighe apologized for not appearing at the previous hearing and stated he believed his appearance was not required after speaking to Investigator Bubenik (there was confirmation a hearing notice was sent and received after the conversation). Tighe reiterated that prior to the August violation they had operated for almost 2 years without a violation. Tighe testified it is a constant battle with employees and argued that with over 2,000 visits to Cambridge throughout the season, the number of violations is "exceptionally small."

Tighe contested that the video only shows the operation not what happened after the fact. Meaning, whether the crew or supervisor made them stop. Tighe also testified he did not ask the crew or supervisor what happed.

Decision: Violation (2 counts) \$300 fine per violation, for a total \$600 fine.

9. **Disciplinary** Nolasco Enterprise for alleged violations of CMC 8.16.081.1(c) & 8.16.081.2(b) – operating without a permit (failure to adhere to a December 16, 2021 cease and desist order), and 8.16.081.2(a) – operating leaf blowers during a prohibited period on August 23, 2022 at approximately 12:57 p.m., at Everett and Oxford Streets.

Present: Investigator Tyler Bubenik. No representative showed up for Nolasco Enterprise.

Documents Considered: Hearing notice and documents attached thereto; and files.

Summary: Delivery receipt for notice. Lesley commercial landscaper and they have been noticed. Submitted an application to become permitted but have not responded to inquiries or completed it.

Decision: Violation (2 counts) \$300 fine per violation, for a total \$600 fine; \$100 hearing fee assessed.

Present: Investigator Tyler Bubenik. No representative showed up for S & J Landscape and General Services.

Summary: Delivery receipt for notice. Observed by the investigator. When applied for permit tried to register this non-compliant leaf blower and it was denied (and they were advised on the blower not being compliant).

Decision: Violation (1 count), \$300 fine; \$100 hearing fee assessed.

11. **Application #193991** Mike Carucci on behalf of John Moriarty Associates for a special noise variance on 10/22/22 - 11/13/22 (No alternate specified) at 441 Morgan Avenue, from 5:00 p.m. until 10:00 p.m. on a consecutive Saturday and Sunday to jump a tower crane using sledgehammers and a crane. The variance is sought to extend the workday to safely accommodate the crane jump, as the process cannot be safely left in an intermediate state.

Present: Investigator Tyler Bubenik; Michael Carucci; and Holly Sutherland. J Donais, resident. Mario Gamboa, resident.

Documents Considered: Application and documents attached thereto; and correspondence received in opposition.

Summary: There is a correction, the hours sought are 5:00 a.m. – 10:00 p.m. The variance is to start before 9:00 a.m. on the weekend, to work on a Sunday and to complete the work past the allowable 6:00 p.m. Applicant stated the crane jump requires good weather which is why the 4 weekends are being asked for but they only need one. Applicant informed jumping the crane is not a "noisy" event. The work cannot be done during the week because cannot have anyone else on site; the work is done by a small crew as it is a focused procedure. Ballpark it would take 10 hours to get the tie installed and 10 hours to get it jumped and locked back in. The Board questioned then why the hours requested if only 10 hours (why not 9 a.m. – 7 p.m.). J. Donais spoke in opposition and stated there is no reason this could not be done during the day. Applicant would need more information from the crew doing the work to determine whether the work could be done during different hours or if the need for additional hours could be minimized.

Decision: Under advisement; applicant needs to get information from the people doing the work on how long it will take, information as to why specifically the requested hours and why could this not be done during regular hours.

12. **Application #194790** Kaitlin Becker on behalf of PIDC Construction for a special noise variance on 9/29/22 - 9/30/22 (Alt. 10/3/22 - 10/4/22) at 21 Athenaeum Street, from 6:00 p.m. to 7:00 a.m. the following morning to perform a gas tie-in using an excavator. The variance is sought to minimize impacts to utility service.

Present: Investigator Tyler Bubenik; Sal Messina.

Documents Considered: Application and documents attached thereto.

Summary: This work requires relocation and piping installation. Tie in needs to be done and once they cut the line, it cannot be left and needs to be connected. Not extremely noisy method. Excavation is already done, and they use pressure, would not do backfill until the allowable hours the next day. Want to work to be completed by 10/11 p.m.

Decision: Granted with the conditions that only the tie in is allowed during the variance hours and no backfill or other type of work can occur outside the construction hours allowed per the Ordinance.

Summary: We were waiting for a floor plan to ensure that the entertainment would comply with the zoning limitations that the entertainment could not be more than 25% of the floor space. We have received the plan it appears to comply with the zoning regulations per our review and also zoning's review.

Summary: We did not vote on this matter pending the issuance of the SSBU, and an outdoor area plan that incorporated the requested changes by the Department of Public Works. An updated plan has been submitted and the proposed area has been approved by DPW. The outdoor area will be against the building, a total of 204 sq. ft. and 10 seats. Everything else is as we heard during the last hearing.

Decision: Granted with the amendment to the premises description that the total square footage is 204, and that the patio is on the public sidewalk against the building.
