## BOARD OF LICENSE COMMISSIONERS' MEETING AGENDA Thursday, June 9, 2022, 10:00 a.m. By Remote Participation

This meeting was held remotely in accordance with Section 20 of Chapter 20 of the Acts of 2021, signed into law on June 16, 2021. Meeting started at approximately 9:00 a.m.

**Decisions:** All votes were by roll call vote, 3-0, unless otherwise stated.

#### **Public Testimony Matters**

1. **Application #167949** Comedy Studio, Inc. d/b/a The Comedy Studio, 20 Brattle Street, has applied for a new General On Premises All Alcohol License with seating capacity of 160, and an occupancy of 180. Proposed hours of operation of 12:00 p.m. to 1:00 a.m. all days. Rick Jenkins as proposed manager of record of a premises described as: The Comedy Studio will occupy a 3,400 square foot parcel of The Abbot, a shopping center under development by Regency Centers at 20 Brattle St., Cambridge, MA. The Comedy Studio will occupy part of one floor. There will be one main room, two toilet rooms, and an office on this part of the floor. There will be one performance stage for stand-up comedians and a sound booth containing audio recording and amplification equipment. Applicant is also applying for an Entertainment License to include: Comedy show; live music with amplification; 3 TV/video screens; and 1 theatrical stage. This application was previously heard on May 2, 2022; this is a rehearing due to the applicant's failure to notify abutters within the time required under state law.

**Summary:** Incorporate by reference and make a part hereof the testimony solicited and received on May 2, 2022. No new information presented and no one from the public spoke.

**Decision:** May 2, 2022 vote ratified, granted.

**Documents Considered:** Application and documents attached thereto; correspondence received regarding application.

**Summary:** Residential condominium with underground parking. Fifty-year-old property for which they just took over management and noticed not properly permitted. The parking is deeded to individual units, and none rented outside. Flammable and Combustible Permit issued. No additional flammables stored. Jacobstein raised some operation and logistical issues. Renzi stated they would work with the neighbors to resolve any issues.

**Decision:** Granted.

3. **Application #168902** Chazumba, LLC d/b/a Felipe's Taqueria, 21 Brattle Street, Common Victualler All Alcohol License #11516, has applied for an Alteration of Premises to expand an existing outdoor seasonal patio on the public way on the sidewalk for a total of 24 seats. The proposed premises description is: Food preparation and storage in basement of approximately 2,350 square feet; approximately 2,350 square foot first floor cooking and seating. Approximately 700 square foot mezzanine seating, approximately 3,067 square foot roof deck and 411 square foot seasonal outside patio on the city sidewalk.

**Summary/Decision:** This matter was not heard as the applicant failed to notify abutters.

The proposed premises description is: Two floors. Ground level has a bar and banquettes. Basement has kitchen, storage, and additional dining. Three exits, two on ground level. Approximately 276 sf patio on the sidewalk curbside and into the parking lane.

**Summary/Decision:** This matter was not heard as the applicant failed to notify abutters.

Basement storage. 294 square foot patio on public property in the parking lane.

Has received training as to the proper sale and service of alcohol.

**Summary:** There were deliveries made/received on Monday, May 9, 2022 at 6:35 a.m., Saturday May 28, 2022 at 7:24 a.m., and Monday (holiday), May 30, 2022 at 7:04 a.m. Per the Ordinance deliveries on the weekdays cannot be before 7:00 a.m., and deliveries on weekends/holidays cannot be before 9:00 a.m. Two of the instances were as to new vendors, and the other was an existing vendor. The issue has been addressed with all the vendors and employees. Clover has also adopted a 3 strike rule: if attempt to deliver outside of allowable hours 3 times in a row, they terminate the relationship with them. In addition, Clover has now informed its vendors it does not accept deliveries prior to 7:30 a.m. on the weekdays to allow enough time or buffer so that they are not in violation.

**Decision:** Violation, \$300 fine to be held in abeyance for six (6) months.

**Summary:** No one showed up for Marco Landscaping. Notice was sent to Marco Vasquez. While investigator was on routine patrol on the morning of May 3, 2022, he observed an employee of Marco Landscape operating a Redmax EBZ8500, which has a manufacturer's specified noise emissions rating of 77 dBA.

**Decision:** Violation \$300 fine, send notice to property owners.

In 2020, Paiva received a cease and desist letter and had been informed of the City's Ordinance and process to become permitted. To date, the company has not applied or received a permit.

**Decision:** Violation, \$300 fine, send notification to property owners.

**Present:** Investigator Tyler Bubenik, Sal Messina, Marshall Harris, Rob Harris, Michael Caruso, and Joseph Maglitta.

**Summary:** Significant history in the area of noise complaints. Have had additional complaints about construction activity by PIDC Construction outside of the allowable hours at 100/150 Cambridgepark Drive. The first instance, March 26 (Saturday), it was persons who were moving into the building using the dumpster. The company failed to tell them about the City's rules. The second instance (May 16) it was the company's employees who were doing work inside the building and were removing waste. They did not have a variance to do work inside the building outside the allowable hours.

**Decision:** Violation for both instances, warning for the March incident and \$300 fine for the May incident.

13. **Application #178138** Abyssinia Coach LLC, has applied for a new livery license with a home office location of 240 Sidney Street. Abiye Gelaye as sole owner and driver.

**Decision:** Granted with the condition that no advertisement/signage permitted at the location.

14. **Request to Stay Suspension** Chazumba, LLC d/b/a Felipe's Taqueria, 21 Brattle Street, Common Victualler All Alcohol License #11516, has filed an appeal with the Alcoholic Beverages Control Commission ("ABCC") as to the Board's findings of the case heard and decided on March 25, 2022, and May 2, 2022. In that case, the Board issued a one-day suspension and based on the violation finding, the one day being held in abeyance for the case heard and decided on September 30, 2021, and November 16, 2021, was also ordered to be served. Felipe's Taqueria was set to serve the two days on June 9, 2022, and June 14, 2022. Based on the receipt of the request to stay, an alternate date of June 23 was given for the June 9 suspension date in order to have the Board consider the request to stay the suspension while the ABCC appeal is pending. If the Board denies the request to stay the suspension, the suspension will have to be served on June 14 and June 23, 2022.

**Summary:** The hearing at the ABCC will be de novo, meaning it will be presented as if our case was not. After the ABCC hears the matter they will decide (based on what they heard at their hearing)

whether our decision was proper and if so, whether the discipline imposed was commensurate or capricious. In this case, the licensee did not contest the violation. They did not present any mitigating factors and our decision was grounded on the first hand observations of our own investigator. The appealed filed does not specify anything, it does not present any errors of law or even contest that the Board's decision was not appropriate. The business has a solid disciplinary history including a similar violation. In addition, the Board's decision was very limited considering this history and was not punitive.

**Decision:** Request to stay suspension denied.
