# BOARD OF LICENSE COMMISSIONERS MEETING MINUTES October 25, 2023, 11:00 a.m.

By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Board Members (All Present): Nicole Murati Ferrer, Christine A. Elow, and Thomas Cahill, Jr.

Staff Member Present: Chris O'Neil.

**Decisions:** All decisions were 3-0, unless otherwise indicated, and by roll call.

## **Public Testimony Matters**

**1. Disciplinary** La Fabrica Central, LLC d/b/a La Fabrica, All Alcohol Common Victualler License #11593, 450 Massachusetts venue, for alleged violation of G.L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7 – Service/Sale/Delivery of Alcohol to an intoxicated person on June 11, 2023.

**Present:** Attorney Bill Kelley; Dennis Benzan; Renato Rodriguez; Juan Valenca; Charleen Benjamin; Officer Timothy Francis; Investigator Tyler Bubenik; and Tyler Bubenik. Sgt William LaMonica.

**Documents Considered:** Hearing notice and documents attached thereto; and file.

**Summary:** Police responded to call for an unresponsive party. When arrived, the party was against the wall. Individual claimed their personal property had been taken by the staff. Everything they claimed to be missing (id and credit card) were in their pocket. The individual had glassy eyes, alcohol on breath and appeared highly intoxicated. They were unable to call an Uber or friends to pick them up, and kept cancelling the calls from their phone to Uber, so the police placed them in protective custody; the individual was falling over and unsteady on their feet. The receipt showed that the individual had purchased 30 drinks at the premises: 5 Long Island Iced Teas, 2 Brugal 1888, 9 Sex on Beach, and 11 Green Tea Shots. The bill was \$386 not including tax, and there was an additional \$500 tip added to it.

The staff reported to the License Investigator that the individual was buying drinks for themself, a group of women and others at the bar. There was no security footage available because the system was getting upgraded. Supposedly La Fabrica did not serve more than one drink per person.

Juan Valencia stated the individual did not want to leave the establishment. They laid on the ground flat on their back. The individual was conscious, communicated with Valencia and Valencia understood what the individual was saying. Individual stated they did not want to leave without identification or credit card. Valencia confirmed that the bartender had provided it and at that point they called the police. The individual then sat with their back against the wall, and the police arrived less than 5 minutes afterwards. The police assisted the individual up and guided him towards the

outside, Valencia followed them outside. The individual was trying to call an Uber or some sort of ride but kept giving the police officers a hard time. Stayed until the police supervisor showed up.

Prior to police arrival, staff asked the individual if they were "okay." The staff did not see signs of intoxication, they individual was not being cooperative as to commands, but was not slurring words. Believe the individual had come the night before and inquired about VIP status for next night, but did not get it. VIP status requires purchase of a table, must be with a group, and must buy at least 1 bottle. The staff did not feel like Fire or EMS was required.

The bartender, Leakkanyka Roeum, explained the individual came back a couple of times with a group of girls and ordered them drinks; the individual had about 2-3 Long Island and the rest of the drinks were for other patrons. The group of girls, always the same, and they would also buy drinks for people next to them at the bar. There was another bartender on duty who also served drinks to the group. Roeum served most of the drinks, the other bartender served a round of shots and gave the girls water at the end of the night. The individual had 2 to 3 Long Island Iced Teas; although there were 5 on the tab, 2 were for the girls but they did not drink them and they were poured out. The individual had no shots. There is not a maximum number of drinks quota. Long Islands are strong drink, Roeum would not serve more than 3 to a person in one night. Roeum testified the 3 girls, drank the green tea shots and Sex on the Beach drinks, and the Brugal were drunk by the couple next to them at the bar. Green tea shot is a mixture of whisky, sour mix and lime. The individual did not have any shots.

Renato Rodriguez testified the individual was laying flat on the floor but was conscious. Rodriguez did not find the individual to be intoxicated. They conversed at bar, at floor, and responsive; the individual was being a difficult customer and batty but was not unresponsive. Rodriguez was not concerned about overservice but more about safety. Individual did not seem like they needed emergency services.

**Decision:** Motion to dismiss the matter, denied. Matter taken under advisement.

The current approved hours of operation are 11:00 a.m. to 1:00 a.m. all days with seating for 40 and an occupancy of 60. Hong Zheng as Proposed Manager of Record of a premises described as: approximately 3,269 SF first floor with dining area in the front and kitchen in the back. One front entrance and 3 exits in the rear.

Present: Attorney James Rafferty; Patrick Conte; Hong Zheng; Lin Xu; and Meixiu Xu.

**Documents Considered:** Application submitted and documents attached thereto, including petition in support of application.

**Summary:** Operating since 2021 with no issues. The lease will be amended to show the proper address of 465 Cambridge Street. ABCC application will also be amended to show maximum occupancy of 48 (per the floor plan). This is a small family business. There are about 60 signatures in support of the application from customers and residents, and also have the support of local business association. The owners have received the necessary training and meet all statutory qualifications.

This was a gift of father Herbert Kuelzer to daughters. No changes to the business. Physical/mailing address for the business is 89 Winthrop Street.

They will have six units, all around the new building, 3 in close proximity. They have jersey barriers with fencing and installing sound blankets fully enclosing the units. The units are powered by natural gas, piped in (the temporary gas service was installed previous week).

**Documents Considered:** Hearing notice and documents attached thereto; Target operational changes plan; police calls/theft reports; and file.

**Summary:** Moving the alcohol behind the register would be a massive reconfiguration, and there is currently not enough room with the current configuration. Janae Curry, Asset Protection Team Leader testified they only have persons at the front monitoring during peak hours. Cannot prioritize alcohol all the time, but right now guard it between 12:00 p.m. and 8:30 p.m. The coolers have gotten locks installed and one or two have been broken, but they have been fixed. They have seen local successful apprehension, 50% decrease in shoplifting in adult beverages. Reinforcing those, more flexible gate more visually appealing, about 98% effective. The current gates fulfill the spirit of the plan they submitted but are still working on it.

Right now the Target member takes the alcohol to the register – since have had gates locked, bring it to the guest each time, and bring it until they pay. Cannot do sale at self-register. Practice will continue. The area where the alcohol is location has motion sensors which is how the security members know to take a look at the monitors.

Target stressed there is a public need for the license at this location. They sell about \$300K in alcohol which shows a clear demand. In addition, Target is essentially a full one-stop store. Busiest time of the day is 4:00 p.m. and 7:00 p.m. on weekdays and Saturday afternoon. Inventory shrink is a huge national problem, so Target is in business and focused on getting this resolved to a 99% plus.

**Decision:** Under advisement.

Although MassDot may limit the hours during the daytime when the work can be performed due to traffic, MassDot informed the License Commission that the work could be performed during the day. We have received a significant number of complaints from residents in the area as to construction activity and noise. In addition, on the application, hearing and the subsequent reconsideration request, the applicant once again represents that the nighttime work is required by MassDot when it is not. The applicant also specifically stated at the hearing that although the work could be performed during the daytime, it was easier and faster for them to do it at night. This is insufficient to establish the need for a variance.
