BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES

Tuesday, February 7, 2023, 10:00 a.m. By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 107 of the Acts of 2022 signed into law on July 16, 2022, and commenced at 10:01 a.m.

Board Members: Nicole Murati Ferrer (present), Christine A. Elow (present), and Thomas Cahill, Jr. (absent).

Staff Member Present: Christopher O'Neil.

Decisions: All decisions were 2-0, unless otherwise indicated, and by roll call.

Public Testimony Matters

1) Follow Up Hearing [Continuance from December 1, 2022] Fresh Pond Auto Sales, Inc. (Used Car Dealer License #12774) v. City of Cambridge License Commission, et al., Middlesex Superior Court Docket No. 1981CV03873. Pursuant to Court Order, evidence will be "re-opened" to allow Fresh Pond Auto Sales to introduce expert witness live testimony or written submission of evidence related to the number of vehicles that should be permitted in the showroom at 307 Fresh Pond Parkway.

Present: Attorney Jesse D. Schomer; Lt. Christopher Towski; Attorney Paul Kawai. Doug Brown, business association representative.

Documents Considered: Report received from Fresh Pond's expert and file. Updated floor plan dated 12/12/22.

Summary: The current license has a condition that only 15 vehicles can be stored inside the premises. Fresh Pond's expert opines that storing 25 vehicles at this property would comply with Fire Code. An appeal as to the Board's decision was filed and a proposed compromise of allowing 20 vehicles to be stored inside the premises was submitted and presented to the Board.

Lt. Towski reviewed the proposed floor plan of 12/12/22 and agreed that the corrected sketch with a full 36 inches of clearance all around would satisfy any fire safety issues previously raised. Lt. Towski testified as to the benefits of having additional conditions such as signage on the maximum number of vehicles and person occupancy. If any larger vehicle is introduced, the number of vehicles stored would need to be reduced and the layout configured to have the 36 inch all around clearance. If there is a major fire, the large windows will be broken and used as form of entry. There was assent to all conditions as stated by Lt. Towski and agreement that if the Board adopted the recommendation, the appeal would be dismissed.

Doug Brown raised other unrelated issues regarding BZA conditions on the premises as well as the license conditions regarding the number of vehicles in the parking lot. The Board noted that any issues regarding the conditions of the license and any violations as to those have been previously addressed and were not within the scope of the hearing. Brown was provided a vehicle by which to file any new complaint as to the premises.

Decision: Conditions on license amended to allow total of 20 vehicles inside the premises and in the manner as depicted in the approved floor plan of 12/12/22, and the additional conditions that said floor plan must be conspicuously posted on the premises; the total person occupancy of the space must be posted conspicuously; if a larger vehicle is stored inside the premises, the number of vehicles inside must be reduced and the configuration must be such that there is a 36 inch all around clearance between the vehicles and the walls.

Is currently the manager of record on the innholder license for this location. Cox is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the running of an innholder license and the sale and service of alcohol. Cox provided TIPS as proof of training in the safe service, sale and delivery of alcohol.

Decision: Granted.

Summary: Desiree Ann Luliano has experience in the food and beverage industry and has not been the manager of record on a liquor license before. Luliano is currently the manager of record on the innholder license for this premises. 4) Disciplinary Republic Services, Solid Waste Hauler License #14078, for alleged violations of CMC 8.16.080(e) – Loading and unloading, on January 25, 2023, 9-11 Chester Street, and on January 27, 2023, 170 Gore Street, both at approximately 5:30 a.m.

Present: Investigator Tyler Bubenik. Maya Gonzalez, complainant.

Documents Considered: Hearing notice and documents attached thereto; and file.

Summary: No one from Republic Services appeared. Gonzalez testified as to the violation on Gore Street, a highly dense residential area. Gonzalez stated the early pick up also happened earlier that day. Gonzalez acknowledged the previous company also picked up early but the matter was resolved. Bubenik testified as to the evidence for the 9-11 Chester violation. Republic has a significant disciplinary record for similar violations, including incidents at 9-11 Chester Street.

Decision: Violation, 2 counts, \$300 fine per count for total fine of \$600. \$100 hearing fee for failure to appear. Notice of violation to owners of premises being serviced.

5) Application #207552 Mike Carucci, John Moriarty & Associates, for a Special Noise Variance on 2/24/23 – 3/26/23 (no alternate specified) at 441 Morgan Avenue, continuously from 6:00 p.m. on a Friday afternoon until 11:59 p.m. on the following Sunday night (staring at 4:00 p.m. Friday), to remove a tower crane using an assist crane. The variance is sought to extend the work day to accommodate the disassembly of the crane, as the process cannot be safely left in an intermediate state.

Present: Investigator Tyler Bubenik and Investigator Joseph Kelley. Michael Carucci, Superintendent, JMA and Holly Sutherland, Mitigation Manager, CSL Consulting. Diane Stokes, DPW Engineer.

Documents Considered: Hearing notice and documents attached thereto; and file.

Summary: The variance would only be needed for one weekend, but due to the need for good weather, they are asking for multiple weekends. It is work that will not be done piecemeal. The applicant is shooting for end of March. It is a long and dangerous process. The applicant will notice abutters when it will happen. The tentative timeline would be starting on Friday at 4:00 p.m. to assemble the assist crane which takes about 5-6 hours which would mean they would end around 10:00 p.m. Then on Saturday they would start at 6:00 a.m. dismantling which takes 26-30 hours depending on how well it goes. So on Saturday they would work from 6:00 a.m. – 11:00 p.m., and then would come back on Sunday at 6:00 a.m. until hopefully 4-5:00 pm. Then they would need an additional six hours or so hours to remove the assist crane. In a perfect world, they would be out of the site on Sunday at 10:00 p.m. the latest. In a not so perfect world, they would need to exercise the 24 hour request. This is the identical process (but in reverse) done in April when the crane was set up. DPW is in support of the grant of the variance as the work is required to remove the existing tower crane, requires road closures and it is very dangerous work that requires good weather.

Decision: Granted with the condition that once exercised and crane disassembled, variance grant becomes moot.

6) Application #208960 Ryan George, Turner Construction, for a Special Noise Variance on 2/25/23 – 6/3/23 (no alternate specified) at 290 Binney Street, from 7:00 a.m. to 9:00 a.m. on Saturdays, for an extension of an expired variance associated with the installation of utilities using hand tools, welding tools, cranes, excavators, triaxles, and skid steers. The variance is sought to minimize impacts to utility services in adjacent buildings.

Present: Investigator Tyler Bubenik and Investigator Joseph Kelley. Ryan George, Contractor/Asst. Superintendent, Turner Construction. Benjamin Paskal, Superintendent Turner Construction. Adam Reynolds, client.

Documents Considered: Hearing notice and documents attached thereto; and file.

Summary: This would be an extension on existing permit, for 7:00 a.m. start for Saturday. This is at the Blue Garage, and they are working deep 20-25 feet in the ground. They are dealing with 100+ year old sewer lines which they are trying to protect along with being sensitive to the abutters. Because many of the abutters are life sciences, not all of the work cannot be done during their regular hours because of the vibrations and effects it has on the work. There is also a need to take advantage of weekends when traffic and pedestrian is less/minimized. Acknowledged some complaints for overnight work but that has stopped, and they do not intend to reimplement the third shift work. The applicant was warned about arriving early to the site with trucks idling before 7:00 a.m. as that is disruptive to the community. There will be increased patrols in the area.

Decision: Granted.

7) Application #209502 Kaitlin Becker, PIDC Construction, for a Special Noise Variance on 2/7/23 to 2/24/23, (alternate dates 2/13/23 to 3/3/23) at 301 Binney, Monday-Friday 6:00 p.m. - 8:00 p.m. (also working regular hours), and Saturday 6:00 p.m. - 8:00 p.m. (also working regular hours). Installation of critical natural gas utility infrastructure, using welding machines. To allow for radiograph of welds, personnel cannot be present during this effort.

Present: Investigator Tyler Bubenik and Investigator Joseph Kelley. Sal Messina.

Documents Considered: Hearing notice and documents attached thereto; and file.

Summary: This will be from corner of Binney Street and Sixth Street. The majority of the installation has already been done and this is for the last 20 feet. They will need to re-excavate and then install the last 20 foot of piping and tie end with Eversource gas. They are seeking for a 12 hour day to be able to complete what they need to install since they have to coordinate the tie end with Eversource and a third party for 2/22/23. The radiograph welds need to be done while personnel are off site.

Administrative Matters

Unless otherwise indicated, all the below listed matters were considered and voted upon by the Board without public testimony. They were decided upon by the Board members' individual review of the papers/applications/matter before them. The summary of what is considered is the identifying information of the matter as listed herein.

8) Board Vote [Matter heard December 1, 2022] Disciplinary - Rush Hour Group, LLC. d/b/a Middlesex, 315 Massachusetts Avenue, Common Victualler All Alcohol License #85782, for alleged improper bodily contact between employees and individuals waiting to gain entry to the premises, resulting in an assault and battery or use of excessive force, in violation of the conditions of its license and the law, including but not limited to, M.G.L. c. 138, § 64, c. 140 and Board's Rules 2, 5.1, 5.2, and 8.1.

Summary: The evidence was that the group attempting to come into the Middlesex was suspected to be intoxicated. One of the persons in the group, pushed the bouncer who in turn pushed them back and then an altercation ensued, people scattered and the police later came. It is unclear from the evidence presented whether there was excessive force used, however I think it is undisputed force was used. I think it is also clear from the evidence that the bouncers tagged these individuals as "problematic" and knew that they were not going to be let in. The Board wondered why the bouncers did not call the police to try to scatter the individuals or if they did not have time, why they did not tell the potential customers they would call the police. After the incident, where it was clear that things got heated and out of hand, why the staff did not call the police (particularly to cover themselves and to also alert the police of this group which they allege had to go home because they were creating problems).

There was discussion that the business was not cited for failure to call police but the evidence substantiated a charge for it. Due to the manner in which the evidence came in there was a violation but because of the manner in which it came in, not sufficient to issue a suspension.

Decision: Violation, warning with order to have the establishment go over deescalating procedures with its staff and retrain them on the need to call police when they are trying to remove unruly patrons or during/after an altercation.
