BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES Tuesday, July 25, 2023, 10:00 a.m.

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Decisions: All decisions were 3-0, unless otherwise indicated, and by roll call.

Public Testimony Matters

1. Application #228379 95-99 Elmwood Street LLC, 95 Elmwood Street, has applied for a new Garage License for 34 parking spaces and 340 gallons of fuel in the tanks of autos only.

Present: No one appeared for the applicant.

Decision: Continue.

2. Application #231053 Rutu, Inc. d/b/a Tanjore, 878 Massachusetts Avenue, Common Victualler All Alcohol License #132251, for a Change of Officers/Directors, Change of Stock Interests, Change of Manager to Prabhjot Kaur.

Present: Sunil Nepali; Pushkar Neupane; Davinder Bedi; and Prabhjot Kaur.

Documents Considered: Application and documents attached thereto.

Summary: Of the current ownership only Sunil Nepali remains part of the corporation. Nirmal Lama and Mamita Lama remain on the corporate documents as directors but they too will no longer be part of the operation. They need to change the corporate documents to reflect the change.

Prabhjot Kaur has experience in the food and beverage industry and has four other restaurants. Has been the manager of record on a liquor license in Somerville and has had no issues with the local board or ABCC. Kaur is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol, and provided TIPS certification as proof of training in the safe service, sale and delivery of alcohol.

3. Application #217143 Cillstifiann, Inc. d/b/a The Druid, 1357 Cambridge Street, Common Victualler All Alcohol License #11667, has applied for an Alteration of Premises to include a seasonal outdoor patio on city property. The proposed premises is: Approximately 1152 square feet on the first floor with kitchen, dining and storage. Approximately 1152 square foot basement for storage. Approximately 250 square foot seasonal patio on city property on the sidewalk.

Present: Sam Kachmar and Tiffany Frary.

Documents Considered: Application and documents attached thereto.

Summary: The area sought is much smaller than what was approved during COVID-19 due to the new bike path. They are seeking 17 seats. Depending on where standing inside the premises, the outdoor area is visible from inside. The operating hours are intended to be the same as indoors (food – Sunday, 11:00 a.m. – 2:00 a.m., Monday-Saturday 8:00 a.m. - 2:00 a.m.; alcohol – Sunday, 11:00 a.m. – 2:00 a.m., Monday – Saturday 10:00 a.m. – 2:00 a.m.). The SSBU has issued.

Decision: Granted with the condition that while the outdoor area is open and operating, it must be staffed and managerial staff must be monitoring it.

4. Application #231029 Top Mix Flagship, LLC d/b/a/ Top Mix Bar & Kitchen Cambridge, 50 Cambridgepark Drive, has applied for a new Common Victualler All Alcoholic Beverages License with proposed seating for 221 inside, an inside occupancy of 234, and 84 seats outside on a patio on private property. The proposed hours of operation are 11:00 a.m. to 2:00 a.m. all days. Joseph Correia as proposed Manager of Record of a premises described as: Approximately 7067 Sq/Ft on the first floor and will include a bar room, dining room, kitchen, 3 bathrooms, office, trash room, Liquor room, and a "speakeasy" room. There will also be an outdoor area where we will have dining. Applicant is also applying for an Entertainment License to include amplified recorded music above conversation level; dancing by patrons; dancing by entertainers; amplified live music; theatrical exhibitions; floor show; light show; dynamic performances; DJ; comedy show; karaoke; acrobatic show; beauty contest; talk show; and six TV's.

Present: Joseph Correia.

Documents Considered: Application and documents attached thereto.

Summary: Traditional bar food with Caribbean twist. Establishing a restaurant that has live entertainment, the area is up and coming in which they are building 2,000 new residential units and within the building itself about 400 units. They want to become a flagship restaurant for the area. In terms of the entertainment, they are just trying to leave options open; the area where the DJ is identified on the plans, that is where some of the entertainment would take place, but it may need to be updated and an alternate configuration may be required. They are seeking an 11:00 p.m. closing hour for your food Sunday - Thursday and 1:00 a.m. Friday and Saturday and have a closing hour of 2:00 a.m. all days for alcohol. For the outdoor area, the opening hours would be the same as indoors but would close at 10:00 p.m. Sunday – Thursday and 12:00 a.m. Friday and Saturday. The application also seeks a pledge to Eastern Bank. Plans are pre-construction, some details may need to change.

Joseph Correia has experience in the food and beverage industry and is an approved manager of record on two other liquor licenses outside of the City with no disciplinary issues with the local Board or ABCC. Correia intends to divide time between the locations. Correia is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol, and provided your TIPS certification as proof of training in the safe service, sale and delivery of alcohol.

Decision: Granted pending submission of proof of funds and the condition that the applicant must provide name, email and phone number of manager on duty while Joseph Correia is not on premises.

5. Application #229574 Jamie's Ice Cream Co., LLC d/b/a Jamie's Ice Cream Co., 86 Kirkland Street, for a New Common Victualler License with hours of 7:00 a.m. to 10:00 p.m. all days and seating for 25 inside and 15 patio seats on public and private property. Jamie Siracusa as manager of a premises described as: 1,200 sq. ft., left side unit, handicap access and front door access, kitchen in back of space. Includes outdoor seating on the sidewalk on the front and side.

Present: Jamie Siracusa. Sarah Morland, abutter. Manny Ramirez, resident and business owner.

Summary: Looking to bring business concept already established in Brookline to Cambridge. They make everything from scratch. General build out is done. Will provide an updated plan with seating configuration. In response to concern regarding operation and trash raised by Morland, they explained they understand it. They will have the trashe tucked away on the back of the building. They will coordinate 2-3 pick-ups a week, none during the weekend. Hope to work with the same company (midday pickup). Get a once-a-week delivery, besides milk which comes daily in the morning. Load through the back with the handicap ramp. Manny spoke in support of the application.

Decision: Granted – the total numbers and plan will be approved and accepted once the construction ends and prior to the issuance of the license. Any required changes will be made administratively so long as within the parameters of what was heard and approved today.

Includes outdoor patio on private property. Kitchen located in rear of building. There are two points of egress, with one ingress

(main entrance). There is a kitchen door exit but it is not an emergency egress as it is staff only. Applicant is also applying for an Entertainment License to include: Dancing by patrons, comedy show, trivia, and 1 TV.

Present: Mark Borenstein, attorney; Joel Prickett; and Brittany Lajoie.

Documents Considered: Application and documents attached thereto.

Summary: There is a presumption of need for this license at this location as it currently licensed. They intend to operate as an ongoing food establishment and adding coffee and lunch service. They will be very similar to what Atwood's offered. This operation has been in Somerville for over 5 years with no issues. They seek a similar layout to Atwood's, although with a little more indoor capacity. There is also an indication that there is a stage; the TV will be at the bar.

Brittany Lajoie has experience in the food and beverage industry, has been a manager of record on a liquor license, and has had no issues with the local board or ABCC. Lajoie is familiar with the rules and regulations of the Board, the ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol, and will provide TIPS as proof of training in the safe service, sale and delivery of alcohol.

The Board acknowledged receipt of letter informing Remnant's intent to surrender its farmer brewery and farmer series pouring permits upon approval for the pouring license.

Decision: Granted.

7. Application #232126 Overlind Industries, LLC d/b/a The Red House, 98 Winthrop Street, Common Victualler All Alcohol License #111650, to Add Live Music without Amplification.

Present: Molly Lindbergh. Dr. Carolyn Rieder, abutter. Investigator Tyler Bubenik and Joseph Kelley.

Documents Considered: Application and documents attached thereto.

Summary: The live music intended to be added is for a maximum of 2 persons and a guitar. The intent is to have it to help bring people in during the winters when the street is dead and it is less lively in Harvard Square. Dr. Rieder spoke in opposition to the application. Dr. Rieder explained she is a small business owner, a psychotherapist, in the building next to Red House. She operates 7:00 a.m. – 10:00 p.m. and the noise would gravely affect her practice. Dr. Reider raised concerns of past grievances, and the current outdoor music; the Board noted all of the complaints seemed to align with the previous operation.

Decision: Granted with the condition that while the entertainment is operating, the windows and doors must be closed to contain the noise inside the premises.

8. Application #230895 Lupo Partners, Inc. d/b/a Gufo, 660 Cambridge Street, Common Victualler All Alcohol License #174713, has applied to add Outdoor Background Music and One TV.

Present: Edward Hawkins; and James Cochner.

Documents Considered: Application and documents attached thereto; and correspondence regarding application.

Summary: The application says background music but the details of the application state they seek music above conversation level. It was confirmed they are only seeking background music (which is something they already have as all Common Victualler licenses are automatically granted background music). However, they are seeking background music on the outdoor area, which is something not automatically granted. The TV would be inside at the bar.

Correspondence from neighbor in opposition of application stated the amplified sound would be detrimental. They claimed the area is like an echo chamber, and thus there should be no music outside. Gufo acknowledged understanding the complaint and reiterated the background music for outdoors is to provide ambience. They are investing a lot of resources in making the outdoor area an amenity. They are a new restaurant and want to start off on the right foot with their neighbors.

Decision: Granted adding the TV inside; as to outside, defer until have an opportunity to investigate the allegation of the echo chamber.
