## **BOARD OF LICENSE COMMISSIONERS MEETING MINUTES**

Tuesday, July 9, 2024, 9:00 a.m. By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

**Board Members:** Nicole Murati Ferrer (present), Christine A. Elow (absent), and Thomas Cahill, Jr. (present).

**Decisions:** All decisions, unless otherwise stated, were 2-0, and by roll call.

# **Public Testimony Matters**

1. Application #273712 Colossal Shrimp, LLC d/b/a Darling, 464 Massachusetts Avenue, for a new Common Victualler All Alcoholic Beverages License with seating for 59 inside and proposed hours of 11:00 a.m. to 1:00 a.m. all days. Brian Callahan as proposed Manager of Record of a premises described as: Restaurant located on the first floor of a single story building, consisting of approx. 2,375 square feet including seating and bar area, restrooms, kitchen, basement storage, with one entrance and three means of egress.

Present: Attorney Adam Barnosky; and Brian Callahan.

**Documents Considered:** Application and documents attached thereto.

**Summary:** This location used to have a malt and wine license attached to it. Used to be the Mary Chung Restaurant which operated at the location for about 40 years and closed two years ago. This license and proposed business will serve to activate the site which has been vacant. The primary focus will be dinner but do intend and hope to have a lunch service incorporated as well. They will have dim sum, small plates and curated beer and wines. They intend to invest a significant amount of money to renovate the space, \$1.1 million in start up costs. They have done some light renovations and are awaiting construction permits. They estimate it will be about a 16 weeks of construction.

Brian Callahan has 8 years of experience in the food and beverage industry. Callahan has not been manager of record and is familiar with the rules and regulations of the Board, ABCC and laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. Callahan has received proof of training in the safe service and sale of alcohol and will upload the TIPS certificate.

**Decision:** Granted.

**2. Application #264991** Xenon JV 2022, LLC, 780 Memorial Drive, for a new Garage License for 83 parking spaces and 830 gallons of gasoline in the tanks of autos only.

**Summary:** They have sent abutter notifications and will upload the affidavit and proof of mailing to the record. The parking is for employees and it is for fee. The site is managed by a company, CBRE.

**Decision:** Granted, pending submission of the management company information.

**3. Application #264823** Xenon JV 2022, LLC, 790 Memorial Drive, for a new Garage License with additional Flammables for 134 parking spaces and 1,340 gallons of gasoline in the tanks of autos only, 500 gallons of diesel, and additional flammables stored by the tenants of the life sciences building.

**Present:** Eve Bancroft.

**Documents Considered:** Application and documents attached thereto.

**Summary:** They have sent abutter notifications and will upload the affidavit and proof of mailing to the record. The parking spaces are for fee. Of the 134 spots, there are 58 that are surface spots. The 500 gallons of diesel, small tank, is for the building generator and the fuel is store in the garage. The site is managed by a company, CBRE.

**Decision:** Granted, pending submission of the management company information.

**4. Application #266606** Quad 109 Place, LLC, 101 Smith Place, for a new Garage License for 154 parking spaces and 1,540 gallons of gasoline in the tanks of autos only.

Present: Gretchen McGill; and Chris Lizewski.

**Documents Considered:** Application and documents attached thereto.

**Summary:** Of the 154 there are 30 that are surface spots. Per requirement from the City of Cambridge, the tenants are charged for use of the parking space, it will done through the lease. The Davies Companies will manage the site. No other flammables on site.

**Decision:** Granted with amendment that the spaces are for fee, and pending submission of the management company information.

**5. Application #273094** Fawaz Abu-Rubayah d/b/a Beantown Taqueria, 245 Massachusetts Avenue, Common Victualler License #12404, to Increase Seating Capacity of the outdoor patio from four (4) to sixteen (16).

**Summary/Decision:** Second call given; no one has heard from the applicants, no proof of abutter notification, and SSBU application still pending. Matter will be rescheduled.

**6. Application #263822** Chicken and Co., 2261 Massachusetts Avenue, Common Victualler License #248415, to Add Seasonal Outdoor Seating on Public Property on the sidewalk for 2 tables and 4 seats.

Present: Teradate Suntornnut.

**Documents Considered:** Application and documents attached thereto.

**Summary:** The proof of mailing to the abutters uploaded but the affidavit is missing, will upload. They had wanted the patio on the street but the restaurant next door applied before they did and obtained the parking space in front of the premises. They have been granted a small portion of the sidewalk to be used for the outdoor area – 2 tables, against the building. This is an amenity they want to add for their customers. The hours of the patio will be the same as indoor. The SSBU has issued.

**Decision:** Granted.

**7. Disciplinary** Burns Landscape & Snow Management, Leaf Blower Permit #218160, for allegedly operating a leaf blower during a prohibited period and hour, June 18, 2024 at 7:34 a.m., at 145 Brattle Street in violation of CMC 8.16.081.3.1 and 8.16.081.3.4.

Present: Damon Krukowski, resident; Kevin Burns; Investigator Tyler Bubenik.

**Documents Considered:** Hearing notice and documents attached thereto; and file.

**Summary:** Krukowski testified they live across the street from Holy Trinity Church and knows the Church employs Burns Landscape. For years, Burns Landscape has been violating the leaf blower ordinance and the Church has allowed it to happen. On June 18, at 7:34 a.m. an employee of Burns operated a leaf blower. The landscaper's employees and the church are non-responsive to the issue. On this occasion, Krukowski called the police. As background Krukowski was one of the persons that testified when the ordinance was implemented to have seasonal prohibitions. Krukowski stated that Burns often has multiple blowers on site operating at the same time, although not this time.

Investigator Bubenik confirmed Burns Landscaping registered this location as one maintained by it. The Board has found 2 previous violations and the last one in April where the Church was also informed. No one from Burns appeared at the hearing.

**Decision:** Violation, 2 counts – prohibited period and hour, \$300 fine per violation, for a total \$600 fine, and an additional \$100 hearing fee for failure to appear. In addition, any future violations at the location will result in a hearing notice to the company and property owner which may result in fines issued to both the company and the property owner.

**8. Disciplinary** Nicolazzo and Sons, Leaf Blower Permit #120918, for allegedly operating a leaf blower during a prohibited period and day, June 19, 2024, at 19 Berkeley Street on June 19, 2024, in violation of CMC 8.16.081.3.1 and 8.16.081.3.2.

**Summary:** On July 8, co-owner and manager, Mike Nicolazzo filed a waiver of hearing admitting to the violations as noticed.

**Decision:** Violations, 2 counts – prohibited period and working on holiday, \$300 fine per violation for a total \$600 fine.

#### **Administrative Matters**

**9.** Application #277794 Chris Shaughnessy, CJ Shaughnessy Crane Service, for a Special Noise Variance from 7/13/24 - 9/7/24 (Alt. 7/20/24 - 9/14/24), at 100 Memorial Drive, from 7:00 a.m. to 5:00 p.m. on Saturdays only, to assemble and disassemble a crane for an equipment hoist using trucking and a crane. The variance is sought in the interest of public safety.

**Decision:** Granted.

**10.** Board Vote [Matter Heard June 25, 2024] Shojo Cambridge, LLC d/b/a Shojo, holder of All Alcohol Common Victualler License #193948, 425 Massachusetts Avenue, for allegedly allowing illegalities in or around the licensed premises by operating over the licensed capacity on May 5, 2024 (7:45 p.m.), in violation of G. L. c. 138, §§ 12, 23 and 64, G. L. c. 140, and Board's Rules 2.3, 2.5, 5.1, and 9.

**Summary:** The Board discussed how this is a repeat violation in a span of months. It is the same number of people over capacity (31 – they had 90 and are only licensed for 59). The business knew they had a special event, had been warned that the promotional materials were advertising prohibited practices, and the owner and manager of record was on site and had a clear view of the inside of the premises and should have been able to tell that it was over capacity. The business is showing a flagrant disregard for the safety of employees, patrons and residents of this mixed use building. In addition, even though they have a pending application which includes a request to increase capacity, even those plans do not support the capacity at which they were operating. Investigator Bubenik testified that from the outside it was clear the space was over capacity. The only thing that was different from this situation than the one we heard a couple of months ago was that the business only took 5 minutes to come back to capacity versus the over an hour that it took in the previous instance. Last time we gave the business 2 days suspension. Even though Moy testified as to changes they plan to make to ensure that the overcapacity does not occur, the Board expressed lack of confidence in their methods or that they are taking the matter seriously.

**Decision:** Violation, 4 days suspension.

**11.** Board Vote [Matter Heard June 25, 2024] Capitol Roofing Inc., for allegedly operating a leaf blower without a permit [failure to adhere to August 30, 2023, cease and desist], on June 11, 2024 (1:35 p.m.) in the vicinity of 66 Sacramento Street, in violation of CMC 8.16.081.3.6.

Present: Investigator Tyler Bubenik.

**Summary:** This company submitted a waiver of hearing but with the submission explained that they are not a commercial leaf blower operator. The waiver was submitted due to a medical emergency on their end. Investigator Bubenik confirmed nothing on their website indicates they are a commercial leaf bower operator. Investigator Bubenik also confirmed they reached out after the hearing to further inquire and even though there was acknowledgement of receipt of the inquiry they have not gotten back and due to the underlying medical issue, has not nudge them as follow up. The Board discussed how the information before it is sufficient to proceed.

**Decision:** No violation for failure to obtain a leaf blower permit. Will nonetheless, issue a warning/educational notice that the company must comply with all other provisions of the Ordinance (none of which were implicated in this instance).
