BOARD OF LICENSE COMMISSIONERS' MEETING MINUTES Tuesday, March 25, 2025 at 11:00 a.m.

Meeting started at 11:00 a.m.
By Remote Participation Via Zoom

This meeting was held remotely in accordance with Chapter 2 of the Acts of 2023 adopted by Massachusetts General Court and approved by the Governor.

Board Members: Nicole Murati Ferrer (present); Christine A. Elow (present); and Thomas Cahill, Jr. (present).

Staff Members Present: Chris O'Neil and Kris Foster.

Decisions: All decisions, unless otherwise stated, were 3-0, and by roll call.

Public Testimony Matters

[Note: Matters listed as #1 & 2 on the agenda were called together.]

1. Application #1151708 7-9 Mellen Street, LLC d/b/a 7 Mellen House, 7 Mellen Street, for a new Lodging House License with 8 rooms and 8 occupants in a premises described as: Three story building with basement. Lodging rooms are on levels one through three. Hong Liu as proposed manager of record.

Present: Hong Liu.

Documents Considered: Application and documents attached thereto; file; and correspondence received with regard to application.

Summary: Board incorporated by reference and made a part hereof, the testimony provided on the applications at the previous meeting of March 12, 2025. This proposed lodging house was purchased by the Applicant from Lesley University, which had used them for student housing. Hong Liu is the manager of record, while Scott Vaughn will be the residential manager and reside there (Vaughn was also represented to be the contractor used by Hong to work on the renovations of the property). Hong has extensive experience running lodging houses in Cambridge. Harvard Square B&B Inns LLC will be the management company.

The Board once again raised concerns about whether renovations were done without permits, the sprinkler system being up to code for a lodging house, who will be running the business, insurance, and an applicant who seems to be circumventing the process. Based on the testimony, the premises are being operated as a lodging house without permits or a license. Specific instructions on how to proceed to get the premises up to code and possibly licensed were provided to the applicant at the hearing.

Decision: Continued and issue a cease-and-desist order of operating/occupying the premises.

2. Application #1151715 7-9 Mellen Street, LLC d/b/a 9 Mellen House, 9 Mellen Street, has applied for a new Lodging House License with 8 rooms and 8 occupants in a premises described as: Three story building with basement. Lodging rooms are on levels one through three. Hong Liu as proposed manager of record.

Present: Hong Liu.

Documents Considered: Application and documents attached thereto; file; and correspondence received with regard to application.

Summary: Board incorporated by reference and made a part hereof, the testimony provided on the applications at the previous meeting of March 12, 2025. This proposed lodging house was purchased by the Applicant from Lesley University, which had used them for student housing. Hong Liu is the manager of record, while Scott Vaughn will be the residential manager and reside there (Vaughn was also represented to be the contractor used by Hong to work on the renovations of the property). Hong has extensive experience running lodging houses in Cambridge. Harvard Square B&B Inns LLC will be the management company.

Board once again raised concerns about whether renovations were done without permits, the sprinkler system being up to code for a lodging house, who will be running the business, insurance, and an applicant who seems to be circumventing the process. Decision: Continued and issue a cease-and-desist order of operating/occupying the premises.

3. Application #1149270 Harvard Square B&B Inns, LLC, 2240 Massachusetts Avenue, Lodging House License #10755, to increase Room Count by 2 rooms.

Summary/Decision: Rescheduled for April as applicant failed to notify abutters.

4. Disciplinary French Express, LLC d/b/a PRB Boulangerie, Common Victualler All Alcohol License #216979, at 295 Third Street, for alleged violation of G. L. c. 138, §§ 23 and 64, and Board's Rules 2 & 6, operating after licensed closing hour.

Present: Attorney Matthew O'Malley (representing building management), Attorney Tyler Henseler (representing the licensee), Attorney Andrew Upton (representing the licensee), Stephen Ruggiero (building management), Loic Le Garrec (owner), Arnaud Abdoun (owner), Investigator Joseph Kelley. Dr. Naomi Leeds and Eric Acuna, residents/complainants.

Documents Considered: Hearing notice and documents attached thereto; file; and correspondence received with regard to complaints/incident.

Summary: Testimony was heard that the business was operating past its licensed closing hour of 5:00 p.m. The Licensee admitted to advertising and operating from 7:00 a.m. – 7:00 p.m. all days, and called it an oversight. The business has been operating for almost three years and the approved closing hour has always been 5:00 p.m. and with Tuesdays closed.

Dr. Leeds, who sent in the complaint based on the Noise Ordinance, explained that the business is operating as factory and the noise is late at night and as early as 3:00 a.m. all days. Dr. Leeds also testified in opposition of an extension of hours. Similarly, Eric Acuna spoke against the Licensee's operations generally, that the Licensee routinely hosts loud parties past 5:00 p.m. or even 7:00 p.m. and starts baking at 3:00 a.m.

Decision: Violation, one (1) day suspension.

5. Application #1153537 French Express, LLC d/b/a PRB Boulangerie, 295 Third Street, Common Victualler All Alcohol License #216979, for a Change of Closing Hour from 5:00 p.m. to 12:00 a.m. all nights. This would include starting to operate on Tuesdays as of 7:00 a.m.

Present: Attorney Matthew O'Malley (representing building management), Attorney Tyler Henseler (representing the licensee), Attorney Andrew Upton (representing the licensee), Stephen Ruggiero (building management), Loic Le Garrec (owner), Arnaud Abdoun (owner), Investigator Joseph Kelley. Dr. Naomi Leeds and Eric Acuna, residents/complainants.

Documents Considered: Application and documents attached thereto; file; and correspondence received with regard to application.

Summary: [Incorporate by reference summary on previous matter.] The Licensee explained it seeks to extend its current license closing time from 5:00 p.m. to 12:00 p.m. seven days a week to host more corporate private dining events. The Licensee represented the "special events" would not be every day and that 7:00 p.m. would be their typical closing hour. The Licensee represented these small dinner parties would be for 10-15 people without a DJ and just with background music and a special menu. Licensee provided information and documentation showing how in 2024 they installed sound proof ceiling panels to try to ameliorate the noise being transmitted to the residential units above it. They also explained the bakers start working between 3:00 a.m. and 4:00 a.m. to have all baked goods ready at 7:00 a.m. for when they open.

Dr. Leeds and Eric Acuna spoke in opposition to the application. They state that the Licensee is acting as a wholesaler for other bakeries and is loud almost all hours of the day and night, between baking and hosting private events.

Ruggiero testified that they manage the apartment side of the mixed used building and although the Licensee has been responsive to communications sent to them, the complaints received by the residents are frequent.

The Licensee's attorney argued the matters were outside the Board's purview and the Licensee has a right to operate from 11:00 a.m. -11:00 p.m.

The Board noted there may be some zoning issues that needed to be considered. The Board also expressed hesitancy over any extension considering the testimony heard. There was discussion of possibly denying the request and having the applicant come back to ask for additional hours.

Decision: Deferred/Under advisement.

6. Application #1146557 HSA Food Park, LLC d/b/a Naco Taco, 297 Massachusetts Avenue, Common Victualler All Alcohol License #11549, for a Change of Ownership Interests and LLC Managers.

Present: Alex Tannenbaum.

Documents Considered: Application and documents attached thereto; and file.

Summary: Alex Tannenbaum will be taking over 100% ownership of the license (buying out partner). There will be no changes to business operations. DUA and DOR are in the process of being obtained.

Decision: Granted.

7. Application #1153734 G&S Restaurant, LLC d/b/a 212 Kitchen, 212 Western Avenue, for a new Common Victualler Wine and Malt Beverages License with proposed seating for 40 and a total occupancy of 47. The proposed hours of operation are 11:00 a.m. to 12:00 a.m. all days. Wangbo Zhang as proposed Manager of Record of a premises described as: Main floor of wood frame building (1,063 sq. Ft.) used for restaurant seating, bar area, customer restrooms (2), and kitchen. All seating/standing will be in 1 room on the main floor. Basement area (1,150 sq. ft.) used for storage and food prep area.

Present: Attorney Ann Marie Johnnen, Wangbo ("Chris") Zhang.

Documents Considered: Application and documents attached thereto; and file.

Summary: This will be a family-owned Asian-themed restaurant with medium priced food, including appetizers, dumplings and noodles, and will have a take-out business. This is a mixed use building and the business will be located in the storefront previously occupied by a pizza place. They will have deliveries in smaller trucks, have trash inside the building emptied daily and be picked up several times a week. They will just have background music as entertainment. This is a family owned and operated business.

Wangbo Zhang has a background in engineering. They are familiar with the rules and regulations of the Board, ABCC, and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. They submitted 360 Certificate as proof of training in the safe service and sale of alcohol.

Decision: Granted.

8. Application #1149248 Shake Shack Harvard Square Boston, LLC d/b/a Shake Shack, Common Victualler All Alcohol License #11491, for a Change of Ownership Interests, Change of Manager, and Change of Officers/Directors/LLC Managers.

Present: Attorney Elizabeth Pisano, Nicholas Bolio (Compliance and License Administrator for Shake Shack), Ashlie DiCicco.

Documents Considered: Application and documents attached thereto; and file.

Summary: Ownership is changing at grandparent level based on Shake Shack going public. They are removing some officers and adding two. There are no changes to business operations.

Ashlie DiCicco has worked for Shake Shack at various locations for more than seven years. They have not been manager of record before and are familiar with the rules and regulations of the Board, ABCC and the laws of the Commonwealth of Massachusetts with regard to the sale and service of alcohol. They are TIPS certified and will provide the certificate as proof of training.

Decision: Granted, pending CORI clearance.

9. Application #1146559 50 Binney Street, LLC d/b/a Lily P's, 50 Binney Street, Common Victualler All Alcohol License #23300, for a Change of Ownership Interests and LLC Managers.

Present: Alex Tannenbaum.

Documents Considered: Application and documents attached thereto; and file.

Summary: Alex Tannenbaum will be taking over Brian Lesser's 37.5% interest in the license. There will be no changes to business operations. DUA and DOR are in the process of being obtained.

Decision: Granted.

10. Disciplinary JKFoodGroup, LLC d/b/a Little Donkey, 505 Massachusetts Avenue, Common Victualler All Alcohol License #11546, for unapproved changes to the beneficial interest holder of the license and/or failure to complete the process to get changes to beneficial process approved in violation of M. G. L. c. 138, §§ 15A, 23 and 64, and the Board's Rules 2.3, 2.5, 5.5, 5.6 and 14.

Present: Attorney Thomas Miller.

Documents Considered: Hearing notice and documents attached thereto; pending application; and file.

Summary: The application has been pending for a while and in July 2024 an RNA was issued, and it was not until early March 2025 that the documents requested for reconsideration were provided. It was discussed why it took so long to submit the documents – basically they were trying to find documents showing how in 2016 a loan provided to the LLC changed the ownership interest. The

documents do not exist, so an affidavit explaining it had to be created and was submitted. It was noted this 2016 transaction and ownership interest change was not applied for or approved. It was questioned whether the affidavit was sufficient and whether they would also need to amend the application to "correct" the unapproved change.

Decision: Continue waiting to hear from ABCC whether issues have been satisfied.

11. Disciplinary Massachusetts Institute of Technology, Leaf Blower Permit #10869, for alleged violations of Cambridge Mun. Code 8.16.081.3(9), using non-compliant leaf blowers, and 8.16.081.3(10), simultaneously operating more than one leaf blower within the same 10,000 square feet, on November 1, 2024, at 60 Massachusetts Avenue.

Documents Considered: Hearing notice and documents attached thereto; file; and Waiver of Hearing.

Summary: Michael Seaberg, MIT Grounds Manager, submitted a Waiver of Hearing the day prior to the hearing admitting the violations.

Decision: Two violations for using non-compliant leaf blowers, \$300 fine per violation for total \$600 fine, and one violation for simultaneously operating the leaf blowers less than 100 feet apart, \$300 fine. Total \$900 fine. Within fourteen days of the issuance of the Statement of Reasons, the Permittee must provide an affidavit attesting as to what they have done with the non-compliant equipment. Failure to provide information will result in hearing which may subject them to additional fines.

12. Application #1155218 Ellise Martignetti, Eversource, for a Special Noise Variance on 3/31/25 - 5/2/25, (alternate dates 4/7/25 - 5/9/25), at 2400 Massachusetts Avenue, from 6:00 p.m. - 6:00 a.m. Sunday through Thursday for gas main installation using excavating, milling, drilling, and jack hammering. The variance is sought to ensure public safety concerns with pedestrians, buses, and cars.

Present: Investigator Joseph Kelley and Michael Kerwin.

Documents Considered: Application and documents attached thereto; and file.

Summary: The Applicant has been working on a gas infrastructure replacement project, with the scope extending from Cameron Avenue to Somerville Avenue installing a main gas pipeline. A variance is sought for work to be more efficient, as they have been shutting down a lane of traffic during working hours, impacting traffic and increasing the risk of worker safety. DPW asked for the majority of the "noise producing" work to be done earlier in the night and it was discussed whether this was possible. The Applicant explained the same issue and implementation was done for the work on Rindge Avenue. The excavation would take place earlier in the night and try to have it all complete by 11:00 p.m. so the rest of the night is backfilling and installation of the pipeline. The Applicant will have close communication with DPW.

Decision: Granted with the conditions that a Sunday Work Permit is required, and the majority of the noise-producing work should be completed during the earlier side of the night.

Alexandra Falafel, LLC d/b/a Falafel Corner, Common Victualler with Entertainment License #12267, 8 ½ Eliot Street, violation for operating without a license, G. L. c. 140, § 20 and Board's Rules 2, 5.1, and 13.1. The Board found a violation and issued a one-day suspension.

Middle East Restaurant, Inc. d/b/a Middle East, All Alcohol Common Victualler License #11691, 472 Massachusetts Avenue, no violation of improper contact by an employee towards a patron.

Decision: Approved as to all.

16. Board Acknowledgement Appeal decision from Alcoholic Beverages Control Commission approving the Board's 2-days alcohol license suspension of Deuko Enterprises, Inc. d/b/a Thistle &

Shamrock, 62-62 ½ Walden Street, Wine and Malt Package Store License #11476, for sale to an underage person on August 6, 2019. The matter was heard by the Board in September 2019, appealed to the ABCC which upheld the Board's decision on March 10, 2025. The suspension was never served; the licensee has been noticed and assigned suspension dates.

Decision: Acknowledged.

17. Consideration of Meeting Minutes March 12, 2025.

Decision: Approved.

18. Board Vote [Matter Heard January 28, 2025] Disciplinary, Industry, LLC d/b/a ManRay, All Alcohol General On Premises License #132709, 40 Prospect Street, for allegedly serving, selling, or delivering alcohol to an intoxicated individual and/or overservice of alcohol on September 1, 2024, in violation of G.L. c. 138, §§ 23, 64-64A, 69, G. L. c. 140, and Board's Rules 2, 12B.6, and 12B.7.

Summary: Board discussed how the case was a difficult one based on the impossible standards set by the law to establish violations of overservice/service to an intoxicated person. However, the Board noted that in cases where a large number of drinks are served in a short period of time, that could be evidence of a violation. In addition, it was also discussed how the demeanor of a person can be deceiving if they are drinking one alcoholic drink right after the other. The Board also made a correlation to a similar case heard and decided by it on the issue of many drinks within a short period of time.

Decision: Violation, one (1) day suspension.

19. Board Vote [Matter Heard February 12, 2025] Application #265972 [Rehearing from January 15, 2025] Urumqi Kitchen, LLC d/b/a Jahunger, 272 Brookline Street, Common Victualler License #238918, to Add Wine and Malt Beverages. Matter was deferred pending submission of the updated ABCC application with corrected financial information and/or supporting financial information.

Summary: The applicant was supposed to provide updated financial information and an amended ABCC application that corresponded to the financial information. The documents provided are incomplete.

Decision: Continued.

20. Board Discussion Middle East Restaurant, Inc. d/b/a Middle East, All Alcohol Common Victualler License #11691, 472 Massachusetts Avenue, discussion regarding manner in which they identify patrons of non-legal drinking age at all ages shows.

Present: Investigator Tyler Bubenik.

Summary: The Board discussed how there was information that Middle East may only be "tagging" underage persons with X marks on their hands and how this may be insufficient to ensure that

underage persons are not served in all ages shows. Middle East security plan provided to the Board explained a more robust system of X marks and wristbands. The Board discussed how that was better. The Chair would follow up with Middle East on the issue.
