Summary: Deputy Chief Donovan testified that during a Task Force Inspection on August 3, 2018, he noticed open flame votive candles on the premises. He informed Ms. Courtney the candles had to be extinguished as open flames were not allowed. She refused and challenged the lawfulness of the request to extinguish the candles.

Deputy Chief Donovan testified that On September 29, 2018, he and Captain Arsenault went to conduct a follow up inspection. They were accompanied by Police Officer McGinty. Upon entering the establishment, Deputy Chief Donovan and Captain Arsenault noticed candles on the bar and tables and requested they be extinguished. Ms. Courtney became argumentative and uncooperative, which necessitated Officer McGinty calling in his supervisor, Sgt. Bates.

Testimony by both Deputy Donovan and Captain Arsenault indicated that both Ms. Courtney and Mr. Dietrich were uncooperative with them, invaded their personal space and were threatening.

Deputy Chief Donovan testified that the Fire Prevention Unit does not allow open flame/candles in Cambridge as they are considered a fire hazard. Captain Arsenault gave an example of a person reaching over the table and the sleeve catching fire on the candle. Courtney made a point to inform the Board that the Cambridge Fire Department's website posted the "candles not allowed" after the interaction with her. However, the testimony presented by Deputy Chief Donovan uncontrovertibly established that "no candles/open flame" has been enforced by the Fire Prevention unit for years. Deputy Chief Donovan has been in the unit for approximately four years and when he has observed open flames in places of public assembly (not churches) he has made the request for the candles to be extinguished. He had never had an issue with a business when the request to extinguish candles was made. Ms. Courtney challenged this by saying other places do it. Deputy Chief Donovan asked for the names to enforce it and she refused to provide them. Deputy Chief Donovan testified he had enforced the "no open flame/candles" rule prior to August 3, 2018.

Decision: Board found a violation on all counts. The Board took no disciplinary action on Count 1 pending the resolution of the appeal filed with the Fire Prevention Regulation Appeals Board. As to the remaining counts (2-4), the Board issued a collective three (3) days license suspension.

2) Violation Continued from October 3, 2018 and October 24, 2018. Bob Bassill, Local Motion of Boston, for violation of Cambridge Municipal Code 8.16.060(B) - Noise in residential areas or affecting residential property, and 8.16.060(E) - Area noise standards.

Decision: No action – the matter was taken off the agenda as they have worked out a plan to become compliant.

There were 53 patrons, 4 in the kitchen and 3 serving. Staff took immediate action to come in to compliance. Mr. Garcia testified that it was their first busy night since the summer. A large party had a reservation and they showed up with more people than anticipated. They removed some employees and a party of 6. They were asked to extinguish candles on the tables and they immediately did so and removed them. The location has plenty of space to accommodate more capacity but due to the building and fire codes their capacity is limited.

Decision:

Board found a violation and issued a warning.
