Minutes from April were approved.

Mike shared the results of the Google Form vote regarding priorities of the RAC. The number of votes for each initiative are:

Curbside Compost outreach: 14

Encourage people to recycle textiles: 12

Bulky items & move-out waste: 11

Compile stats on Bring Your Own Bag Ordinance: 9

Encourage people to use Recycle Center: 6

Drop-off Compost Outreach: 3 Compile stats from Buy Nothing: 2

Other suggestions:

Work with businesses to reduce single-use items: 2

Try to restart carton/tetrapack recycling: 1

#### City Updates:

Earth Day was a great success. All 20 tons of compost were distributed. A second 20 ton load was ordered and distributed later on to those who put their names on a waiting list.

A good distribution of kitchen compost bins was provided for new users (approx. 45).

The FIXIT CLINIC was well attended and considered a great success.

Bike repair and clothing swap was positive.

Tracie suggested doubling the compost distribution to 40 tons. She also suggested a November pumpkin "smash". Consideration will be given to the idea.

Cambridge Science Festival in the fall considered a good time to promote the compost program.

Upcoming May Fair a good time to make Harvard student s in campus dorms aware of the compost program.

Dailey explained that a pilot program was underway to encourage student composting. There was some opposition by building managers to the issue (rodent potential).

Tracie offered to use her college contacts to encourage greater student participation.


More drop off sites suggested, with mid-Cambridge as a focus.




NEXTDOOR groups could be encourage with unofficial messages of positive compost experiences.

### Trash Collection statistics:







Summary: trash tonnage is down, aim is to get recyclables and food OUT of the trash collection.

Newspaper used to be huge percentage of recycling but no longer. Now it's cardboard from all the packages received.

Higher compost tonnage includes businesses.

43% of residences are composting; 13,000 out of 30,000 - which translates to 5.6 lbs/HH/week

Covanta tour recap: those who went found it quite interesting. Facility is at capacity. What they can't handle goes to NH. Long line of idling trucks waiting to enter.

Dave Demme, a career veteran gave an extremely informative presentation of the waste to energy technology. See the slides at the end of the Minutes. Europe uses the concept extensively and has for 35 years; here in the US we still landfill more than half of our waste. American plants are concentrated in the Northeast and FL (landfill leach into drinking water, so FL uses lots of waste to energy). We didn't use to ship waste but that's become more common. Most cities in Europe have their own waste to energy plants, with more than 500 in total. The steam produced by the burning of the waste produces electricity.

Many members interested in a RAC tour of the Bourne, MA landfill.





U.S. EPA Waste Management Hierarchy




### Municipal Solid Waste Management: 1960-2018






