## 2. City Updates:

- Annual waste mailer about how to properly sort waste should have arrived in mailboxes
- Move-out waste update
  - o Picked up more metal than anticipated
  - Collected more mattresses than anticipated; ones left on the curb don't get trashed, staff will flag, and city picks up but space is limited for how many city can store until the next collection
- DPW is coordinating a waste characterization study
  - Need to choose one set of Mon/Thurs dates, 7:45-11:45 am in Charlestown at Casella (don't have to commit to doing both Mon and Thurs):
    - Sept 29 & Oct 2
    - Oct 6 & 9
    - Oct 27 & 30
  - o Carpools will be arranged, PPE will be provided, pizza will be offered afterwards
  - o Process: have table with bags of trash, open bags and sort into buckets/barrels
- Update on City's trash generation rate



- Outreach events and volunteers update. Opportunities this Fall:

  - o Arts in the Park: Sept 27

#### 3. Zero Waste Master Plan 2.0

What are next steps for implementation?

- Short-term objectives talking to law department to formally get these drafted, ordinance starts at law department -> City Council Ordinance Committee -> full City Council will then vote on Ordinance changes, might decide to change or punt; likely will happen after election
- What interests each RAC member the most?
  - o Improving accessibility to the Recycling Center need to improve fuel tank island in DPW yard (all of City's vehicles are fueled here) so space will be redesigned, RAC can comment on design
  - Strategy #14: Determine if new materials can be diverted from landfill: Ridwell-company that
    is trying to get into the Northeast. Sends \$30 box with various pre-paid mailer bags for
    different materials that you mail back when you accumulate enough.
  - Strategy #15: Facilitate community-based programs: make it clearer who at DPW to reach out to and how to implement. How to bridge divide between large property landlord and tenants. Maybe making stickers to post on people's doors.
  - Strategy #17: Provide information in multiple languages: could be merged with Strategy #1:
     Outreach.
  - Strategy #18: Remain nimble and adjust plans as needed: example would be strike happening at Republic and having to find backup trash vendor
  - o Community events in smaller neighborhoods (Dawn got lots of engagement from doing the sorting game with parents and kids at the King Open School), Block Party
  - o Richard is part of Rotary Club of Massachusetts, and their sustainability committee is planning an event in March with pop-up table display that they want RAC to be at
