## NOTRE DAME DE CAMBRIDGE

ELLEN WATSON: Good morning. The first item on the agenda is the application continued from January 7, 2014, Association of Notre Dame De Cambridge, Inc., Francis Duffy, manager of holder of all alcoholic beverages as a club

license at 2322 Massachusetts Avenue has applied for a change of manager to Thomas A. Moore.

CHAIR ANDREA JACKSON: Please come forward.

Could you please state your name for record and spell your last name.

THOMAS MOORE: Thomas A. Moore,  $\label{eq:moore} \text{M-O-O-R-E.}$ 

CHAIR ANDREA JACKSON: So we're here as a result of a continuation from January 7 in which we had questions regarding your background as it applied to your change of manager position.

We received the email that you submitted with a letter of explanation as we had requested, along with a copy of your transcript from New England Law.

Did you have any questions, Commissioner?

POLICE COMMISSIONER ROBERT HAAS: No.

I'm satisfied that I think you addressed some of the issues.

I'm more than willing to try or give you an opportunity to demonstrate you are on right track.

But the thing I would ask the chair to consider possibly doing a review either probably six months just to see how things are going and come back and check with us to see that everything is copacetic.

THOMAS MOORE: Does that mean you would like me to come to a Commission meeting in about six months.

POLICE COMMISSIONER ROBERT HAAS: Right.

Check back in with us and see how things are going and how you are doing and make sure things are going the way you hoped it would go.

CHAIR ANDREA JACKSON: So if we are in

February, we're talking August, which is good, so by then you would have finished with your classes and perhaps you can bring us an updated transcript as well.

THOMAS MOORE: Certainly.

CHAIR ANDREA JACKSON: I'm all for giving people second chances. And your letter was satisfactory to me as well.

So based on that, I make a motion to approve Thomas A. Moore as the manager for the Association of Notre Dame De Cambridge, Inc. with a six-month review.

Also included in with that an updated transcript from New England law.

Do I have a second?

POLICE COMMISSIONER ROBERT HAAS:

Seconded. Just remind me, did you do 21 Proof

training? Or no?

THOMAS MOORE: I didn't do 21 Proof training. When I worked in California, I took a similar course. It was called LEAD.

It meant Liquor Education -- or something to that effect. But I have that similar training I would be more than willing to do what the Commission requests.

POLICE COMMISSIONER ROBERT HAAS: It is required of all people taking over an alcohol license to take 21 Proof training. It's specific to Cambridge and that you contact the License Commission office and they'll put you in touch with Frank.

CHAIR ANDREA JACKSON: Kesha Orman (phonetic) from the Cambridge Health Alliance.

When you are done here, if you have time, you can stop up in the License Commission Office and someone can get you her contact information.

THOMAS MOORE: Certainly.

CHAIR ANDREA JACKSON: On the motion?

POLICE COMMISSIONER ROBERT HAAS:

Seconded.

CHAIR ANDREA JACKSON: All in favor?

POLICE COMMISSIONER ROBERT HAAS: Aye.

CHAIR ANDREA JACKSON: Aye.

You are all set.

Thank you very much.

POLICE COMMISSIONER ROBERT HAAS: Good luck.

THOMAS MOORE: I brought this, I didn't know if it was relevant, or you want to see it, I mean, as far Mr. Haas mentioned, as being on the right track, I got a letter from the Dean the other day, I was awarded the Excellence of the Future Award because I received the overall course grade in my environmental law class. So I

made a copy and brought it. And perhaps maybe --

CHAIR ANDREA JACKSON: We would be happy to have it and include it in your file.

Thank you and congratulations.

ELLEN WATSON: The last item is a review.

Continued from January 7, 2014. The Board of Cambridge License Commissioners to review the Pedicab Pilot Program.

The City of Cambridge allowed two pedicab operators to take part of this pilot that ran from March through November of 2013.

CHAIR ANDREA JACKSON: And there's no one here to speak.

So my understanding is that there were two different companies that participated in the pilot program.

Let me sure I have the correct names.

One was the Cambridge Pedicab.

And the other was Charles River Pedicab.

The testimony provided at hearing. The Charles River Pedicab had stated that they were only interested in maintaining the program if they were doing it on an event-type basis for weddings, et cetera.

Where Cambridge Pedicab appeared to state that they were interested in actually participating on a full-time basis in terms of providing their services.

POLICE COMMISSIONER ROBERT HAAS: I think the first one also would be interested in doing certain nights of the week, like the weekends. I have to check my notes.

They have Thursday, Friday, and Saturday.

But mostly they want to do weddings and tours and events. But they want to restrict their operations it looked like to the weekends

because that's when they think they will get the most amount of business.

CHAIR ANDREA JACKSON: That would be correct.

POLICE COMMISSIONER ROBERT HAAS: There's nothing in the regulations that requires them to do it every day of the week, so ...

CHAIR ANDREA JACKSON: I'm concerned about the commitment.

POLICE COMMISSIONER ROBERT HAAS: Yeah.

CHAIR ANDREA JACKSON: And if they are looking to do it on an ad hoc basis and kind've picking and choosing and saying, well, just weddings or whenever we think we can make some money versus someone who is willing to establish a real presence.

POLICE COMMISSIONER ROBERT HAAS: The other thing that was troubling too I think the

other ones were talking about the fact they possibility going back and forth to Boston which we told them can't happen.

That's another obstacle in terms of them being able to conduct business if their plan is to be able to have free flow back and forth between Boston and Cambridge.

POLICE COMMISSIONER ROBERT HAAS: So ...

CHAIR ANDREA JACKSON: Are you trying to read my mind?

POLICE COMMISSIONER ROBERT HAAS: I am.

CHAIR ANDREA JACKSON: I'm really leaning towards offering the license just to Cambridge Pedicab.

And if and when the other company -- it doesn't mean the other company is prohibited from coming back to us but if they come back to us with a more stable plan, I would be willing to

entertain it. Based on what is presented to us this morning, I'm looking at making the recommendation that we approve Cambridge Pedicab for operation in the City with the time frame as applied. I think it was March 1 to the end of the year weather permitting.

thinking about it. I thinking rather than having one company to create it off the top and then another company going -- do the whole thing, I think I agree that they really shouldn't be disadvantaged if they are giving service. But I guess the stipulation I have is, if they decide to curtail their operations, they have to notify us so we can review their application as well.

CHAIR ANDREA JACKSON: Absolutely.

Do you want to put that in the form of a motion?

POLICE COMMISSIONER ROBERT HAAS: I want to make sure I got the right company.

CHAIR ANDREA JACKSON: It's Cambridge Pedicab.

POLICE COMMISSIONER ROBERT HAAS: I make a motion to approve a license to Cambridge

Pedicab under the present rules and regulations established with no modifications, with the stipulation that if they do modify their hours, that they are required to notify the License Commission.

CHAIR ANDREA JACKSON: Second. All in favor signify by aye.

POLICE COMMISSIONER ROBERT HAAS: Aye.

CHAIR ANDREA JACKSON: Aye.

POLICE COMMISSIONER ROBERT HAAS: We'll notify the other company that they are not going to be granted a license based on their

representations to us at that last hearing that they testified before the Commission.

CHAIR ANDREA JACKSON: And also let

Cambridge Pedicab know they have been awarded the

license and if they want to change the hours,

they need to come back before the Board.

Well, after that lengthy agenda, I make a motion adjourn.

POLICE COMMISSIONER ROBERT HAAS: Seconded.

CHAIR ANDREA JACKSON: All in favor say aye.
