## APPLICATION:

ARAMARK CORPORATION
D/B/A ARAMARK \& TAKEDA
The first matter is the application of

Aramark Corporation doing business as Aramark \& Takeda Pharmaceuticals, Samantha Smiley, Manager, has applied for a Common Victualer license at 300 Massachusetts Avenue. Said license, if granted, would allow food and non-alcoholic beverages to be sold, served, and consumed on said premises with a seating capacity of 32 and proposed operating hours from 7:00 a.m. until 4:30 p.m. Monday through Friday.

CHAIRMAN ARTHUR GOLDBERG: Hi.
SAMANTHA SMILEY: Hi.

CHAIRMAN ARTHUR GOLDBERG: Please have a
seat. Could you state your names and spell your names for the stenographer, please? SAMANTHA SMILEY: Samantha,

S-A-M-A-N-A-T-H-A, Smiley, S-M-I-L-E-Y.
TIMOTHY CONNELLY: Timothy Connelly,

T-I-M-O-T-H-Y, C-O-N-N-E-L-L-Y.

CHAIRMAN ARTHUR GOLDBERG: Hi. Could you
state why you're here and what you're looking for?

SAMANTHA SMILEY: Sure. We're looking
for a common victualer 1 icense for our coffee bar on the top floor of Takeda Pharmaceuticals building at 300 Mass Ave, the new construction building.

CHAIRMAN ARTHUR GOLDBERG: Okay. And
could you describe a little bit what you'd be serving and the food preparation area and so forth?

SAMANTHA SMILEY: Sure. It's going to be -- we proudly brew Starbuck's coffee bar, we'11 have grab-and-go sandwiches, soups and salads along with 1 ike yogurt cups and soft beverages
which will all be bottled and -- yeah.

TIMOTHY CONNELLY: The food preparation, so we'11 be at our current existing location that's across the street at 35 Lansdowne Street, that we also have a full kitchen that we operate there for Takeda Pharmaceuticals. They've extended their footprint in Cambridge and outgrown their current space and they've moved into 300 Mass Ave, and they want to bring food and beverage to their folks at that location as we 11.

CHAIRMAN ARTHUR GOLDBERG: At 300 Mass

Ave, are there refrigeration facilities?

SAMANTHA SMILEY: Yes, we have a holding
room, it will have a warmer and refrigeration and the three-bay sink and a dishwasher.

CHAIRMAN ARTHUR GOLDBERG: Okay.

CHIEF GERALD REARDON: A11 the food prep
wil1 be done at Lansdowne Street?

TIMOTHY CONNELLY: Yes.
SAMANTHA SMILEY: Down the street.
CHAIRMAN ARTHUR GOLDBERG: So that's
already licensed and permitted?

TIMOTHY CONNELLY: We have been operating
there since January of 2012, and with the Board of Health, Inspectional Services Division and stuff we did share plans with them. There will be no food preparation at 300 , but we have the ability to wear, wash and have the ability to keep hot food, hot and cold food, cold.

CHAIRMAN ARTHUR GOLDBERG: The seating capacity of 32 inside and 35 outside as well, is that correct?

SAMANTHA SMILEY: Yes.

CHAIRMAN ARTHUR GOLDBERG: Are there any
members of the public here to speak about this?
None.
EXECUTIVE DIRECTOR ELIZABETH LINT: Do
you have the abutter notifications?

SAMANTHA SMILEY: I do.

CHIEF GERALD REARDON: Outdoor seating is that roof level?

SAMANTHA SMILEY: Yes, it is.

TIMOTHY CONNELLY: Sixth floor.

SAMANTHA SMILEY: Sixth floor of the building.

EXECUTIVE DIRECTOR ELIZABETH LINT: Thank you.

CHAIRMAN ARTHUR GOLDBERG: Are there any
questions from the Board?

POLICE COMMISSIONER ROBERT HAAS: Talk
about your experience as an operating manager and talk about your prior experience.

SAMANTHA SMILEY: I have been with

Aramark four years now, $I$ have been at Takeda that whole time and --

POLICE COMMISSIONER ROBERT HAAS: You
have been --

SAMANTHA SMILEY: I have been at Aramark
and Takeda Pharmaceuticals the entire time, so we have been with them since we opened the account.

POLICE COMMISSIONER ROBERT HAAS: In a
managerial capacity, or is this the first
managerial position you're holding and you're transitioning over to this new site?

SAMANTHA SMILEY: It will be in addition.

TIMOTHY CONNELLY: Samantha reports to
me.

I have been with Aramark just shy of 18 years and district manager for New England and have other operating businesses in Cambridge as well, with the Biogen on the other side of the Kendal1 Square, have multiple operations over there as well.

CHAIRMAN ARTHUR GOLDBERG: Okay.

Anything from the Executive Director?

## EXECUTIVE DIRECTOR ELIZABETH LINT: I

think we're missing the abutter affidavit.

SAMANTHA SMILEY: I don't have that. Is
that something $I$ can get from you?

EXECUTIVE DIRECTOR ELIZABETH LINT: It
would've been in that packet. You can take care of it in the office.

SAMANTHA SMILEY: Okay.

CHAIRMAN ARTHUR GOLDBERG: Do we have a
motion or further questions?

CHIEF GERALD REARDON: No further
questions.

POLICE COMMISSIONER ROBERT HAAS: No
other questions.

CHIEF GERALD REARDON: I make a motion to approve the Aramark \& Takeda Pharmaceuticals common victualer 1 icense at 300 Mass Ave with seating capacity of 32 seats and 32 outside seats from the hours as stated.

CHAIRMAN ARTHUR GOLDBERG: 35 outside.

CHIEF GERALD REARDON: 35 and 32 in the room with the provision that the paperwork for Ms. Lint is followed up on.

CHAIRMAN ARTHUR GOLDBERG: Second.

POLICE COMMISSIONER ROBERT HAAS: Second.

CHAIRMAN ARTHUR GOLDBERG: A11 in favor?

POLICE COMMISSIONER ROBERT HAAS: Aye.

CHAIRMAN ARTHUR GOLDBERG: Aye.

CHIEF GERALD REARDON: Aye.
EXECUTIVE DIRECTOR ELIZABETH LINT: Just
see Chris in the office.

SAMANTHA SMILEY: Okay.

CHAIRMAN ARTHUR GOLDBERG: You're
approved subject to that document being filed.

TIMOTHY CONNELLY: I'm pretty sure it
wil 1 be done tomorrow, first thing.

Application: Roxtar Foods Limited d/b/a
Thresher, Christopher Willis, Manager, has applied to transfer the All Alcoholic Beverages Restaurant License currently held by Shiv, Inc d/b/a India Castie, Mohinder Badwal, Manager, at 924-928 Massachusetts Avenue. The applicant is applying for an Alteration of Licensed Premise Description. The proposed hours of operation are 5:00 p.m. to 1:00 a.m. seven days per week with a seating capacity of 85.

CHAIRMAN ARTHUR GOLDBERG: Good evening.

Could you each of you state your name and spell your names for the stenographer, please?

CHRISTOPHER WILLIS: Christopher Willis, C-H-R-I-S-T-O-P-H-E-R, W-I-L-L-I-S.

PAMELA WILLIS: And Pamela, P-A-M-E-L-A,
last name Willis, W-I-L-L-I-S.

ATTY LESLEY ST. GERMAIN: Lesley,

L-E-S-L-E-Y, St. Germain,

S-T-period-G-E-R-M-A-I-N.

CHAIRMAN ARTHUR GOLDBERG: Thank you.

Please go ahead.

ATTY LESLEY ST. GERMAIN: Chairman,

Members of the Commission, Lesley St. Germain with McDermott, Quilty \& Miller before you today seeking a license to continue to be operated at 928 Massachusetts Avenue.

With me are the applicants, each owning half of the 1 icensee, the proposed 1 icensee entity, Christopher Willis and Pamela Wiliis.

Christopher is also the proposed manager of record, and I'11 get into his experience in just a moment.

I have with me the abutters notification.

What we're seeking to operate is a new

American-style restaurant with an emphasis on Italian cuisine. We're seeking to open a restaurant that would appeal to the neighborhood. It would kind of be able to provide a fine dining or rustic fine dining experience in a more acceptable and less stuffy atmosphere.

They're seeking to operate seven days a week serving dinner beginning at 5:30 p.m. with a closing hour of 1:00 a.m.

CHAIRMAN ARTHUR GOLDBERG: If I could interrupt for a minute. I believe on the application 1 unch was checked off, but the hours requested were 5:00 p.m. to 1:00 a.m. Is 1unch to be considered?

ATTY LESLEY ST. GERMAIN: We don't know plan to open with lunch. We expect in potentially six months we would come back to the Board seeking the opportunity to open for brunch on the weekends.

CHAIRMAN ARTHUR GOLDBERG: So at this
time, you're not seeking lunch?

ATTY LESLEY ST. GERMAIN: At this time,
we're not seeking lunch.

CHAIRMAN ARTHUR GOLDBERG: Go ahead.

ATTY LESLEY ST. GERMAIN: Of course. As

I noted, we're seeking to open a neighborhood restaurant. Chris and Pam are actually going to be moving into the neighborhood. They 1 ived in Cambridge previously, which is one of the reasons why they chose the specific location, and they're actually renovating a house at 318 Harvard.

They're going to be right down the street.

And in addition to seeking to operate a successful business, they really want that business, and both that respect, and personally, invest in this community and be a really positive aspect of the community.

As far as Chris' experience as manager of
record, he has over ten years of experience in the restaurant industry, and specifically, in fine dining. He's worked in a number of capacities and places such as Cleo and Realto and has experience managing.

He worked in a managerial capacity for
two years at a restaurant on Nantucket. He's
familiar with all of the regulations of both the Commonwealth and of the City of Cambridge.

Pam, who will be working there, has significant experience in the restaurant industry in her own right.

CHAIRMAN ARTHUR GOLDBERG: Did those restaurants have alcohol, all alcohol incenses?

CHRISTOPHER WILLIS: Safolya (phonetic), where $I$ was a manager, had just beer and wine. I worked in other capacities at restaurants with full 1 iquor, but $I$ have not actually managed a restaurant with full 1 iquor.

POLICE COMMISSIONER ROBERT HAAS: But you
were a manager of record for the beer and wine 1 icense?

ATTY LESLEY ST. GERMAIN: He was not manager of record, but he was operating in a managerial capacity.

POLICE COMMISSIONER ROBERT HAAS: Okay.

ATTY LESLEY ST. GERMAIN: So I believe if
the Commission has any questions, that's the summary of what we're seeking.

We anticipate this being a successful operation.

Obviously, we see a need for this sort of establishment in the neighborhood, and we're hopeful and excited to join the community.

CHAIRMAN ARTHUR GOLDBERG: You're looking
to purchase an existing al1 alcohol 1icense at that address?

ATTY LESLEY ST. GERMAIN: Yes, the
license will be remaining at that address and we entered into a purchase and sale agreement with the existing owner.

POLICE COMMISSIONER ROBERT HAAS: How much renovations will you be doing?

CHRISTOPHER WILLIS: We'11 be doing mostly design work for three or four months, nothing structura1.

PAMELA WILLIS: Moving the bar.

CHRISTOPHER WILLIS: Mostiy decorative changes.

POLICE COMMISSIONER ROBERT HAAS: What about the kitchen?

CHRISTOPHER WILLIS: The kitchen --
POLICE COMMISSIONER ROBERT HAAS: You're
redoing the kitchen?
CHRISTOPHER WILLIS: We're redoing the kitchen to the extent that we'11 be taking out a11 the existing equipment and we'11 be changing
the position of the vent a few feet towards the center of the room.

ATTY LESLEY ST. GERMAIN: As far as capacity, we're going to be reducing the capacity.

What is asked is a seating capacity of 85 and the current 1 icensee has a capacity of 99.

CHAIRMAN ARTHUR GOLDBERG: Is any member of the public here to speak on this?

None.

Any other questions?

CHIEF GERALD REARDON: So if the kitchen is going to be a replacement or going to be -you're going to get into the hood and so you're going to get into that new hood ordinance and relationship.

Do you have a fryolator as wel1?

CHRISTOPHER WILLIS: We do have a
fryolator, yes, it's a relatively small one.

That's not a big --

CHIEF GERALD REARDON: Be conscious of the regulation on the hood venting, that's - in the past five, six years, when you're doing that work.

CHRISTOPHER WILLIS: We have Harbor Foods
who is going to be sort of spear-heading the whole kitchen renovation, so $I$ think they're pretty good on that.

CHIEF GERALD REARDON: What is your
expected construction time?

CHRISTOPHER WILLIS: So we're
optimistically hoping to wrap things up in
three or four months barring no unforeseen conditions.

CHIEF GERALD REARDON: What was your
previous experience, a lot of Italian cuisine?

CHRISTOPHER WILLIS: When $I$ was a
manager, $I$ was cooking rustic Italian food which
is essentially what we'11 be doing sortve with some American accents.

CHIEF GERALD REARDON: No further
questions.

CHAIRMAN ARTHUR GOLDBERG: Anything from
the Executive Director?
EXECUTIVE DIRECTOR ELIZABETH LINT: Yes,

I did not see a business certificate in the packet that was sent over, and Indian Castle is going to have to get an updated certificate of good standing. It's outdated. The backgrounds are fine.

CHAIRMAN ARTHUR GOLDBERG: So the manager
would have to do the TIPS training?

EXECUTIVE DIRECTOR ELIZABETH LINT: 21

Proof as well.

CHAIRMAN ARTHUR GOLDBERG: 21 Proof,
okay.

Anything further?

POLICE COMMISSIONER ROBERT HAAS: Nothing
further.

CHAIRMAN ARTHUR GOLDBERG: Do we have a
motion?

CHIEF GERALD REARDON: I make a motion to
approve Roxtar Foods Limited doing business as Thresher, Christopher Willis, manager, for the address at 924 through 928 Mass Ave with a seating capacity of 85 with operating hours of 5:00 p.m. to 1:00 a.m. seven days a week.

POLICE COMMISSIONER ROBERT HAAS: Did you
say 5:00 p.m. or 5:30?

CHIEF GERALD REARDON: 5:00 p.m.

thought you said 5:30.

CHRISTOPHER WILLIS: 5:00, yes.

## EXECUTIVE DIRECTOR ELIZABETH LINT:

Ratification: Moksa, LLC doing business as

Moksa/Naga, Renato Rodriguez, Manager, holder of
an All Alcoholic Beverages Restaurant License and Entertainment License at 450 Massachusetts Avenue has submitted the change of $d / b / a$ to Monroe.

ACTING CHAIR ARTHUR GOLDBERG: Good
evening.

ATTY SEAN HOPE: Good evening,
Mr. Chairman and Members of the Commission. For the record, Sean Hope of Hope Legal Offices in Cambridge.

I'm here tonight on I'm behalf of Moksa, LLC. This is an application to change the business name.

The purpose of the change of name is part of a rebranding effort, primarily for the restaurant portion of the facility, but overal, 1 as the Commission may know, there are several Asian-style cuisine restaurants opening up on Mass Ave, they have been struggling with the lunch and dinner business at this location. And so they're rebranding.

It will be all interior, more decor and design, but it's the idea of trying to rebrand the cuisine as well as some of the nightlife.

CHIEF GERALD REARDON: What is the
cuisine change going to be?
ATTY SEAN HOPE: I think it's going to be
-- they're still going to have some Asian food offerings, but it's going to be more standard fare.

I think the uniqueness didn't necessarily work for the business crowd that's existing, plus the price point. So they're going to have more American local fare. I think they're going to have more of a diverse palate. It's more sushi and pan Asian cuisine, and they're hoping to drive some more traditional American cuisine to the facility.

CHAIRMAN ARTHUR GOLDBERG: So we should get a copy of the new menu?

ATTY SEAN HOPE: Yeah, I believe that's
still being developed. I think the first step
was to get the approval.

We would be happy to submit one once a
final menu is prepared to the Commission as part of any review. I know they're getting a chef and working with the consultant to try to continue to drive more business and dinner patrons.

CHIEF GERALD REARDON: So this will be basically more domestic and name change than --

ATTY SEAN HOPE: The seating is not
changing -- the numbers of seats is not changing.

I do think there's a goal of shifting the
focus from the nightiife, which part of the name change, as the Commission may know, Naga is
well-known in the nightlife community. So
this is going to be a change for the whole facility.

They're hoping it will attract a more
dinner-based crowd, 1 ess focused on the nightiffe.

But to the Chief's point, there will be
the interior decor only. There's no change of
seating and number of seats.
CHIEF GERALD REARDON: And Mr. Rodriguez
is the present manager so there will be no change in managers?

ATTY SEAN HOPE: No change.

CHAIRMAN ARTHUR GOLDBERG: No change in
hours.

ATTY SEAN HOPE: No change in hours, manager or seating.

CHAIRMAN ARTHUR GOLDBERG: Is any member
of the public here to speak on this?

JEFFREY RICHARDS: Did you handle the one at 924-928 Mass Ave already?
