Alive Acquisition, LLC doing business Life Alive, at 763 Massachusetts Avenue, previous holder of a Common Victualer license which has expired, has applied for a new Common Victualer 1 icense.

They're seeking a temporary iicense until the matter can be properly noticed.

CHAIR NICOLE MURATI FERRER: So this is
the one that -- can you give us the background on this because $I$ don't really remember it?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

This one, they came in, they called to ask if they could apply for a wine and malt license, and in looking at the paperwork they submitted, it was a new corporation, a new LLC that had not been approved by the Board. New members, new owners. And in reviewing --

CHAIR NICOLE MURATI FERRER: This is one
of the ones we didn't schedule because they got lost in the shuffle because they originally held a liquor license.

## EXECUTIVE DIRECTOR ELIZABETH LINT:

Exactly. And then, in looking in the system, the license was expired and they thought the food handlers permit was sufficient. CHAIR NICOLE MURATI FERRER: Did they submit to us the CV application?
EXECUTIVE DIRECTOR ELIZABETH LINT: It's
in the process. They needed more paperwork.
CHAIR NICOLE MURATI FERRER: Do we know
their hours of operation?

## EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

CHAIR NICOLE MURATI FERRER: All the
same?
EXECUTIVE DIRECTOR ELIZABETH LINT: All
the same.

CHAIR NICOLE MURATI FERRER: I would

Matter was deferred pending receipt of the First Holiness Church's letter regarding the application. Letter and responses thereto submitted to the Commission. CHAIR NICOLE MURATI FERRER: We received the church's letter basically saying what the woman had represented at the hearing about the parking and whatnot, and we also received another letter from the church right across saying
they're in support of the application, and we
received some other 1 etters in support.

During the hearing, $I$ found that they had shown public need. I think the fact that yes, of course, they're going to bring in some business, but it doesn't seem like it's going to impact in such a negative way, and considering the CV and they have gone through an extensive process with that already, and they have been approved for the number of seats that they were seeking, and the variance, $I$ see no problem with granting the application presented to us. ## CHAIR NICOLE MURATI FERRER: Good

evening.

ATTY JOE HANLEY: Nice to see you. Just passing out materials for the record. Attorney Joe Hanley, McDermott, Quilty \& Mil1er, 131 --

THE REPORTER: Joe, you have to spe11 your first and last name.

ATTY JOE HANLEY: Joe, J-O-E, initial P,
last name, H-A-N-L-E-Y.

With me is or $I$ can actually let you guys
introduce yourself.

BRIAN NADLER: Brian Nadler, B-R-I-A-N,

N-A-D-L-E-R.
JAMES CECIL: James Cecil, J-A-M-E-S,
C-E-C-I-L.
MATT CHRISTY: Matt Christy, M-A-T-T,
C-H-R-I-S-T-Y.
ATTY JOE HANLEY: Madam Chair, we handed out some presentation materials for you. Thank you for the opportunity to be here tonight.

To my right, as he introduced himself, Brian Nadler is the proposed manager of record on the application before you, and to my middle right is James Dan Cecil, who is a principal with the proposed licensee for the beer. And Matt Christy, to my far right, who is the marketing manager for the concept.

We're excited to be here with an
opportunity to open the first World of Beer
Restaurant concept in Massachusetts in the area.
The space is the former California Pizza Kitchen

Restaurant location inside the Cambridgeside Galleria.

That operation completed business at the end of the year, and it has been vacant, and my client signed a lease with New England Development, the owner of the mall, to go into that space. And the application before you is approximately a 1.9 milition dollar investment, a million of which is estimated for the build-out of the space.

And as the Executive Director read into
the record, we're looking for 149 seats interior and 21 on the patio for a total of 170. You have a floor plan with you as well. Just a little bit about World of Beer, 70 locations nationally, and they're in the midst of repositioning with a very strong focus on dining and restaurant.

And pairing the beer and sort of alcohol
as an amenity to the dining aspects, they offer almost 70 craft beers on tap with a real regional and local focus.

And this, again, would be the first in
Massachusetts and the fourth for this franchisee who has the rights to the northeast market as well as some parts of Florida.

Also, proud to say that the standard here obviously is public need and the character and fitness. This applicant in the other locations have never had a violation from any of the licensing authorities at their other locations. Everyone that works World of Beer will be TIPS certified and routinely trained.

The manager of record, Brian, is -- has been working with the concept for two years now. He's local. We anticipate that by the time the build-out is done, we'11 probably be before you with a change of manager for someone who is more
of a day-to-day person, but certainly Mr. Nadler has taken the time to work with us and with Dan and the company to become familiar with all the rules and regulations and certifications and will go through Cambridge's certification process as we11.

Finally, we had very positive outreach with the community before coming to you tonight.

I have a copy of the letter from the East Cambridge Planning Team. I don't know if you're in receipt of this.

CHAIR NICOLE MURATI FERRER: We did receive it.

ATTY JOE HANLEY: We met with them on

February 10 and they voted to support the concept.

With respect to the public need, this is a space that was licensed. These are, as you know, licenses that are issued for the mall
itself, so that license has been handed in rather than a transfer for tax reasons. This is, obviously, a new entity, so we're seeking a new license in its place, and would suggest there's a need that continues in the mall and Cambridge and in the area for this type of concept that is to provide a very good dining experience with a selection of craft beers and spirits that reflect the region and the tastes of the area.

CHAIR NICOLE MURATI FERRER: Thank you.
Mr. Hanley, before I ask your clients a couple questions, I did see a couple issues.

Mr. Nadler's CORI request form, it's notarized, but the notary did not fill out the -neither did David, he signed it before the notary or the ID used.

ATTY JOE HANLEY: Okay.
CHAIR NICOLE MURATI FERRER: So that
probably needs to be re-notarized or fixed. I
think it's Helena Facetto (phonetic), maybe she is in your office. I'm not quite sure.

ATTY JOE HANLEY: Okay.

CHAIR NICOLE MURATI FERRER: I did have a question. Does the landlord have any interest in the 1 icense? Any -- it's not a percentage lease or anything of that nature?

ATTY JOE HANLEY: In the 1ease --

CHAIR NICOLE MURATI FERRER: I know the
landlord is providing funds for some of the improvements, but they're not taking --

ATTY JOE HANLEY: Is it percentage rent though?

JAMES CECIL: Over a certain cap.

ATTY JOE HANLEY: We checked off "yes."

I know the $A B C C$ now has a different way of looking at this.

CHAIR NICOLE MURATI FERRER: I mean, I
was wondering in terms of $18 B$ because it says

from your menu, you will have fryolators?

JAMES CECIL: I'm sorry?

FIRE CHIEF GERALD REARDON: Looking at
your menu, I assume you have fryolators?

JAMES CECIL: Yes.

FIRE CHIEF GERALD REARDON: You're aware of all the new changes in Massachusetts with regard to the hoods?

JAMES CECIL: We have a hooding system.

FIRE CHIEF GERALD REARDON: And you need to get that certified by a competent certified one by the State Fire Marshal's Office when you make a move 1 ike that.

Are you moving them far horizontal to
where they were before or relatively close?

JAMES CECIL: Exact same location.

FIRE CHIEF GERALD REARDON: A11 right.

As part of the retrofit, you're going to be doing the firearm alarm system and sprinkler system predicated on the space?

JAMES CECIL: Yes. We have a full set of architectural plans with complete mechanical engineering.

FIRE CHIEF GERALD REARDON: How far along are you right now?

JAMES CECIL: Just gutting the space and putting the permits and architectural plans and mechanical engineering are with the city right now for review.

FIRE CHIEF GERALD REARDON: You're also
familiar with the crowd manager law because you will have over 100 people as well?

JAMES CECIL: Yes.

FIRE CHIEF GERALD REARDON: You make sure
that someone is present at all times when the establishment is open so you have the crowd manager law.

Lu. Premise description: First floor fast order restaurant with approximately 1200 square feet, including open kitchen. Street level with entrance on Winthrop Street and emergency exit into Crimson Galleria Mall.

ATTY ANDREW UPTON: Good evening, Madam Chair, Chief, Chief.

Andrew, $\mathrm{A}-\mathrm{N}-\mathrm{D}-\mathrm{R}-\mathrm{E}-\mathrm{W}$, Upon, U-P-T-O-N representing the applicant.

With me is Rosamond, R-O-S-A-M-O-N-D,
last name L-U, and Gerry Tracy, G-E-R-R-Y, T-R-A-C-Y.

CHAIR NICOLE MURATI FERRER: Thank you.

ATTY ANDREW UPTON: Thank you for
1istening. We're here on behalf of Tom's BaoBao, which an exciting Asian fast order food concept which Gerry will describe a iittle bit.

But just by way of procedure, we met with and earned the support of the Harvard Square Business Association and the Harvard Square Advisory Committee.

We also have been approved for the
appropriate $Z B A$ relief, and we're waiting for that decision to come through.

I will also mention that Austin Collier (phonetic), the director of operations, is here in the back, as is Tom Tong, the founder of the company, who has over 200 locations in China.

He's from China and will probably not be asking questions unless you address him in Chinese, but his business and his representation in his own
country are impeccable. He wanted to be here because this is the first outlet that they're starting in Cambridge.

It's the first in the $U S$ and with that,
we'11 have Gerry just give you a very brief description of the concept and answer any questions along the way.

GERRY TRACY: Good evening. I am just
back four days ago from my month long trip to

China to learn all about this company and the art of Bao, and I'm really excited to bring it to the states. This concept that we have is unlike any other.

Our product is hand-crafted, it's
authentic, uses the highest quality of filings
and ingredients all the way around. With that,

Bao is centuries old and probably the most
recognized food in China.

It goes back over 1200 years. And it's
simply a steamed bun. You may know them from dim sum or from markets where you have the dough, the 1emon dough with the filling, and typically we eat them at brunch, but they're a staple in the Chinese cuisine.

CHAIR NICOLE MURATI FERRER: What is your role within the concept?

GERRY TRACY: I'm the vice president of operations for the company.

CHAIR NICOLE MURATI FERRER: Okay.

ATTY ANDREW UPTON: Rosamund has applied for manager of record, but once the store is up and running, Gerry will take over on the day-to-day basis.

CHAIR NICOLE MURATI FERRER: The owner is GQS Harvard Square, Inc?

ROSAMUND LU: Correct.

CHAIR NICOLE MURATI FERRER: You're the owner of that company?

ROSAMUND LU: An officer of the company.

CHAIR NICOLE MURATI FERRER: And who is the actual -- aside from --

ROSAMUND LU: Harvard Square -- who are the other officers?

CHAIR NICOLE MURATI FERRER: Yeah.

ROSAMUND LU: Tom is.

CHAIR NICOLE MURATI FERRER: So the
profits -- I'm trying to figure out, who gets the profits from this venture basically.

ROSAMUND LU: GQS Harvard Square, Inc is
owned by GQS -- Bao, Inc, which is the parent company.

CHAIR NICOLE MURATI FERRER: Okay.

You will be open from 7:00 a.m. to 1:00
a.m.?

ROSAMUND LU: That's what is suggested by the Advisory Board. They would like to see it open from 7:00 to 1:00 p.m.

ATTY ANDREW UPTON: We originally
proposed shorter hours, but the Harvard Square Advisory Commission said they're interested in having both breakfast options and late night fast order food and snacks.

We expect most of the business to be sort of brunch and dinner, but we agreed to expand for now to see if that's viable.

CHAIR NICOLE MURATI FERRER: Any
questions?

POLICE COMMISSIONER ROBERT HAAS: No questions.

FIRE CHIEF GERALD REARDON: How much of a build-out is this location for you?

ROSAMUND LU: We're getting the RFPs back next week, so $I$ would -- just a rough estimate, probably a quarter milition.

FIRE CHIEF GERALD REARDON: This is basically another gut?

GERRY TRACY: Indeed.

ROSAMUND LU: Yes, it was formerly a yogurt space.

FIRE CHIEF GERALD REARDON: That's not really conducive. So you, again, will have to put fryolators in for this or --

GERRY TRACY: No. Actually, there's no fryolators at all. We will be installing the hood system with appropriate Ansul-required suppression system.

Our cooking elements are steam. We have two very large vessels which generate steam, and besides the coffee maker, that's the sole initial source.

GERRY TRACY: Exactly.

David Cagle, proposed manager, and hours of operation of 11:00 a.m. to 1:00 a.m. seven
days a week, 74 seats inside and 40 outside.

Also applying for an Entertainment License to include an audio tape machine/CD/computerized digital media that can be played at conversation level and two TVs.

DAVID CAGLE: Good evening, Madam chair and Chiefs.

CHAIR NICOLE MURATI FERRER: Please state your names for the record. DAVID CAGLE: David, D-A-V-I-D, Cag1e, C-A-G-L-E.

CHRIS SCHLESINGER: Chris, C-H-R-I-S.

Sch1esinger, S-C-H-L-E-S-I-N-G-E-R.

CHAIR NICOLE MURATI FERRER: Thank you.

Tel1 us a 1 ittle bit about your application.

DAVID CAGLE: We're looking to open up a casual neighborhood restaurant moderately priced right outside of Central Square, that is an area that is growing and we definitely think there's a
market for something that's a little more moderately priced.

FIRE CHIEF GERALD REARDON: Is this the Asca property?

DAVID CAGLE: Atasca.

FIRE CHIEF GERALD REARDON: Atasca, excuse me.

CHAIR NICOLE MURATI FERRER: Who is going to sign for us the tax certification form?

This is the one sheet you guys didn't sign.

DAVID CAGLE: Oh, no. I blame Bob.

CHAIR NICOLE MURATI FERRER: This might not be a reasonable question, but you are not seeking to 1 icense the parking garage space, correct?

DAVID CAGLE: No.

CHAIR NICOLE MURATI FERRER: So really
it's just the dining room, kitchen, the two
restrooms, the storage -- the storage is yours -you will be using the storage?

DAVID CAGLE: Yes.

CHAIR NICOLE MURATI FERRER: And the
seasonal outdoor patio?

DAVID CAGLE: Yes.

CHAIR NICOLE MURATI FERRER: I got thrown
off by the parking garage. I didn't know exactly what you were planning to do there.

CHRIS SCHLESINGER: The exit of the egresses goes into the parking garage.

CHAIR NICOLE MURATI FERRER: That's fine.

Mr. Cagle, you have never been a manager of record on a 1 iquor 1 icense?

DAVID CAGLE: I have not, but $I$ have been on premises manager at four or five different places that have an all alcohol 1 icense.

CHAIR NICOLE MURATI FERRER: I did notice that you presented all of your affidavits and
everything, so that's in order.

Can you tell us a ittle bit about your experience?

DAVID CAGLE: I'm currently the general manager of Green Street Gril1 in Central Square. Prior to that, $I$ was a managing partner with Deep Ellum and Lone Star in Allston and helped them to open their location in Cambridge on Cambridge Street. I worked for the guys for eight years.

I have been working in restaurants since $I$ was 15. I have done everything, kitchen manager, general manager, you know.

CHAIR NICOLE MURATI FERRER: I know you guys said it's a casual neighborhood, but what kind of food is it going to be? What kind of concept other than neighborhood and moderately priced?

DAVID CAGLE: Like a more casual version
of East Coast Gri11. More everyday version.

CHRIS SCHLESINGER: Plan to serve the
neighborhood there where the people can go and eat there a couple times a week to be a ittie bit different than some of the others.

CHAIR NICOLE MURATI FERRER: Just to relate back to what you started off with, the public need is to fill out the space that has now been empty by the last place and also to serve the growing neighborhood?

DAVID CAGLE: That's exactly it.
CHAIR NICOLE MURATI FERRER: Have you been to the 21 training, 21 Proof training?

DAVID CAGLE: I haven't, but when I was over at the License Commission or upstairs, I should say today, I got a sheet with the dates on it and I' 11 make sure that $I$ take care of that right away.

I know both of these gentlemen through both of their restaurants, and I'm very in support of this mostly because $I$ know Dave from the $B$ Side Lounge and 1 ives close to it. I live on Union Street which is close. And he was a very respectful bartender and manager there.

As a neighbor, $I$ work in this business as we 11 differently and somewhere else, and when I go home, $I$ like a quiet neighborhood.

When the B Side was first there, I
worried 1 ike every neighbor did about people strolling through your neighborhood or loud people leaving a bar, and they made our neighborhood so much quieter than the previous bar which we know, and, in my opinion, than the
current bar that's there.

It was a very, very respectful place,
caring about every customer whether they were traveling as a destination or whether they were in the neighborhood.

Same thing with Chris, I've been going to the East Coast Gri11, sadly not anymore, but since $I$ moved here in 1991, and it's the same thing. Very respectful business people. So I would be excited for this place to open in my neighborhood for those exact reasons.

MARC SHULMAN: Marc Shulman, M-A-R-C, S-H-U-L-M-A-N.

CHAIR NICOLE MURATI FERRER: Thank you.

Mr. Shulman, can you tel 1 us what has been going on with this license and --

MARC SHULMAN: The project did not go
through. We transferred the license from an existing business and we intend to transfer it back to both corporations under a different venue. We're waiting for the letter of good standing from the Department of Revenue to move forward.

CHAIR NICOLE MURATI FERRER: When did you request the letter?

MARC SHULMAN: Just recently. Two weeks ago.

CHAIR NICOLE MURATI FERRER: You already
-- is there already an agreement with a buyer or...?

MARCH SHULMAN: We have a --

CHAIR NICOLE MURATI FERRER: I'm sorry.

I didn't quite understand. Are you
retransferring to someone or...?

MARC SHULMAN: Transferring back to
ourselves. There were two locations. And the old location closed and we opened up a dumpling restaurant in Central Square called Patty Chen's Dumpling Room, homemade dumplings from scratch, and we think the alcohol would complement the 1icense. People like to eat dumplings and drink beer and Sake and such.

CHAIR NICOLE MURATI FERRER: You're going to transfer it to yourself and to a different location?

MARC SHULMAN: Different location. The original location was demolished for the 300 Mass Ave building.

CHAIR NICOLE MURATI FERRER: So basically
a11 you're waiting for is the DOR release?

MARC SHULMAN: That's it.

CHAIR NICOLE MURATI FERRER: And you
already requested it?

MARC SHULMAN: Yes.

CHAIR NICOLE MURATI FERRER: A11 right.

Say six months from now, a nonuse
hearing. If nothing has been before us, otherwise we cancel it.

POLICE COMMISSIONER ROBERT HAAS: I
agree.

CHAIR NICOLE MURATI FERRER: This was off because we dealt with it with the waivers, so it was taken off the 1 ist.

## EXECUTIVE DIRECTOR ELIZABETH LINT: My

note was on a different agenda.

Consideration of the 2016 renewal of the
used car dealer License No. UCD10028 for Morgan

Okundaye doing business as NOMA Auto Sales at 2380 Mass Ave.

ATTY WILLIAM SPALLINA: Good evening, William Spalina.

CHAIR NICOLE MURATI FERRER: Let's swear the witnesses in before we start.

For the record, if anyone in the audience
is here to testify on this matter, if you could also stand up and raise your right hand.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Anyone who is going to testify, please stand up and raise your right hand.
(People sworn.)

CHAIR NICOLE MURATI FERRER: Thank you.

Now, good evening. Could you please state your names for the record and spel 1 them for the stenographer?

ATTY WILLIAM SPALLINA: Wil1iam Spaliina, counse1 for NOMA. W-I-L-L-I-A-M,

S-P-A-L-L-I-N-A.

And this is Morgan Okundaye.

M-O-R-G-A-N, is the first name, last name O-K-U-N-D-A-Y-E.

And his wife Jane Okundaye, J-A-N-E, O-K-U-N-D-A-Y-E.

CHAIR NICOLE MURATI FERRER: Thank you.

ANDREA BOYER: Andrea Boyer, B-0-Y-E-R, chief investigator for the City of Cambridge License Commission.

CHAIR NICOLE MURATI FERRER: Thank you.

Go ahead, Ms. Boyer.

ANDREA BOYER: Thank you.

This is regarding consumer complaints
regarding NOMA Auto Sales at 1280 Massachusetts Avenue.

According to our License Commission files

NOMA Auto Sales is owned by Mr. Morgan and

Mrs. Jane Okundaye.

The following are the three current pending cases regarding NOMA: Case Number 1506-5503 Complainant, Mr. Matthew McGuckin, opened June 23, 2015: The buyer, Mr. McGuckin, purchased a green 2000 Chevrolet Malibu with 141,000 miles for $\$ 1,300.00$ in Maine on June 11, 2015. (Please see attached Bill of Sale 1abeled NOMA Auto Sales 1abeled \#1. Please note the Bill of Sale states the sale took place on June 8, 2015, which is part of Mr. McGuckin's complaint). The original listing of the vehicle was allegedly posted by Mr. Edward Delarosa on Craig's List giving the impression to the buyer, Mr. McGuckin, that the vehicle was located in Manchester, New Hampshire. When buyer,

Mr. McGuckin spoke with seller, Mr. Delarosa, he was told not to go to Manchester, New Hampshire, but to Lawrence, Massachusetts to pick up the vehicle.

Mr. McGuckin missed his train, so

Mr. Delarosa had the vehicle delivered by a gentleman, named Patrick, with additional cost to Mr. McGuckin in Topsham, Maine on June 11, 2014. On June 14, 2015 Mr. McGuckin had the vehicle inspected and was told by the inspection mechanic that the vehicle was too rusted to pass inspection.

Mr. McGuckin contacted Mr. Delarosa and was told, "Too bad." He further explained that since Mr. McGuckin bought the vehicle it was now his problem. Mr. McGuckin reviewed his paperwork and realized that the seller's signature was the person who delivered the vehicle, Patrick with NOMA Auto Sales listed as the used car dealer.

Mr. McGuckin further explained the
vehicle history by outlining the back of the vehicle title. He stated that the original owner traded the vehicle in on May 30,2015 to Banks

Chevy, who then sold it on June 4, 2015 to

Bayrock Motors, owned by Mr. Delarosa. Bayrock then sold it to NOMA Auto Sales on June 6, 2015. (Please see attached complainant's McGuckin written statement labeled \#2.) On June 17, 2015 Mr. McGuckin placed a complaint with Massachusetts Attorney General's Office, who forwarded it to the Cambridge Consumer Council. The complaint was faxed to the State of Maine on June 30, 2015. The Secretary of State and Bureau of Motor Vehicles

Investigator, John A. Gould, concluded that NOMA

Auto Sales acted as an unlicensed Dealer in

Maine. Investigator Gould explained to

Mr. McGuckin the difficulty of serving legal
process outside of Maine and that he would
forward the complaint to the Cambridge License Commission.
(P1ease see attached report by

Investigator John A. Gould, labeled \#3.)

Case Number 1511-5500 Complainant

Mr. Brian Fitzgerald, opened November 9, 2015:

The buyer, Mr. Fitzgerald, bought a blue 2002

BWM. The case shows a Bill of Sale signed by Mr. Nickerson Theodat from NOMA Auto Sales.
(Please see attached Bill of Sale NOMA Auto
labeled \#4;RMV-11abeled \#5; Certificate of Tit le labeled \#6.)

Mr. Fitzgerald stated that the vehicle he purchased did not pass inspection and that an expensive part for the headlights needed to be repaired for the high beams to work.
(Please see attached Massachusetts

Vehicle Inspection Report labeled \#7; BMW Service Quote labeled \#8.)

Mr. Fitzgerald sent several certified
letters to NOMA explaining the problem and did not receive compensation to fully fix the
vehicle.
(Please see attached letters labeled \#9, \#10, \#11, \#12.)

The NOMA owners, Mr. Morgan and Mrs. Jane Okundaye, stated that Nickerson Theodat does not work for them and has been using their Auto Dealer 1 icense to attend auto auctions without their approval. Jane Okundaye stated that she has filed a Statement of Small Claim with the Clerk Magistrate Trial Court of Massachusetts.
(Please see attached Statement of Smal1

Claim labeled \#13 and Notice of Trial Court 1abeled \#14.)

The clerk at Dorchester Smal1 Claims stated that the letter sent to the defendant, Nickerson Theodat, was returned and no further action was taken.

Case Number 1512-5509 Complainant,

Mr. Adilo Chinchilla, opened July 31, 2015: The
buyer, Mr. Chinchilla, bought a black 2007
Infinity on July 14, 2015.
(Please see attached RMV-11abeled \# 15.)

The case shows that the transmission did not work and that Mr. Chinchilla purchased a new transmission for the vehicle.
(Please see attached transmission Repair bill dated July 24, 2015 labeled\# 16.)

NOMA would not reimburse Mr. Chinchilla
for the transmission cost and submitted a
complaint to the Cambridge Consumer Council.

Cambridge Consumer Council contacted
Mrs. Jane Okundaye. In January 2016,
Mrs. Okundaye agreed to resolve the complaint and pay the consumer $\$ 1,500.00$ in monthly
installments of $\$ 300.00$ through the Cambridge Consumer Complaint office to the complainant.

They no longer want to have contact with the consumer based on Mr. Chinchilla hanging up the
phone when she or Mr. Okundaye calls.
(P1ease see attached email from Ms. Laura

Nichols labeled \#17.)

Additional information collected: Per
the Commissioner's request $I$ went to NOMA's
office to examine their records. At said time of the request no one was at the 2380 Massachusetts
office. I still took pictures of the exterior of 2380 Massachusetts Ave, kiosk and the business hours of operation that are posted on the door.
(Please see attached Pictures 1abeled \#18, \#19 and \#20.)

On January 26, 2106 informed Ms. Nichols
that another man, other than Nickerson Theodat, was using their used auto license without permission. Mrs. Okundaye contacted Cambridge Police Detective Donald Mahoney. Detective Mahoney performed an investigation regarding the alleged fraudulent usage of NOMA's used car
license to be able to attend auto auctions.
Detective Mahoney stated that he could not contact Nickerson Theodat, but he was able to speak with the second person allegedly using their license, Mr. Kawenja. Mr. Kawenja gave Detective Mahoney a third person's name allegedly using the license, Mr. Belyaev. Detective Mahoney concluded that he has serious doubts that Mr. Kawenja and Mr. Belyaev are buying and selling vehicles with the authority of NOMA Auto Sales. Detective Mahoney submitted a report to our office via email.
(P1ease see attached report labeled \#21.) NOMA's Previous History: There were
three previous cases filed with Cambridge
Consumer Council regarding NOMA Auto Sales.
(Please see attached Consumer Complaint
List labeled \#22.)

Case Number 1402-5493, Complainant,

Mr. Wanderley Fonseca, opened, February 6, 2014, closed June 30,2014.

Mr. Fonseca bought a 2002 Acura from Elie
Routana on January 27,2014 for $\$ 1,900$. The
vehicle failed inspection and a mechanic quoted
it would cost $\$ 2800$ to fix the vehicle and the vehicle needed a new transmission. NOMA refused Mr. Fonseca's claim and Cambridge Consumer

Council got involved. Tony from NOMA responded and negotiated with Mr. Fonseca to his
satisfaction and the case was closed.

Case Number 1404-5493, Complainant

Mr. Ferdinand Furxhi, opened Apri1 15, 2014, closed September 20, 2014. Mr. Furxhi filed a complaint stating that he bought a 1997 Toyota Camry on November 5, 2013
from Mr. Abia Pierre and wanted his money back because the vehicle is a lemon. A Cambridge

Consumer Council representative called NOMA's
owner, Mr. Morgan Okundaye. Mr. Okundaye contacted Mr. Abia Pierre and asked him to call the Cambridge Consumer Council office.

Mr. Pierre contacted the Consumer Council, stated he was an agent for NOMA, and reimbursed the complainant $\$ 250$.

Case Number 1405-5499, Complainant,

Ms. Michelle Rushton, opened May 13,2014, closed August 29, 2014.

Ms. Rushton bought a vehicle from

Patrice, who stated he worked for NOMA Auto

Sales, off a Craig's List ad. The vehicle was located at Patrice's residence in Derry, New Hampshire. The seller requested a $\$ 200$ deposit towards the purchase of $\$ 3500$. Patrice said the vehicle had an oil leak from an oil valve cover gasket, which would be fixed by pick-up. On April 14, 2014 the complainant paid Patrice $\$ 3,300$ cash for the vehicle and got a title/bil1
of sale from "NOMA Auto Sales, 2380 Massachusetts Ave, Cambridge, Massachusetts." The vehicle did not pass inspection and Patrice stopped responding to phone calls. The complainant contacted NOMA Auto Sales and was told, no one by the name of Patrice worked there. The
complainant then contacted Cambridge Consumer

Council in May, 2014. When Cambridge Consumer
Council contacted Mr. Morgan Okundaye, he said he was not familiar with the complaint. The

Cambridge Consumer Council requested, but did not receive, additional information from the complainant. The case was administratively closed.

Please note that Mr. Okundaye's Worker's

Compensation 1 icense renewal paperwork for 2014
and 2015 reflects that NOMA has no employees
other than its owners. (Please see renewal
information attached \#23 and \#24.)

Please advise if further investigation or
information is needed.

CHAIR NICOLE MURATI FERRER: Thank you.

Counselor?

ATTY WILLIAM SPALLINA: I think I'11 te11
you what they're going to say. They're going to say that these people, Mr. Theodat, they don't -they know one of them, but none of them work for them or had the authority to use their 1icense or buy or sel1 cars.

CHAIR NICOLE MURATI FERRER: Who do you know of all these people, do you know Mr. Edward De1arosa?

MORGAN OKUNDAYE: No.

CHAIR NICOLE MURATI FERRER: You have no idea who he is?

MORGAN OKUNDAYE: No, I have no idea.

CHAIR NICOLE MURATI FERRER: Patrick?

MORGAN OKUNDAYE: I know Patrick.

CHAIR NICOLE MURATI FERRER: You know

Patrick?

MORGAN OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: Do you know

Nickerson Theodat?

MORGAN OKUNDAYE: No.

CHAIR NICOLE MURATI FERRER: Do you know Patrice?

MORGAN OKUNDAYE: That's why I have to take Nickerson to the court.

ATTY WILLIAM SPALLINA: Do you know this guy, Patrice.

MORGAN OKUNDAYE: Patrick?

ATTY WILLIAM SPALLINA: No, not Patrick.

CHAIR NICOLE MURATI FERRER: The case
with regard to Ms. Rushton who bought a car for
$\$ 3,500 ?$

MORGAN OKUNDAYE: No, no, no. Don't know her.

CHAIR NICOLE MURATI FERRER: No?

MORGAN OKUNDAYE: No.

CHAIR NICOLE MURATI FERRER: Do you know
someone by the first name or last name Kawenja?

MORGAN OKUNDAYE: Kawenja?

JANE OKUNDAYE: That's the -- that's the guy that --

ATTY WILLIAM SPALLINA: Charles Kawenja.
JANE OKUNDAYE: He doesn't work for us.

MORGAN OKUNDAYE: He doesn't work for
him.

POLICE COMMISSIONER ROBERT HAAS: Do you know him?

MORGAN OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: How about

Belyaev?

ATTY WILLIAM SPALLINA: Kiril1 Belyaev.

JANE OKUNDAYE: I know him, though.

CHAIR NICOLE MURATI FERRER: How do you
know him?

JANE OKUNDAYE: I know him because when somebody called me went to look -- they went to look up NOMA Sales on the internet and because there's -- this guy Carice sold a car to somebody using my auto sales information. And the car was bad. So this guy went to internet to look for NOMA Sales and he called me and he said, "You sold me a car and the car is no good. You didn't do the paperwork." I said, "Who are you? Who sold the car to you?" He said me. I said, "I didn't sell the car to you." He said, "You put it on Craig's List." I said, "No. Do you know the name of the person?" He was furious. "Why are you asking me the name of the person? You sold the car to me." "No, I didn't sell the car to you." I said, "Okay. Bring the paperwork" -because there's a lot of issue going on people using our information to buy cars. "Can you
bring the paperwork so $I$ can see the signature of the person who signed the papers?"

He came to my house to meet me. And when

I looked at the back of the paper, he told me to complete the paper, the title. I said, "Please. I'm sorry. This person that signed this paper I'm not familiar with this. I'm not going to sign this. I want to get to the bottom of this."

I took the paperwork from him and take a copy of the back of the title. So I looked at the last person that bought, the company, the company was from Tennessee, so 1 called Union Motors. I think it was Union Motors. I call the company.

I said, "Please. I bought a car from you guys.

Do you work for" -- he kept -- he said, "What do you want?" I said, "because I bought a car.

This guy -- you didn't complete the paperwork. I need to complete the paperwork." He said, "What are you calling for?" I said, "I bought a car in

Boston." He said, Okay. Someone will call you back." I did not give them my number. I gave them my office number.

Ten minutes 1 later, somebody cal 1 me.
"Did you buy a car?" I said, "Yes. You sold a car to me. The car is no good. I need to do the paperwork." "Okay, okay. What happened?" I said, "You didn't complete the paperwork." He said, "Meet me in Watertown." I said, "Watertown"?

Then I called this guy that was badgering me. I told him "I found the person that sold the car to you. Come with me." Both of us -- I took my two kids with me and went to Watertown. When we got there, I gave him the paperwork. He finish the paperwork and he went and saw the car.

He copied my 1 icense and everything right in front of me. He copied, filled out the paper. After he finished, I said, "Okay. Thank you." I
said, "Do you work for NOMA Auto Sales?" He
said, "Yeah, yeah, yea." I said, "Really? Can I
see proof you really work for NOMA Auto Sales?"

He says "No, no, no. Why, why, why, why?"

Then I got aggressive. I said, "I'm NOMA

Auto Sales. You're using my information. How did you get my information?" Then my two boys came out because he tall. Then my son ask him, "My friend, do you work for NOMA Auto Sales?" Both of them. That's why I took my sons. My son ask "Can you please give me your license," because he thought we like police. So that's the only reason because I didn't want -- because I was -- confronted them first before my two boys came out from the car.

My son said, "Give me your 1 incense and give me the other license." Both of them, one of them was resisting.

I said, "Give it to me right now. I want
to see it." I took the two pictures. I don't know them before.

They -- I said, "How did you get NOMA

Auto Sales?" He told me "Charles." "Who is Charles?" "Some guy." He told me "I pay him a lot of money so $I$ buy car in this name and use NOMA Auto Sales to sell it."

How do people do that?

I said, "Please, based on your
explanation, $I$ have to come to see you're
innocent in this matter."
"You can do me a favor. Let me him write something for you to state that he really permits you to use NOMA." He told me okay. "I don't try to make trouble with you. I don't want to make trouble."

I said, "I understand. I want to get
something because this guys -- they've been using
my information to do this." He said, "What do
you need?" I said, "You don't need to pay me
anything." Then $I$ sent - he sent me a letter
that -- Charles made up a letter using NOMA and NOMA and he wrote his name.

This is the letter he sent to me on my
phone.

So that's -- he give me this letter and
that's why $I$ went to the police.

Before $I$ went there, $I$ went to the police to report this matter. So they would not
take anything. I said, "Please, I need help."

They said they cannot go to arrest somebody
because $I$ wanted them to be arrested.

So that's how I got this information. I
don't even know them. I don't know where they came from.

I understand these people, these guys
just -- this is because -- my husband was telling you, this is what they do.

They take deposit information when they
ask you to buy a car from you, they collect your
information and you to sell cars without
permission. So he said -- I understand he told detective.

EXECUTIVE DIRECTOR ELIZABETH LINT: One
at a time.

JANE OKUNDAYE: He told Detective Mahoney
that -- he's our friend. He knows also -- let's see about the auction. Maybe he bought a car
from us one time not knowing the intention.

That's what they do. That lawyer told us that.

This is what they do.

They have a lot of lawsuits because of this type of behavior.

CHAIR NICOLE MURATI FERRER: A question:

From all these cases was Mr. Adilo Chinchilla the only person that NOMA sold to?

MORGAN OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: Can you tell
me whose signature is on the bottom of this -- on the top of NOMA, who signed that?

ATTY WILLIAM SPALLINA: I'm not sure -where are you?

CHAIR NICOLE MURATI FERRER: At the very bottom of the page.

ATTY WILLIAM SPALLINA: Above the name NOMA?

MORGAN OKUNDAYE: I don't know.

CHAIR NICOLE MURATI FERRER: Whose signature is that?

MORGAN OKUNDAYE: Which one?

ATTY WILLIAM SPALLINA: Right there.

ANDREA BOYER: Where your finger is.

MORGAN OKUNDAYE: I think it was you.

Maybe it's her.

CHAIR NICOLE MURATI FERRER: Is that your
signature, ma'am?

MORGAN OKUNDAYE: Sometimes she sign like this.

CHAIR NICOLE MURATI FERRER: I want a
"yes" or "no." Is that your signature?

JANE OKUNDAYE: I can't remember if I --
no, this is not -- no.

CHAIR NICOLE MURATI FERRER: That's not your signature. So who sold him his car?

JANE OKUNDAYE: Who is this person?

ATTY WILLIAM SPALLINA: This is

Chinchilla. This is -- the car was sold to Adilo Chinchil1a.

JANE OKUNDAYE: Let's see that paperwork.

ATTY WILLIAM SPALLINA: What do you need to see?

JANE OKUNDAYE: I want to see the front of this one, the title.

FIRE CHIEF GERALD REARDON: I guess I'm unclear. You're saying that's not your
signature?

JANE OKUNDAYE: No.

MORGAN OKUNDAYE: No.

CHAIR NICOLE MURATI FERRER: Who sold the
car to Chinchilla?

JANE OKUNDAYE: Who is Chinchilla?

ATTY WILLIAM SPALLINA: The guy you
resolved the complaint with.

MORGAN OKUNDAYE: Resolved the complaint.

JANE OKUNDAYE: Okay. That brother that brought him.

MORGAN OKUNDAYE: Maybe. That's not my signature.

JANE OKUNDAYE: This is our judgment --
they always 1 ike refer people to us.

CHAIR NICOLE MURATI FERRER: He works for

NOMA?

MORGAN OKUNDAYE: No, no.

JANE OKUNDAYE: No, no.

MORGAN OKUNDAYE: He doesn't work for

NOMA.

## CHAIR NICOLE MURATI FERRER: He refers

cases and he signs on behalf of NOMA, but he doesn't work for NOMA?

JANE OKUNDAYE: Because like every time we go to the auction, we always -- he always help me out with papers and he always -- he drive us home. He's the one that referred this guy to us.

FIRE CHIEF GERALD REARDON: When you go to the auction, you have to present credentials and your 1 incense to purchase as a dealer?

MORGAN OKUNDAYE: Yes.

FIRE CHIEF GERALD REARDON: How are these people buying on your behalf unless they have the credentials?

MORGAN OKUNDAYE: No. The way it work, we go to the auction, and let's say you want to buy, you say "Okay. You want to buy?" You take
it to the auction. You see the car you like, now we bid for it. When $I$ bid for it, then when you like it, you took it and you pay for it, and then when you pay for it, then -- sometimes they say on the auction board, they will have blue -- red, green, blue lights, yellow lights. If it's yellow and blue -- blue means (inaudible) -yellow mean (inaudible). Green means there's no problem. Sometimes when you buy it and do the paperwork, then you give it to the customer.

FIRE CHIEF GERALD REARDON: But you, as
the dealer, do the paperwork --

MORGAN OKUNDAYE: Yes.

FIRE CHIEF GERALD REARDON: -- not the
customer.

MORGAN OKUNDAYE: No customer, no, no,
no.

FIRE CHIEF GERALD REARDON: You're doing
the paperwork at the auction because the auction

is only allowed to sel1 to dealers?
    MORGAN OKUNDAYE: Yes.
```

FIRE CHIEF GERALD REARDON: What do you
present to the auction for paperwork?

Do you have a 1 icense and you have a
dealer number and you have a credential?

MORGAN OKUNDAYE: Yes.

FIRE CHIEF GERALD REARDON: What is the
credential? Do you have the credential with you? MORGAN OKUNDAYE: The auction.

JANE OKUNDAYE: Yeah.

CHAIR NICOLE MURATI FERRER: This person
that you said signed this application form to transfer the title, what was his name?

JANE OKUNDAYE: Which one?

CHAIR NICOLE MURATI FERRER: Chinchilia.

JANE OKUNDAYE: Yeah.

CHAIR NICOLE MURATI FERRER: What was the
name that you said signed for NOMA?

MORGAN OKUNDAYE: Kolangi.

CHAIR NICOLE MURATI FERRER: How do you
spe11 that?

MORGAN OKUNDAYE: K-O-L-A-N-G-I.

CHAIR NICOLE MURATI FERRER: Isn't that
the person that the detective spoke to?

ANDREA BOYER: That is one of the gentleman being referred to the paperwork.

FIRE CHIEF GERALD REARDON: So when you go to the auction, you have to present your card as a dealer, right?

MORGAN OKUNDAYE: Yes.

FIRE CHIEF GERALD REARDON: And then do they verify you with your driver's license to prove this is you?

MORGAN OKUNDAYE: Yes.

FIRE CHIEF GERALD REARDON: So no one can use your card unless they have it in hand and they're verifying --

MORGAN OKUNDAYE: No, no, no.

ATTY WILLIAM SPALLINA: If you look at
the photograph, this guy in Watertown made a card using their name.

JANE OKUNDAYE: That's not what he did.

What he did after -- if we buy a car for somebody 1ike -- they can buy their own car, some of them have wholesale 1 icense, they cannot sell. So they buy with the wholesale, they go in there with the 1 icense, after they buy -- this is what this guy did -- after they buy with the wholesale 1icense, they will not send to NOMA Auto Sales using our information.

This is -- it's not like they have our card to go in. They don't have our card to go in.

FIRE CHIEF GERALD REARDON: You're saying they falsified your information?

MORGAN OKUNDAYE: Yes.

JANE OKUNDAYE: Because like -- if you
buy a car for somebody, definitely just like I made a copy for -- made a back of the copy of the title. So this is what $I$ think they did. They make the back of the title like they pretended to buy a car from us not knowing they have ulterior motive 1 ike different intention to copy all our information because once we give the paperwork, it's like anybody can copy it. So I think that's what these guys are doing. Because they didn't tell us this is what they will be doing until this problem start coming from everywhere.

FIRE CHIEF GERALD REARDON: So the thought is that the other car is a fraudulent car?

MORGAN OKUNDAYE: Which one?

ATTY WILLIAM SPALLINA: Kiril 1 is a
wholesaler? Can we see a copy of it?

JANE OKUNDAYE: This is fraudulent. This
is not fraudulent. Because this -- he owned this license. This is his own license. He's buy cars under -- this is the one I looked for Union

Motors. This address is in Tennessee. So now he buys as a wholesale and sold it to NOMA. He can go to the auction with this information with his card. But once he buy the car wholesale, he not transferred to NOMA and he is not selling like NOMA Auto Sales.

FIRE CHIEF GERALD REARDON: He's claiming to sell to NOMA, but he's not authorized?

JANE OKUNDAYE: He's not authorized, but he's selling to NOMA.

FIRE CHIEF GERALD REARDON: He's buying the car at the auction under his card?

JANE OKUNDAYE: Yeah, yeah, yeah.

FIRE CHIEF GERALD REARDON: But at the car auction, you have to swipe the card, so he's using his card?

MORGAN OKUNDAYE: Exactly, exactly, to
try to buy from the auction. They now
transferred the paper to NOMA.

FIRE CHIEF GERALD REARDON: There's no
way of proving he stole your ID. He would have
to have swiped his own card and purchased it on
his own, but then he's -- your contention is that he's now selling it as NOMA without authorization?

MORGAN OKUNDAYE: Exactiy.

JANE OKUNDAYE: Because a long time ago,

I remember Charles bought a car from us, but we didn't know that is what he does. I'm sure when Charles got our information, we never really take -- he doesn't work for us. He has his own dealership. But his own dealership is wholesale. Now, he gets our information just 1 ike here.

Anybody can copy this. The information is there. My license number is there, everything is in
there. This is where he got information and he sold my information to this guy. He said he paid \$1,000 to Charles.

MORGAN OKUNDAYE: It's in the report.

JANE OKUNDAYE: For him to use NOMA Auto

Sales, Charles doesn't work for NOMA Auto Sales.

CHAIR NICOLE MURATI FERRER: When you
fil1 out the paperwork, do you use the stamp with NOMA and your information?

JANE OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: Is it like
the one that Nicholas Theodat used?

JANE OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: But you're
saying that Nicholas Theodat never worked for you?

MORGAN OKUNDAYE: We don't know him.

CHAIR NICOLE MURATI FERRER: He went
through the trouble of creating a stamp just like
yours?

JANE OKUNDAYE: And he put his number.

CHAIR NICOLE MURATI FERRER: That's not your phone number.

JANE OKUNDAYE: 617-407-8444.

CHAIR NICOLE MURATI FERRER: So 429-1398
doesn't appear in your records?

JANE OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: The person you do authorize to sign for NOMA handwrites your stuff, they don't use your stamp, is that what you're saying?

JANE OKUNDAYE: That's -- yeah, because we didn't use the stamp. Sometimes my husband is not there and somebody comes to do the paperwork, and I use my hand to write it, too. As far as the information is correct.

FIRE CHIEF GERALD REARDON: But you did make a settlement with Laura Nichols on a car you
sold, correct?

CHAIR NICOLE MURATI FERRER: No Laurie
Nichols is the director of Consumer Council.

They only did it on Chinchilla matter.
FIRE CHIEF GERALD REARDON: I'm sorry.

The Chinchilla matter, Adilo Chinchilla.
ATTY WILLIAM SPALLINA: I would note
while we're looking at the bill of sale,

Mr. Chinchilla paid $\$ 9,000$ for the car submitted
to the investigator a bill allegedly from Silver

Auto Repair claiming it needed $\$ 2,900$ for a
transmission, parts and labor.
FIRE CHIEF GERALD REARDON: It appears
that's a used transmission.

ATTY WILLIAM SPALLINA: Maybe used, yeah.
But settled his case for $\$ 1,500$ and apparently
kept the car, as I understand it. Apparently he
was satisfied because he took $\$ 1,500$ and kept the car. And for some reason, one of the
complainants was Brian Fitzgerald. He puts down an address for NOMA as being on North Street in Randolph with a 508 phone number. I don't know where he got that from. That's obviously not where NOMA is and that's not their phone number.

CHAIR NICOLE MURATI FERRER: What are you looking at?

ATTY WILLIAM SPALLINA: 12.

FIRE CHIEF GERALD REARDON: When you go
to the auto auction, do you ever buy cars for someone just for a handling fee, like you buy the car and you catch \$100, \$200 cash for purchasing the car and let them do it?

MORGAN OKUNDAYE: No. At the auction,
no. When I have a customer let's say like that, he brings a customer to us and we go to the auction.

FIRE CHIEF GERALD REARDON: From the auto auction, you should have paperwork showing them
of transferring ownership to you for each of
these vehicles, correct?

ATTY WILLIAM SPALLINA: I don't think the auto auction takes title. It comes from a dealer directly.

FIRE CHIEF GERALD REARDON: So --

ATTY WILLIAM SPALLINA: Like the title
here from this dealer in Tennessee.

FIRE CHIEF GERALD REARDON: Counse1,
there's no record of the -- your recitation is
that the auto auction has no record of what they did with that car, or how they transferred it to someone?

ATTY WILLIAM SPALLINA: Do you know if
the auto auction keeps a record of the sales they make identifying the buyer?

FIRE CHIEF GERALD REARDON: They may not have the title for it, but...

CHAIR NICOLE MURATI FERRER: They do give
you a receipt.

JANE OKUNDAYE: No, the auction -- what
happened the dealers give the title to the auction, so after -- 1 ike if $I$ buy with my
license if $I$ buy, now the auction will not do the paperwork on behalf of the dealer. They give it to me as the buyer.

FIRE CHIEF GERALD REARDON: So the auto auction will do the title?

MORGAN OKUNDAYE: Yes. Give to me.

FIRE CHIEF GERALD REARDON: There must be that paperwork for all of these cars you buy that you have a copy of? When you buy from the auction and they transferred you the title, there has to be paperwork to that effect.

JANE OKUNDAYE: We have, yes.

FIRE CHIEF GERALD REARDON: Do you have any of that for these vehicles?

JANE OKUNDAYE: We're not disputing this.

We bought that. But those other ones we didn't buy at all. Like this one.

MORGAN OKUNDAYE: We didn't buy this one.

You see the Union is transferred to NOMA Auto

Sales, that's why we have to give to the cops.

Because a lot have been using -- they have been using information without authority.

JANE OKUNDAYE: Because we have been
dealing with this for awhile right now. I went to the Registry and we -- to change the number and they told us even if you change the number,
they can still use it because we try to change the number so everyone have -- nobody has my
information. So they said because -- we went as
far as changing the number to get a different
number, so that they can stop using our
information.

FIRE CHIEF GERALD REARDON: How many
cases are there, four or five?

ANDREA BOYER: Altogether there's the
three for right now and there was a fourth from years ago.

FIRE CHIEF GERALD REARDON: The three that's present right now, how many do you acknowledge are yours?

MORGAN OKUNDAYE: One.

ANDREA BOYER: May I ask a question for
the Board?

When we first started to talk about the different people that you may or may not know, I know there's a difference between Patrice and Patrick. You stated that you know Patrick.

MORGAN OKUNDAYE: Yes.

ANDREA BOYER: Patrick was the one that brought the car for the gentleman in Maine. Does he work for you? How do you know Patrick?

MORGAN OKUNDAYE: The auction. At the auction.

ANDREA BOYER: He also --

MORGAN OKUNDAYE: He goes to the auctions.

ANDREA BOYER: You only know him -- if he delivered a name --

MORGAN OKUNDAYE: I don't know him.

ANDREA BOYER: You just know who he is?

MORGAN OKUNDAYE: Yes.

ANDREA BOYER: Do you have any open cases against him as well using your name since you know him and you know where he lives? Have you opened up a case?

MORGAN OKUNDAYE: I know he was one --

ANDREA BOYER: You had opened up a case against Nicholas Theodat, but you do know Patrick and you had this case a couple weeks? Have you thought about placing a complaint against him as wel1 for using your name?

MORGAN OKUNDAYE: I don't --

ANDREA BOYER: I don't know Patrick's
last name. What is Patrick's last name?

MORGAN OKUNDAYE: I don't know Patrick's
last name.

ANDREA BOYER: You don't know Patrick's
last name. So you're going to throw a case at him as well? I have an address for Nicholas Theodat if you want it.

FIRE CHIEF GERALD REARDON: Do you believe that Patrick has an ID for the auction?

MORGAN OKUNDAYE: I have to find out when

I go to the auction. Now I will find out and ask him everything and hand it over to my 1 lawyer.

FIRE CHIEF GERALD REARDON: Have you
tried to go to the auction and say that you believe that people have been misrepresenting you?

MORGAN OKUNDAYE: We have not been able
to -- we have not renewed. You cannot go to the
auction. Since if you don't renew and you try to take this 1 icense, it won't work.

ANDREA BOYER: The people using your

1icense, are they still able to go to the auctions?

MORGAN OKUNDAYE: I don't know.

CHAIR NICOLE MURATI FERRER: But if I'm
understanding your complainant's position correctly, what they're saying is that none of these people are actually using their license. What they're doing is that they actually go to the auctions, either as a wholesaler or a friend of a friend, and buy these vehicles, and just for the heck of it or putting NOMA as the seller with the number 21 dealer next to it?

MORGAN OKUNDAYE: That's correct. That's
correct. That's correct. That's correct.

That's correct.

ATTY WILLIAM SPALLINA: I think some of
these people are going with wholesale dealers' 1icenses. They're not just going -- that's how they're getting in and buying the cars.

FIRE CHIEF GERALD REARDON: As a
wholesaler, they can't sell retail.

ATTY WILLIAM SPALLINA: Right, but they
can buy at the auction. They'11 go with a valid wholesaler 1 icense and selling retail which apparently is --

FIRE CHIEF GERALD REARDON: I guess my other question is: If they go up there and using NOMA's credentials, apparently the car auction isn't very critical about writing the title to them --

ATTY WILLIAM SPALLINA: I was surprised to hear that.

FIRE CHIEF GERALD REARDON: -- under
false pretenses, so to speak?

ATTY WILLIAM SPALLINA: I would have
thought the auction would keep better records of who comes and goes there.

I understand from talking about this case with other 1 awyers that you would be surprised, apparently, as long as they can sell cars, they se11 cars. Exactly who is to regulate how they supervise who they sell to is not clear to me. So that's my understanding. I'm not exactly sure what records they're supposed to keep, but, obviously, if someone goes in with a wholesale 1icense and they keep a record, there's no cause for concern. They don't know what that person does to that car afterwards. As far as they know, he is a wholesaler and sells to a dealer.

FIRE CHIEF GERALD REARDON: But in the case of the ones where the wholesaler potentially bought on behalf of NOMA, did the car auction do the title transfer to NOMA or to the wholesaler, do we know?

MORGAN OKUNDAYE: To the wholesaler. To
the wholesaler. They went to sell to customer, they transfer to NOMA first before they sel to customer.

FIRE CHIEF GERALD REARDON: Because they can't transfer the wholesale to the customer direct1y.

MORGAN OKUNDAYE: Yes. What we -- we go back to Registry, want to make sure we change.

JANE OKUNDAYE: As a matter of fact, I need help personally because if people are doing this, somebody wrote a letter stating he works for NOMA Auto Sales, they just cannot get away with this 1 ike that. They take away food away from my table. How many months now with this and Charles is on this. The somebody paying $\$ 2,000$ something to use our information.

CHAIR NICOLE MURATI FERRER: Did you get that information to the police detective?

JANE OKUNDAYE: I did.

CHAIR NICOLE MURATI FERRER: When?

JANE OKUNDAYE: As soon as I finished, I
came to the office -- no, I went to the police
station. I drop all these things off.

CHAIR NICOLE MURATI FERRER: I'm
wondering whether because the detective's report came in awhile back. Have you given him this information since that time --

JANE OKUNDAYE: Yes.

MORGAN OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: -- so he can
investigate this situation?

MORGAN OKUNDAYE: Yes.

CHAIR NICOLE MURATI FERRER: Do you want to take this under advisement?

POLICE COMMISSIONER ROBERT HAAS: Take it under advisement.

ATTY WILLIAM SPALLINA: The detective in
his email does mention Mr. Belyaev so he, in fact, called him.

CHAIR NICOLE MURATI FERRER: Counselor,
do you have anything else for us?

ATTY WILLIAM SPALLINA: That's it.

There's three complaints that are the subject of this hearing. One of them apparently has been resolved to the satisfaction of the consumer, to the extent he didn't want to give the car back and wanted to keep it. He submitted an estimate for $\$ 2,900$, but accepted or is accepting $\$ 1,500$, so I'm assuming he's satisfied.

And the other two involved these people they have gone to the police, they have given all the information to the police, they confronted this guy. They got information out of him which

I think was dangerous. They filed a suit against this guy Theodat based on the address they had.

It came back with no good address. Now I
understand there's a good address for him. I don't know what else they can do to stop people from doing this.

CHAIR NICOLE MURATI FERRER: We'11 take this matter under advisement. Take this matter under advisement and $I$ think our next -- is it the 8 th or when do we meet next?
