Single story 10,032 square foot brick and concrete structure situated on a 10,684 square feet plot of land with brewing/bottling room (6,339 square feet), tasting room with bar (1,060 square feet), kitchen (177 square feet), three bathrooms, break room, and storage in rear (1,300 square feet). Building is a rough rectangle, approximately 73 feet wide facing the street and going back 152 feet, with a cutout in the back right corner that is 13 feet wide by 39 feet long. CHAIR NICOLE MURATI FERRER: Good evening.

Please state your name for the record.

CAYLA MARVIL: My name Cayla, C-A-Y-L-A.

Last name Marvil, M-A-R-V-I-L.

ANDREW JONES: My name is Andrew Jones, $\label{eq:J-0-N-E-S} \text{J-0-N-E-S}.$

TYLER FITZPATRICK: Tyler Fitzpatrick,
T-Y-L-E-R, F-I-T-Z-P-A-T-R-I-C-K.

CHAIR NICOLE MURATI FERRER: Thank you.

I do know that you guys already have a farmer
brewery license there, correct?

CAYLA MARVIL: Correct.

CHAIR NICOLE MURATI FERRER: Can you tell us what the public need is for the pouring license?

CAYLA MARVIL: Sure. A main point of the business is we really want it to be downtown and have a tap room place where people can come in and sit and watch the brewing process, learn about what we're doing and sample our beers.

We're hoping to have a tap room to give people the opportunity to do that. Whereas the farmer brewer license we have now only allows us to sell off-sites to accounts.

ANDREW JONES: That opens up the building right now. It's a closed space right now, 10,000 square feet and having a tap room will allow us to open it up to the public.

through the application had a few questions. I know you already, since the farmer brewery license goes straight through the ABCC, I'm sure you already have gone through this process and all you have been vetted by the ABCC, but, unfortunately everyone has to fill out everything all over again.

Right now I'm missing all the CORI information forms except for the manager of record.

CAYLA MARVIL: Okay.

CHAIR NICOLE MURATI FERRER: So I need all of the people involved with interests to submit their CORI forms again.

CAYLA MARVIL: Okay. Got you. For the ABCC, they just had us do it for the voting members but we can get everybody else to do it.

CHAIR NICOLE MURATI FERRER: They only had you -- even though this is not a publicly-traded company or anything?

CAYLA MARVIL: We have Class A members, which is the two of us and everybody is Class B members. And as Class A members we're the only two with voting rights.

CHAIR NICOLE MURATI FERRER: That's only why I have your CORI forms.

CAYLA MARVIL: For the two of us.

ANDREW JONES: They told us the ownership percentage was small enough.

CHAIR NICOLE MURATI FERRER: Less than 5 percent, so it didn't matter.

CAYLA MARVIL: Yes.

ANDREW JONES: We can do that, if you like.

chair Nicole Murati Ferrer: Listen, it's an ABCC requirement, not a local board requirement. I mean, we can send up the application that way, but if it gets kicked back to us, it's because of that.

CAYLA MARVIL: Okay.

CHAIR NICOLE MURATI FERRER: So it really -- it's not a local requirement because of what you just mentioned, but because it wasn't a publicly-traded company pursuant to the ABCC kind've matrix, it says that you have to, but since they have already gone through that, I mean we can certainly try it.

CAYLA MARVIL: We're willing to try.

CHAIR NICOLE MURATI FERRER: Who is in the DMI Group, LLC?

CAYLA MARVIL: It's Tom Neidermyer (phonetic) and Aaron Sells (phonetic), and they both have personal information forms in there.

CHAIR NICOLE MURATI FERRER: And are you pledging the inventory?

CAYLA MARVIL: No.

CHAIR NICOLE MURATI FERRER: I'm going to have you check "no" on that.

CAYLA MARVIL: Sure.

CHAIR NICOLE MURATI FERRER: Because it wasn't answered. I'll give this to you. 16C.

You guys are going to be closed on Mondays?

CAYLA MARVIL: Correct.

CHAIR NICOLE MURATI FERRER: You're

currently operating?

CAYLA MARVIL: We're not currently in

operation. We're under construction.

CHAIR NICOLE MURATI FERRER: When do you expect to finish construction?

CAYLA MARVIL: Hopefully in mid-May is the projection.

CHAIR NICOLE MURATI FERRER: Ms. Marvil,

I know that you're approved as the manager of
record on the other permit, correct?

CAYLA MARVIL: Correct.

CHAIR NICOLE MURATI FERRER: Have you been approved in any other license, liquor license?

CAYLA MARVIL: Just our Federal brewing permit, but no otherwise.

CHAIR NICOLE MURATI FERRER: Can you tell us a little bit about your experience?

CAYLA MARVIL: Sure. I worked in the restaurant industry for the last ten years, various commissions, manager, server, bartender,

chef.

And prior to Lamplighter, I was a manager at a cafe in Vermont and they had a beer and wine license. I wasn't the manager of record there, but I did work really closely and understood the responsibilities.

CHAIR NICOLE MURATI FERRER: Have you received the 21 Proof training?

CAYLA MARVIL: I have.

CHAIR NICOLE MURATI FERRER: Are you familiar with the rules and regulations and the laws with regard to the sales and service of alcohol?

CAYLA MARVIL: Yes.

CHAIR NICOLE MURATI FERRER: You understand we expect you to stay up to date with those rules and regulations?

CAYLA MARVIL: Yes.

CHAIR NICOLE MURATI FERRER: Are you a

Massachusetts resident?

CAYLA MARVIL: Yes.

CHAIR NICOLE MURATI FERRER: Are you a US citizen?

CAYLA MARVIL: Yes.

CHAIR NICOLE MURATI FERRER: Any questions?

ASSISTANT FIRE CHIEF GERARD MAHONEY:

Are you going in the space that was Metric

Systems?

CAYLA MARVIL: Yes.

CHAIR NICOLE MURATI FERRER: I have one more for Aaron Sells. The personal information form, can you just fill out No. 5 completely?

Specifically the percentage interest -- sorry -- I should have had you come and also for you,

Ms. Marvil, on there, No. 5.

CAYLA MARVIL: I'm not positive. I would have to look this up.

CHAIR NICOLE MURATI FERRER: Anyone in favor of this petition?

Anyone in opposition to this petition?

Questions?

POLICE COMMISSIONER ROBERT HAAS: Are you planning to sell from 11:00 to closing?

CAYLA MARVIL: Correct, yes.

ASSISTANT FIRE CHIEF GERARD MAHONEY: I

do have one question. There was a small -
there's a small parking area adjacent to that

building, is that --

CAYLA MARVIL: Unfortunately, it's not ours.

ANDREW JONES: We wish we could have more seats out there. They're actually turning that into a garden center. It was a small garage that just went in business there.

CHAIR NICOLE MURATI FERRER: Do you have the green cards?

I note for the record we received two letters from different people, neighbors, who were in support of this application.

Yes, ma'am. You need to come up and state your name, and if you're a resident, your address.

MARGO BRATHWAITE: I'm new to this process. My name is Margo, M-A-R-G-O, Brathwaite, B-R-A-T-H-W-A-I-T-E.

And I have represented the first Holyness
Church on Columbia Street which is around the
corner.

We just have a few concerns and questions. And we have been there for a hundred years or so and parking is always an issue.

So our main concern is parking. Right now, as congregates of the church, we find it hard to park on Sundays, and during the week nights or have anything going on, we wanted to

know how you were going to address that.

This may have already been answered. I don't know.

ANDREW JONES: So this was a conversation we had during the Zoning Board hearing about parking, and actually one of our emphasis is to make sure people are not driving. We don't want people driving, especially if they're going to be drinking beer. The hope is not to do that.

We're on Broadway there. There's some parking there. We agree that's not ideal. But we're also going to point people to the parking garages and make sure no one is double parking and emphasize Uber and other alternative transportation.

It's a relatively small space. It's 35 seats. We don't anticipate it being a huge additional burden on the parking. We actually live on Boardman Street right down there, so we

know parking can be a bit of a drag.

MARGO BRATHWAITE: I have another question.

Our other concern is loitering. What do you -- how do you anticipate preventing this from happening and your hours of service that --

ANDREW JONES: Loitering. We're actually --- we were talking about this. We're putting NO SMOKING signs and hopefully have nobody in front of the building at all. And that's something we would like to avoid, too, because that is not good for anybody. We weren't really anticipating this behavior much like a bar. It should be more like a coffee shop look and feel. I don't think it should be particularly crowded in that way. That's not much of an issue. We can make sure that doesn't happen with our staff coming out.

And the second part of your question was?

MARGO BRATHWAITE: Your hours of

operation?

ANDREW JONES: We want to be open from -- did we apply for 11:00 a.m.?

CAYLA MARVIL: 11:00 a.m. to 12:00.

ANDREW JONES: 11:00 to midnight, and the thought there being that last call would be at 11:15. We don't want to be a late night spot. We're not applying for 2:00. We're just so you can come over and have a drink.

MARGO BRATHWAITE: I can't, but...

Thank you.

CHAIR NICOLE MURATI FERRER: Just for the record, the First Holyness Church is not submitting an opposition to this application, is that correct?

MARGO BRATHWAITE: Can we? I don't know.

CHAIR NICOLE MURATI FERRER: So pursuant to the law when you got your affidavit, when you got notice of this, I mean, there's a whole

write something to the Commission for its consideration with regard to whether or not they oppose the application or are concerned. I'm wondering because we have not received anything to date.

Was the intent of the church to file something with us?

MARGO BRATHWAITE: Okay.

Can I -- I'm not sure. I can get an answer by tomorrow and -- is it too late to mail something?

CHAIR NICOLE MURATI FERRER: No, that's fine. We'll take this matter under advisement and then if you can just call the Commission tomorrow and let us know whether something -- whether we should expect something or not.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: 0912, LLC doing business as Forage, has applied for a new Common Victualer All Alcoholic Beverages License to be exercised at 5 Craigie Circle, Stanislas Hilbert, as proposed Manager, and hours of operation for Monday-Friday of 5:00 p.m. to 1:00 a.m., and Saturday and Sunday 10:00 a.m. to 1:00 a.m., and a seating capacity of 49. Applicant is also applying for an Entertainment License to include an audio tape machine/CD/computerized digital media that can be played below conversation level. Premise description: Restaurant at basement level on Craigie Circle, one main dining room with bar (approximately 1200 square feet) with storage in

the rear (approximately 550 square fee). One main entrance on Craigie Circle and one rear service entrance.

ATTY KRISTEN SCANLON: Good evening,

Madam Chair and Members of the Board, Kristen

Scanlon, Scanlon Law, LLC.

With me this evening and seated to my

left is Stan Hilbert, H-I-L-B-E-R-T, who is the

LLC manager, sole member and proposed manager of

record as the applicant before you this evening.

Just by way of background, the applicant is seeking to open a new restaurant with all alcoholic beverages license at 5 Craigie Circle which is the former home of Ten Tables which was there over a decade. Stan, who has 20 years of experience in all phases and facets of the restaurant industry, including being a general manager at Solea, beverage director, and head server at Solea, most notably worked with Ten

Tables for the past eight years and is a critical piece of their team and daily restaurant operation. So he is seeking to open his first restaurant and share his version and expertise and fine dining and wine and spirits in a small neighborhood setting.

Additionally, he's excited to bring onboard with him Chef Eric Copper who has additionally 20 years of global experience in the restaurant industry from London to Madrid to New York City to Ten Tables in Jamaica Plain and South Africa. And this location, as you know, is a featured dining location and we're seeking to keep it that way.

I would like to turn it over to Stan in a few moments to tell you further about the concept he has in mind regarding the food and beverage programming. But what the Board can essentially expect is elements of what he's learned in his

experience in fine dining with L'Espalier and

Ten Tables and would like to bring that same

consistency and excellence in his food and dining

programming and hospitality and service he can

bring to the customers, residents and

nonresidents alike to Cambridge.

As this is a new liquor license application, as far as public need goes, this is a unique restaurant concept in an existing former restaurant space was previously used as a restaurant space, and looking to keep it that way. This is an amenity and dining option that the neighborhood has had for several years, and otherwise, it would be shuttered. And it's an ideal restaurant location in a neighborhood setting of its size can really focus on the culinary and wine and spirits expertise they can provide to their customers.

As far as jobs go, they anticipate adding

14 full-time staff members, and as far as the setting in the restaurant goes, you can expect to see largely how Ten Tables looked with a fresh coat of paint and new signage. They plan to keep the same seating and tables and chairs and just kind of give it a cosmetic facelift before opening.

So at this point, if I may turn it over to Stan to tell you a little bit more about the concept itself.

CHAIR NICOLE MURATI FERRER: Before we go to Mr. Hilbert, I do have a couple questions. I always mispronounce her name. Is it Kranyak?

ATTY KRISTEN SCANLON: Kranyak, yes.

CHAIR NICOLE MURATI FERRER: So she is sort of giving a loan with regard to this transaction, is that correct?

ATTY KRISTEN SCANLON: Correct.

CHAIR NICOLE MURATI FERRER: Can you tell

me how that doesn't imply Section 25 of Chapter 128?

ATTY KRISTEN SCANLON: It's a private promissory note that the seller funded. I did talk to the ABCC about that and they said that was okay to do, which he'll be paying back which is laid out in the promissory note loan that was included as an attachment to the asset purchase agreement.

CHAIR NICOLE MURATI FERRER: Because she's doing it personally and not through the license?

ATTY KRISTEN SCANLON: It's not related to the license. It's related to the assets. The furniture and fixtures and equipment.

CHAIR NICOLE MURATI FERRER: She has licenses elsewhere in the state, correct?

ATTY KRISTEN SCANLON: That's correct.

CHAIR NICOLE MURATI FERRER: And it

doesn't imply that because it doesn't apply indirect of a licensee on Section 25?

ATTY KRISTEN SCANLON: She won't have an interest in this license.

CHAIR NICOLE MURATI FERRER: Who at the ABCC did you speak to about this?

ATTY KRISTEN SCANLON: Ralph Sacramone.

CHAIR NICOLE MURATI FERRER: In the description of the premise, it says restaurant basement level on Craigie Street, and the last sentence, one main entrance located on Craigie Circle. Is that a typo or is there a street --

ATTY KRISTEN SCANLON: It's a typo. It's circle and I can fax that to the Board.

CHAIR NICOLE MURATI FERRER: Yes, that would be great. Thank you.

And we do know that the seller doesn't really have a title on the license, correct?

ATTY KRISTEN SCANLON: What do you mean

by that?

CHAIR NICOLE MURATI FERRER: So on the purchase and sale agreement on 11A that's on Page 5, do you have a copy of it with you?

ATTY KRISTEN SCANLON: Of the asset purchase agreement?

CHAIR NICOLE MURATI FERRER: Uh-huh.

ATTY KRISTEN SCANLON: Yes.

CHAIR NICOLE MURATI FERRER: It says:

Representations and covenants, and then it has

11A title and The seller has good and marketable

title to the license.

This is not really the sale of the license?

ATTY KRISTEN SCANLON: Right. Right. Understood.

CHAIR NICOLE MURATI FERRER: I want to make clear that doesn't really apply and that's not appropriate in this.

ATTY KRISTEN SCANLON: This says title to the assets, which I did go back and forth with Ms. Lint on correcting. So there is -- it was corrected to just say assets and can exclude the license.

CHAIR NICOLE MURATI FERRER: We'll need a copy.

ATTY KRISTEN SCANLON: A fresh copy.

CHAIR NICOLE MURATI FERRER: It says title to the license.

ATTY KRISTEN SCANLON: Got you.

EXECUTIVE DIRECTOR ELIZABETH LINT: It should be in there somewhere.

ATTY KRISTEN SCANLON: I can simply email you over a new one if that's easier.

CHAIR NICOLE MURATI FERRER: We can swap that page if that's the only one that changed. I saw it and I wanted to flag it because I was like, wait a minute.

And then Lucinda Hilbert has no interest in the license?

an affidavit prepared ready for her to sign because I know typically the ABCC asks about that. She signed on as a limited guarantor to get the financing through East Boston Savings

Bank.

CHAIR NICOLE MURATI FERRER: You do have her affidavit?

ATTY KRISTEN SCANLON: I don't have it signed. It's prepared. I'm waiting for her to sign it. I can get that to you as well as the ABCC.

CHAIR NICOLE MURATI FERRER: Okay. Now we'll here you from Mr. Hilbert.

STAN HILBERT: I have been working in this industry for 20 years in Boston. I have been with Ten Tables for eight years. I worked

in JP as well as in Cambridge as a matter of fact. I started there right at the beginning with the opening. I created the beverage program there. I worked there a number of times as fill-in manager for wine dinners. I know the location well. My wife used to work at Craigie Street Bistro back in the day. I know that location as well. I would go there often.

My concept for the restaurant is really to keep it be much the same as Ten Tables had before, farm to table neighborhood restaurant, not doing anything fancy, I want to keep it cozy with a warm neighborhood feel. Something really simple.

ATTY KRISTEN SCANLON: I do have extra menus. I think we submitted one with the application, but if the Board would like to see it.

CHAIR NICOLE MURATI FERRER: I did see

the menu. I'm not sure if either of the chiefs want to see one.

So you have never been the manager on a liquor license, but you have worked in the industry?

STAN HILBERT: Yeah.

CHAIR NICOLE MURATI FERRER: I saw what you received. I must state for the record we received quite a number of letters recommending you personally to hold the liquor license which was interesting, including one from L'Espalier. Did you do a cheese Tuesday there?

STAN HILBERT: I did those back in the day.

CHAIR NICOLE MURATI FERRER: And you used to sing with the song?

STAN HILBERT: Yes. Played my guitar.

Those were the days.

CHAIR NICOLE MURATI FERRER: That's why I

said wait a minute.

STAN HILBERT: I used to bring my guitar then. That was a long time ago.

CHAIR NICOLE MURATI FERRER: Have you received a 21 Proof training?

STAN HILBERT: No.

CHAIR NICOLE MURATI FERRER: And are you familiar with the rules and regulations and laws with regard to sales and service of alcohol.

STAN HILBERT: Yes.

CHAIR NICOLE MURATI FERRER: Do you understand we expect you to stay up to date with those rules and regulations?

STAN HILBERT: Yes.

CHAIR NICOLE MURATI FERRER: Are you a Massachusetts resident?

STAN HILBERT: Yes.

CHAIR NICOLE MURATI FERRER: Are you a US citizen?

STAN HILBERT: Yes.

CHAIR NICOLE MURATI FERRER: Any

questions?

POLICE COMMISSIONER ROBERT HAAS:

Nothing.

ASSISTANT FIRE CHIEF GERARD MAHONEY:

Nothing.

CHAIR NICOLE MURATI FERRER: Anyone in favor of the petition?

Yes, ma'am, please come up.

KRISTA KRANYAK: Krista Kranyak,

K-R-I-S-T-A, K-R-A-N-Y-A-K, former owner of Ten
Tables in Cambridge, I sold the restaurant
because I am focusing just on the Jamaica Plain
area and expanding my burger bar.

Stan worked for me over eight years and I can't speak enough how great of a manager he is.

I highly recommend him and I'll miss him.

CHAIR NICOLE MURATI FERRER: Thank you.

Anyone else?

Yes, sir.

KENNETH TAYLOR: Questions and then comments.

Ken Taylor, K-E-N-N-E-T-H, T-A-Y-L-O-R.

The address is 2 Craigie Street and 23 Berklee

Street, which is across the street from the premises.

Your application is correct, by the way.

It's 2 Craigie -- there's a number on Craigie

Circle. Circle is correct. And it fronts on

Craigie Street.

In any case, the question I have is I'm not familiar with licensing laws, but when it says applying for an entertainment license to include an audio tape machine and CD, computerized digital media that can be played below conversation level, is there a limitation on the decibels that it can be played in a

license like this?

CHAIR NICOLE MURATI FERRER: The statute doesn't particularly state decibel levels. It just states whether it can be played below conversation level or above conversational level. But Mr. Hilberg can probably explain what kind of music he's trying to incorporate.

STAN HILBERT: Jazz music. Nothing crazy or extravagant. Obeisance really. I'm not trying to make this a bar atmosphere.

KEN TAYLOR: Not ^ fix music?

STAN HILBERT: No, no, no. That's not my type at all. It's more fine dining.

Like I said, jazz or maybe a little sole music, it's more of a background.

KENNETH TAYLOR: We have lived across the street from Craigie Street Bistro and Ten Tables the last ten years. And there haven't been any difficulties that I'm aware of relative to their

operation. It is -- they were not licensed, they did not have a license that you're asking for.

Occasionally people would come out late at night on their way and make a little more noise than you would like, but it that's tolerable and I'm not objecting to that.

I just would suggest that since it's a residential neighborhood, which has benefited from having a neighborhood restaurant for longer than the ten years I'm talking about, that we would welcome you. And I think the only question that I would have is that we would hope you would be good neighbors which your predecessors have been and the noise wouldn't -- I'm not sure what conversational level is because if you go into a New York restaurant it's lot higher than it is in most, and I would be feel more comfortable if anybody could put a decibel level on that.

CHAIR NICOLE MURATI FERRER: If you do

look at -- I apologize. I wasn't really understanding where you were getting to. If you look at the noise ordinance, the City of Cambridge noise ordinance, there's decibel levels there would have to be a measurement made and I think the way it says it, I don't have it in front of me, so I apologize. Do either of you know it off the top of your head?

EXECUTIVE DIRECTOR ELIZABETH LINT: I do.

CHAIR NICOLE MURATI FERRER: So there you go, she can tell you.

EXECUTIVE DIRECTOR ELIZABETH LINT: In this situation the music could not be plainly audible from 50 feet.

KENNETH TAYLOR: From?

EXECUTIVE DIRECTOR ELIZABETH LINT: 50

feet which is not very large a distance.

If you can hear it outside, it's too loud.

KENNETH TAYLOR: Okay. That would be tolerable. That would be acceptable. And is there -- will there be any operation of the restaurant outside of the dining room?

STAN HILBERT: No.

KENNETH TAYLOR: There will be people coming and going and that's what has been happening. Well, I mean, I would support your application.

STAN HILBERT: Thank you.

KENNETH TAYLOR: I haven't seen your menu yet. I would like to see your menu but you hopefully will see us visiting you when you open.

CHAIR NICOLE MURATI FERRER: Thank you very much.

Anyone else anyone in opposition to this petition?

Okay. Thank you. I would say we take it under advisement while we wait for the affidavit

and everything else before we vote on it.

ATTY KRISTEN SCANLON: Okay.

CHAIR NICOLE MURATI FERRER: Are you fine with that?

POLICE COMMISSIONER ROBERT HAAS: Yes.

ATTY KRISTEN SCANLON: Thank you.

DISCIPLINARY HEARING
SUNSET CAFE, INC D/B/A SUNSET CAFE

EXECUTIVE DIRECTOR ELIZABETH LINT:

Disciplinary Hearing held pursuant to G.L.C. 138,
§§ 23 and 64, and c. 140, §§ 9 and 185C as to
Sunset Café, Inc d/b/a Sunset Café for alleged
violations of: M.G.L. c. 138 §15A- Failure to
apply for and be approved for a Change of
Officers/Directors of a licensed corporation;
M.G.L. c. 138 §23 - Transfer of the privilege of
a license without approval; M.G.L. c. 138 §26 -
Operating without an approved manager and/or
changing manager without approval.

CHAIR NICOLE MURATI FERRER: Good evening.

ATTY COLIN SMITH: Good evening.

CHAIR NICOLE MURATI FERRER: Please state your name for the record.

ATTY COLIN SMITH: My name is Colin Smith, S-M-I-T-H.

CHAIR NICOLE MURATI FERRER: Mr. Smith, are you an attorney?

ATTY COLIN SMITH: I am.

CHAIR NICOLE MURATI FERRER: And you're here representing?

ATTY COLIN SMITH: I represent the corporation, and I also represent Irene Pereira, as she's is the personal representative of the estate of Fernando Castanheira and her mother who is the -- Mrs. Castanheira who is the heir to Fernando. So that sounds more complicated than it needs to be. Basically Fernando Castanheira

died in December of 2012. He was the manager as a matter of statute, as a matter of this Board's action. He also was the sole shareholder and the sole officer. His surviving brother has been running the premises on basically a day facto sort of basis.

And the several applications that have existed since then all have had the deceased name preprinted as the manager.

We have been going back and forth with David and his counsel for three years three months about this situation.

CHAIR NICOLE MURATI FERRER: I'm sorry

David being the brother?

ATTY COLIN SMITH: David being the brother who is day facto been operating the premises. And in November of this year, Irene Pereira reluctantly signed the application as personal representative, sole officer and sole

director. And I say reluctantly because she's not in control of the day-to-day operations, and doesn't really have any control of it.

CHAIR NICOLE MURATI FERRER: Has there been any change to Sunset Cafe, Inc?

ATTY COLIN SMITH: Beg your pardon?

CHAIR NICOLE MURATI FERRER: Has there been any change to Sunset Cafe, Inc?

ATTY COLIN SMITH: It's the same corporation. I submitted certified copies of the articles of organization. I submitted certified copies of, I believe, every single annual report that exists on the records of the Secretary of State. Since Fernando was deceased, I have submitted officer and director annual statements on behalf of Irene Pereira and submitted votes of both the shareholder and votes of the officer with the proposed application.

CHAIR NICOLE MURATI FERRER: So why

hasn't there been a change with regard to this?

I mean, I'm sorry that --

ATTY COLIN SMITH: Yeah.

CHAIR NICOLE MURATI FERRER: -- you know, that Mr. Castanheira passed away, but that happened in 2012, and you know our laws are our laws and this should have been done.

ATTY COLIN SMITH: I understand that. I can't speak really for David Castanheira or his counsel, Caroline Conway or his counsel, William Bare. I understood that David may have a CORI problem. There's a lot of correspondence from me saying "How are you coming on that problem? Do you have any solution?"

At this stage my clients have come to the determination they want to go into inactive status with the Board's permission and they want to sell the premises and whatever sale of the license is possible.

CHAIR NICOLE MURATI FERRER: I apologize because, quite frankly, I went through this file and I could not find it. Does the estate agreement say anything with regard to this license or this business?

ATTY COLIN SMITH: It's intestate.

There's no estate agreement. So everything went to the mother who is in her 80s who is not fluent in English and has never been in the liquor business. Okay.

ATTY COLIN SMITH: It's a Subchapter S.

At some point after two years, she signed a return and became, for IRS purposes, shareholder as opposed to the estate.

The real estate premises, not to get too complicated, but the real estate premises is held in the name of a trust which was set up by Carlos, David and Fernando in the 1990s. And it provides that upon the sale of -- I'm sorry --

upon the death of a beneficiary, the trust must be terminated.

So the real estate is going to vanish where the premises is, and frankly, the operation hasn't been one that's really economic, so it's one thing for two brothers who own the real estate and running the restaurant if they want to not pay themselves rent, that's fine. But it doesn't the work it's constituted now.

And from a liability standpoint, it doesn't work for these two people who are not in the liquor business, and it's a lot of liability and they're not in control. They don't know what the tax returns are. They don't have any background on them.

CHAIR NICOLE MURATI FERRER: I'm going to stop you because the more you say the words, you're making this case, quite frankly. To be frank, the cases like this particularly when

viewed by the ABCC licenses are suspended indefinitely until this is corrected and they can even be revoked. This is one of the biggest no-nos of liquor laws and stuff like that.

And seeing how this has been going on since 2012, and I understand that you're telling us now that you want to put it in inactive status and I get that, but, quite frankly, I don't know even if you come tomorrow with an application to transfer or sell this license. I mean, it seems like estate-wise there needs to be a lot of legwork to do that first.

So I mean --

ATTY COLIN SMITH: Well, you know, it's the -- the stock belongs to the people I represent.

CHAIR NICOLE MURATI FERRER: Uh-huh.

ATTY COLIN SMITH: And they have been silent partners, sort of hoping their brother,

son, would come in with a proposal that would be satisfactory to the Board. He has not done so and now they're on the application.

CHAIR NICOLE MURATI FERRER: What -- but they're not. This is the thing. This license is currently right now in the name of a deceased person. This license should not be active at this point. And there should have been a transfer to either the trustee of the estate or the estate or something so that this could continue, and then you can, for lack of a better term, clean up what has been going on family-wise.

ATTY COLIN SMITH: Well, the statute does suggest that in the case where somebody has passed away with some deference to the estate.

CHAIR NICOLE MURATI FERRER: Yes.

Absolutely. There should be deference, but this happened in 2012. I think deference has come and

gone.

ATTY COLIN SMITH: I frankly agree. And, frankly, we were trying to preserve the business for David. And, you know, the -- it has not been any secret that David -- sorry -- that Fernando was deceased.

CHAIR NICOLE MURATI FERRER: What would be the timeline for this to be resolved?

ATTY COLIN SMITH: Well, I did talk to Ralph Sacramone about this, and I talked to two people at the DOR. From the standpoint of technicalities, I think the biggest technicality right now is having enough of a deal of release or lien of certificate to satisfy the ABCC assuming that you were --

CHAIR NICOLE MURATI FERRER: We also have DOR issues?

ATTY COLIN SMITH: I don't believe -well, I don't know if there's any amount owed. I

doubt very much that there's any significant amount owed. It may be that there's a tax return that has not been filed as of last September. I have no reason to believe there's any amount owed, and if it was owed, it would be something like less \$5,000. So this is not a situation where there's some great tax lien that nobody has the money to pay.

CHAIR NICOLE MURATI FERRER: Okay. So, again, when do you expect -- what would be the timeline that you say this would be all dotted Is and crossed Ts?

ATTY COLIN SMITH: Well, I would think that if I could straighten something out with the DOR in a month to have that certificate, then I could say it was a complete application.

CHAIR NICOLE MURATI FERRER: Has the certificate been requested?

ATTY COLIN SMITH: Yes.

CHAIR NICOLE MURATI FERRER: When was it requested?

ATTY COLIN SMITH: Maybe a week ago. And I talked to Deborah Hess today and Ralph last week and faxed Deborah Hess last week. So I'm working on it, been working with the accountant for literally months to try to have tax returns filed and have enough material so my clients could sign them.

So this is not been -- you know, when we got this violation letter, we pretty much had this application in hand and filed within a few days after getting the violation letter.

This has been something I have been working on for three years, but especially working on the license part of it since November.

CHAIR NICOLE MURATI FERRER: Questions?

POLICE COMMISSIONER ROBERT HAAS: So is it unrealistic to expect this to be resolved in

the next six months?

ATTY COLIN SMITH: Yes.

POLICE COMMISSIONER ROBERT HAAS: It's unrealistic or realistic?

ATTY COLIN SMITH: I think it's realistic to resolve it.

POLICE COMMISSIONER ROBERT HAAS: In six months?

ATTY COLIN SMITH: You know, I, in fact, have an offer that was unsolicited. I think from the standpoint of having somebody that would like to purchase the real estate and the license as part of that, I don't think that's a hard thing to do.

POLICE COMMISSIONER ROBERT HAAS: Uh-huh.

ATTY COLIN SMITH: I would suppose there might be some problem in the Probate Court if I had an objection from David, but I think with the status of the license, if David doesn't have a

restaurant to operate, I think I can do things indirectly that maybe I couldn't do directly, so it's unlikely to be held up in Probate Court.

I have an action pending in Probate Court in equity which I filed in December of '14 in which David is a defendant. So, you know, my clients have been generous in time to their brother and son, but they have not been sitting on their hands and, you know, each year the Commission has preprinted another application with Christopher's name on it. I have been kind of holding my breath for David and giving David a chance to try to put something together and there's no other -- other than family ties, there's been no, you know, latchees or laziness on the part of my client. They're trying to deal with a situation that was not their making. And they're in this reluctantly. This is not where they want to be.

So, in other words, the delay here was for good motives, and there hasn't been anything, as far as I know, untoward happening at the premises in the interim.

ASSISTANT FIRE CHIEF GERARD MAHONEY: So is the restaurant still in operation?

ATTY COLIN SMITH: Oh, yes.

ASSISTANT FIRE CHIEF GERARD MAHONEY:

Yet the license is in the name of somebody that's been deceased for over three years?

ATTY COLIN SMITH: Correct.

ASSISTANT FIRE CHIEF GERARD MAHONEY:
That's a problem.

POLICE COMMISSIONER ROBERT HAAS: I remember there was a time, and I can't place the time frame when there was actually an ongoing dispute where the restaurant was closed, there was a dispute between who the owners were, and I just don't remember when that occurred. I

remember there was somehow we got involved in it and then we referred it back to the License Commission.

the brother-in-law had been on the license and there was fighting between the brother-in-law and the brothers so he --

POLICE COMMISSIONER ROBERT HAAS: They locked one of the owners out or people out.

EXECUTIVE DIRECTOR ELIZABETH LINT: Something like that.

ATTY COLIN SMITH: What happened was the stock was pledged to the brother-in-law. He sold it to somebody. He came to you and said, "Do a trust special order, we won't conserve it." He went to court, the parties settled it.

POLICE COMMISSIONER ROBERT HAAS: Okay.

ATTY COLIN SMITH: Basically --

POLICE COMMISSIONER ROBERT HAAS: Do you

remember when that occurred?
