Mass Ave, basement conference room.

Before you are Commissioners: Chief Gerald Reardon and Commissioner Chris Burke.

We're going to take one matter out of order.

#### APPLICATIONS:

PORTER SQUARE HOTEL, LLC
D/B/A PORTER SQUARE HOTEL

Application: Porter Square Hotel, LLC doing business as Porter Square Hotel has applied for a new garage license at 1924 Massachusetts

Avenue for 40 vehicles and 400 gallons of gasoline in the tanks of cars only.

ATTY KAREN SIMAO: Good afternoon,

Commissioners. Karen Simao of McDermott, Quilty

& Miller.

With me, I have representatives of the hotel.

This is the existing garage at the location. There is currently a temporary permit in place, but, of course, we want to make sure that we have a permanent one in compliance with the Board's rules and regulations.

There is no change proposed to this garage as it has been operating.

It is for 40 parking spaces, a couple of which are dedicated to hotel staff, the remainder

of which are for guests.

FIRE CHIEF GERALD REARDON: So, counselor, the -- so they had a TCO for the whole building, so they have the permanent CO right now?

ATTY KAREN SIMAO: Do you have the permanent certificate of occupancy?

KEVIN SHEEHAN: It's pending with the garden --

THE REPORTER: Sir, before you speak, you have to state your name and spell it.

KEVIN SHEEHAN: My name is Kevin Sheehan, K-E-V-I-N, S-H-E-E-H-A-N.

THE REPORTER: Thank you, Kevin.

KEVIN SHEEHAN: It's pending with the building of the garden in the back.

FIRE CHIEF GERALD REARDON: Okay. So this was already inspected by the Fire Department and approved under the TCO agreement. So now

you're looking to get your License Commission permits for the flammables for the garage?

ATTY KAREN SIMAO: That's correct.

FIRE CHIEF GERALD REARDON: There's nothing else in the garage other than the vehicles themselves? We're not licensing any flammables at this time?

ATTY KAREN SIMAO: Correct. There are, just for the record, six short-term bike racks and 11 long-term bike racks, but the bicycles no fuel.

FIRE CHIEF GERALD REARDON: Okay. I'm fine with this.

Any questions?

POLICE COMMISSIONER CHRISTOPHER BURKE:
No questions.

FIRE CHIEF GERALD REARDON: Anyone from the public wish to speak on this matter?

(No response.)

Seeing none, I would move to approve this license.

POLICE COMMISSIONER CHRISTOPHER BURKE: Approved.

FIRE CHIEF GERALD REARDON: It passes.

All set.

Thank you.

ATTY KAREN SIMAO: Thank you.

AAM INC D/B/A BEAUTY'S PIZZA

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: A.A.M., Incorporated doing business as Beauty's Pizza, holder of a common victualler wine and malt license at 228 Broadway has applied for a change of corporate name to A.M. American International, Incorporated, change of location to 187 Hampshire Street, and amendment to the premise description to be 1,250 square foot Italian pizza restaurant with takeout, dine-in, and delivery, one entrance and two exits.

FIRE CHIEF GERALD REARDON: Good evening.

For the record, would you state your name and spell it out, please, for the stenographer?

MICHAEL NADER: Nader, Michael.

THE REPORTER: First name?

MICHAEL NADER: N-A-D-E-R.

THE REPORTER: N-A-G-A...?

MICHAEL NADER: D-as in David-E-R --

THE REPORTER: N-A?

MICHAEL NADER: N-A-D-E-R. Michael,

M-I-C-H-A-E-L.

MONA NAKHLA: My name is Mona Nakhla.

M-O-N-A, last name is N-A-K-H-L-A.

THE REPORTER: Thank you.

FIRE CHIEF GERALD REARDON: Could you give us a description of this change of license and what's going on?

MICHAEL NADER: Okay. After we had beer and wine license for Beauty's Pizza, which was

located at 228 Broadway, after the fire, we had it for about two years. We had no problem at all. And after the fire, we waited, like, long time, for about three years, like, for the building to be remodeled, but landlord wouldn't renew our lease. So we had to seek another location which is 187 Hampshire Street. moved to Hampshire Street. Since we open mid -toward the end of August of this year, we start to talk to the customer, and they looking for beer and wine,, so we came to activate our license because the license department was very kind, hold our license for us for our circumstances for the fire we had. And we find out we have to do a hearing again to activate our license and we changed the name of the corporation. We feel like not very lucky with the old one, so we change to our new name.

FIRE CHIEF GERALD REARDON: So is all the

work done at the 187 Hampshire Street location?

MICHAEL NADER: Yes. Yeah.

FIRE CHIEF GERALD REARDON: And you are open?

MICHAEL NADER: We are open now. We there for like beginning of September we open for public and everything.

We didn't ask for it in the beginning

till like we get stable and we get all set, like,

to get familiar with the place and see the

customer -- kind of customer we get, and we find

that there's a need for it. So we --

FIRE CHIEF GERALD REARDON: How long was the license held by you at the previous location, beer and wine?

MICHAEL NADER: We had it for over three years at the old location, and we never had a problem with it. We never served like minors or...

FIRE CHIEF GERALD REARDON: So at the new location, there's no bar or specific area for drinking at all?

MICHAEL NADER: No, no. Can be served with, like, sit-down customer if they ask for a glass of wine or glass of beer or bottle of beer.

FIRE CHIEF GERALD REARDON: How many seats do you have in the new location?

MICHAEL NADER: Now about 25 seats.

Inside.

FIRE CHIEF GERALD REARDON: You have a permanent certificate of occupancy? You have a permanent certificate of occupancy for that location?

MICHAEL NADER: Yes, yes. We have a lease for four or five years in this location -- five and three options for three fives.

FIRE CHIEF GERALD REARDON: What are the hours of operation that you're looking for?

MICHAEL NADER: We not going to be serving or asking for anything past midnight.

The normal. We have our -- our operation now is like 6:00 in the morning, but we decide not to open in the morning.

We open for lunch and dinner, and we have our license to, like, 3:00 in the morning. We're not going to do anything past --

FIRE CHIEF GERALD REARDON: So what are you looking for, the alcohol service for --

MICHAEL NADER: 1:00 in the morning would be fine for us.

We usually now close at 11:00, but, if we need -- because we have just been there for like three months now. If we need to, we stay like 1:00, we will.

FIRE CHIEF GERALD REARDON: You really have to have some finite numbers on this. It can't be moving around. So if you say --

MICHAEL NADER: Average 1:00.

FIRE CHIEF GERALD REARDON: So if you say you're going to be open to 1:00, you have to be open to 1:00.

MICHAEL NADER: Yeah, to 1:00.

FIRE CHIEF GERALD REARDON: That's, what, seven days a week? Five days a week?

MICHAEL NADER: Weekends.

FIRE CHIEF GERALD REARDON: Weekends only?

MICHAEL NADER: Friday, Saturday, yeah, 1:00.

FIRE CHIEF GERALD REARDON: Friday and Saturday and Sunday you're looking -- for Friday and Saturday you're looking for 1:00?

MICHAEL NADER: 1:00, unless it's at least 12:00.

FIRE CHIEF GERALD REARDON: What about the rest, Monday through --

MICHAEL NADER: 12:00.

FIRE CHIEF GERALD REARDON: Excuse me,

Sunday through Thursday?

MICHAEL NADER: 12:00.

FIRE CHIEF GERALD REARDON: 12:00.

Did we have any issues with this licensee before?

EXECUTIVE DIRECTOR ELIZABETH LINT: We did not.

FIRE CHIEF GERALD REARDON: Everything is up to date on the paperwork?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

FIRE CHIEF GERALD REARDON: Any

questions?

POLICE COMMISSIONER CHRISTOPHER BURKE:

None.

FIRE CHIEF GERALD REARDON: Anyone wish to be heard on this item from the public?

(No response.)

Seeing none, I make a motion to

approve -- background and everything in order?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yes.

FIRE CHIEF GERALD REARDON: Okay. Make a motion to approve.

POLICE COMMISSIONER CHRISTOPHER BURKE: Second that motion.

FIRE CHIEF GERALD REARDON: Okay. All set. Thank you.

MICHAEL NADER: Thank you so much. Have a good holiday.

FIRE CHIEF GERALD REARDON: You, too.

IBD LIMITED D/B/A

DARWIN'S LTD

EXECUTIVE DIRECTOR ELIZABETH LINT:

Application: IBD Limited, doing business as

Darwin's Limited, holder of a common victualler

license at 313 Massachusetts Avenue has applied

for a new common victualler wine and malt

beverages with cordials/liqueurs license to be exercised at 313 Massachusetts Avenue with proposed hours of 6:30 a.m. to 9:00 p.m. Monday through Saturday and 7:00 a.m. to 9:00 p.m. on Sundays with seating for 76 inside, Steven

Darwin, as proposed manager of record, a premise described as: 1,245 square foot ground floor space with 62 seats, 235 square feet mezzanine with 14 seats.

ATTY JAMES RAFFERTY: Good afternoon.

FIRE CHIEF GERALD REARDON: Good afternoon.

For the record, name?

ATTY JAMES RAFFERTY: James Rafferty reporting, attorney, 675 Massachusetts Avenue, appearing this evening on -- afternoon on behalf of the applicant, IBD Limited, doing business as Darwin's.

Seated to my right is Steven Darwin, the

president and principal of the corporation and business. And to his right is Alexandra

Dinulescu, and Ms. Dinulescu is the proposed manager.

I'm sure the Commission's aware that --

FIRE CHIEF GERALD REARDON: Just for the record, Ms. Stenographer, do you have the correct spelling on that?

THE REPORTER: I do. He was so kind as to forward that. Thank you.

FIRE CHIEF GERALD REARDON: I just wanted to make sure.

ATTY JAMES RAFFERTY: I learned this weekend the benefits of being prepared. I was observing closely conditions in the city. I gave that to the stenographer.

So, Mr. Darwin, this is the third

Darwins, the wildly popular sandwich cafe located

on Mount Auburn Street, Cambridge Street opposite

the high school, and this third location for the past two-and-a-half years is 313 Mass Ave opposite the new building constructed by Forest City that's housing -- they now call themselves Takeda Oncology.

For the past two-and-a-half years,

Mr. Darwin has operated the third Darwins at this

location in a smaller space. And then about a

year ago, the Commission approved an expansion of

premises and allowed Mr. Darwin to expand into

the former university stationery store. They've

moved across the street into the new building at

300 Mass Ave.

So, Mr. Darwin went through an extensive renovation about four or five months ago, opened and expanded Darwin in that location. Now he has seating for 80, counter seating. And it's very popular. It's popular morning, noon and particularly into the evening.

And for a significant period of time, since he has been at this location, he has received requests about the opportunity to have beer and wine service, which is particularly sought after in the early evening where the light dinner business is.

So I advised Mr. Darwin that he should memorialize that demand in petition and he's collected in a short period of time approximately 280 signatures of people who regularly patronize the restaurant. And he is here today asking -- seeking to have a beer and wine license added to his existing common victualler license at that location.

As I said, Mr. Darwin has been a businessman and license holder in the city for, I'm going to guess, for close to 30 years?

STEVEN DARWIN: 23 years.

ATTY JAMES RAFFERTY: 23 years. The

first Darwins opened on Mount Auburn Street. On Mount Auburn Street he has a beer and wine package store license. This is a cafe setting and this would be a beer and wine pouring license, restaurant license as they are referred to.

Mr. Darwin is roughly familiar and in regular contact with other operators in the city. And he's particularly been in conversations with the operator here next door at Life Alive to see how they have been able to incorporate from an operational perspective a beer and wine into a setup like his where you come up and you order your food and you wait, and then you're given your food and you go to a table.

So, they are going to follow the same practice here and demonstrate proof of age at the time of purchase. Limitation of one purchase per individual.

So if there's requests for two glasses of wine, two individuals, two IDs will need to be produced.

It's clearly a supplement to the food.

We don't anticipate they'll have any business

beyond business related to people who are dining

or eating at the restaurant.

There is no bar. There's no change in capacity or hours of operation. It's just an opportunity to expand the offering to the public and satisfy the need for beer and wine.

There's increased commercial activity in this stretch of Mass Ave. The Forest City building is complete, the Novartis new campus added over a 1,000 new jobs a block from here.

So the population of that location, particularly the daytime population, is active and that population tends to stay beyond the traditional office hours of 9:00 to 5:00. So,

he's seeing an increase demand in the early evening between 6:00 and 8:00. And it's during that time he anticipates he would be able to most satisfy the demand for beer and wine with the food offerings.

FIRE CHIEF GERALD REARDON: Now, there's no outside seating at this location?

ATTY JAMES RAFFERTY: There's not.

FIRE CHIEF GERALD REARDON: Is there anticipation of outside seating?

STEVEN DARWIN: No.

FIRE CHIEF GERALD REARDON: Only because the handling of beer and wine leaving becomes -- it becomes a little more problematic.

STEVEN DARWIN: It wouldn't be feasible at that location.

ATTY JAMES RAFFERTY: The sidewalk isn't that generous in terms of --

FIRE CHIEF GERALD REARDON: I would tend

to agree.

incorporated here that -- you've seen it in a few places -- a mezzanine level where -- and it's supposed to be very popular. So it's in the restaurant space that's where they got additional space. They have at Felipe's and have it Crema Cafe, C-R-E-M-A, and a couple places in Harvard Square. Candidly, it was an inspiration for the approach here.

So they've combined the two storefronts, and it really is a very nice cafe with seating for 80. So it's not a dash-and-go place.

FIRE CHIEF GERALD REARDON: And just for the record, the access to the mezzanine is all interior to the building?

ATTY JAMES RAFFERTY: Yes. Correct.

Fully permitted and approved by the Building

Department at the time of construction.

FIRE CHIEF GERALD REARDON: So,
obviously, this is going to be your first pouring
license if approved?

STEVEN DARWIN: That is correct, yes.

FIRE CHIEF GERALD REARDON: So, you're aware of the requirements for 21 Proof training?

STEVEN DARWIN: Absolutely. I have been through that with my other beer and wine sale licenses at 148 Mount Auburn Street. All staff at this location will be professionally trained.

ATTY JAMES RAFFERTY: Ms. Dinulescu has worked in the restaurant business and has been an employee at Darwin for nearly two years now, almost since its opening at that location.

FIRE CHIEF GERALD REARDON: You will be the manager of record?

MONA NAKHLA: Yes.

FIRE CHIEF GERALD REARDON: Can you kind've give us some of your experience with

alcohol?

MONA NAKHLA: Sure.

So the past eight years I worked specifically in the service industry, different restaurants in this area, mostly in the Lowell area, where I'm from, and I did different restaurants, serving, hosting, things of that nature.

FIRE CHIEF GERALD REARDON: Have you ever had a license as a manager of record?

MONA NAKHLA: No. This will be the first time.

FIRE CHIEF GERALD REARDON: For the record, counsel, what is the number of seats here?

ATTY JAMES RAFFERTY: It's what is existing on the current CV. I'm just flipping through it.

STEVEN DARWIN: I think the current CV is

higher than the 80 that Ms. Lint stated. There might be a discrepancy there.

ATTY JAMES RAFFERTY: It's 76 seats with a 98-person occupancy.

STEVEN DARWIN: There we go, yep.

FIRE CHIEF GERALD REARDON: You're not -- at one point we have 76 and the other one, ground floor is 62, that is --

ATTY JAMES RAFFERTY: That's because of the mezzanine level.

FIRE CHIEF GERALD REARDON: But the total number of seats is?

ATTY JAMES RAFFERTY: 76.

FIRE CHIEF GERALD REARDON: 76, okay.

She's listed as manager of record?

EXECUTIVE DIRECTOR ELIZABETH LINT: In the paperwork she is.

FIRE CHIEF GERALD REARDON: Any questions?

POLICE COMMISSIONER CHRISTOPHER BURKE:

FIRE CHIEF GERALD REARDON: Anyone from the public wish to comment or speak on this license?

(No response.)

Seeing none, I make a motion to approve.

POLICE COMMISSIONER CHRISTOPHER BURKE: I second that motion.

FIRE CHIEF GERALD REARDON: With the proviso that all the employees meet the required training prior to issuance of the alcohol license, which will take some time from ABCC, and background checks are in order.

EXECUTIVE DIRECTOR ELIZABETH LINT: The ABCC does their own and I didn't have an opportunity to --

FIRE CHIEF GERALD REARDON: Okay. And assuming that the background checks and

everything is in order...?

POLICE COMMISSIONER CHRISTOPHER BURKE: I second that.

FIRE CHIEF GERALD REARDON: Okay, all set. Thank you very much.

PHILLIPE WR LUZ, INC

D/B/A ZOE'S

EXECUTIVE DIRECTOR ELIZABETH LINT:

Phillipe WR Luz, Inc, doing business as Zoe's, has applied for a common victualler license at 1105 Mass Ave with a seating capacity of 114 and proposed hours of 7:00 a.m. to 3:00 p.m. on Sundays and 7:00 a.m. to 9:00 p.m. Monday through Saturday. Rafael Daluz is the proposed manager of record. Premise is described as approximately 3282 square feet on one level, including dining, kitchen and storage areas.

FIRE CHIEF GERALD REARDON: Good afternoon.

ATTY EMMANUEL MEIMARIS: My name is Emmanuel Meimaris.

THE REPORTER: Spell your first and last name, counsel.

ATTY EMMANUEL MEIMARIS: E-M-M-A-N-U-E-L, last name M-E-I-M-A-R-I-S.

Rafael Daluz, R-A-F-A-E-L, D-A-L-U-Z.

THE REPORTER: Thank you.

ATTY EMMANUEL MEIMARIS: And we're here for WR Luz, Inc.

To the left of me is Mr. Rafael Daluz, he's the president of the newly formed corporation.

He, along with his uncle, are buying Zoe's at 1105 Mass Ave.

Both come from an extensive restaurant experience. His uncle has been working at Nick's Restaurant in Weymouth for the past 15 years or 20 years. Rafael has been working in the past

ten years. Rafael, you may know him at the Greek corner on Mass Ave in North Cambridge. His main focus is server, waiter and his uncle is the cook. They are both joining forces to open up their own establishment.

We have applied for the common victualler license, entertainment license and the beer and wine license, a transfer. They both have ServSafe certification.

We have obtained a letter of intent from the landlord regarding the lease. The proposed structure is such that the menu will stay the same. They are not going to make any changes to the menu.

Seating capacity, tables, all the same, except for the hours. I'm not sure what the current hours are, but Ms. Lint mentioned the proposed hours are 7:00 a.m. to 9:00 p.m. Monday through Saturday, 7:00 a.m. to 3:00 p.m. on

Sunday.

FIRE CHIEF GERALD REARDON: Who is the present occupant on that?

ATTY EMMANUEL MEIMARIS: Mykonos Fair, Inc. Theo Kallis is the owner.

FIRE CHIEF GERALD REARDON: In terms of the --

EXECUTIVE DIRECTOR ELIZABETH LINT: It's Zoe's.

FIRE CHIEF GERALD REARDON: Ms. Lint pointed out we don't have the request for alcohol licenses at this time. We have been looking for it, a CV license.

ATTY EMMANUEL MEIMARIS: I'm not familiar with the process. We did file it on-line and waiting for the next step.

EXECUTIVE DIRECTOR ELIZABETH LINT: I believe it's January 11.

FIRE CHIEF GERALD REARDON: It's not

scheduled for the particular hearing.

ATTY EMMANUEL MEIMARIS: I wanted you to be aware we did file.

FIRE CHIEF GERALD REARDON: In terms of the footprint you're doing, is it just cosmetic work in there, or are there any plans to change the layout or the equipment? Kitchen?

RAFAEL DALUZ: Everything will pretty much be the same, stay the same.

FIRE CHIEF GERALD REARDON: Are you having everything recertified and checked prior to -- before your inspections?

RAFAEL DALUZ: Yes.

FIRE CHIEF GERALD REARDON: Even though it exists, you will get an additional set of inspections. So just make sure that everything is current in terms of your hood cleaning, your fire extinguishers, your exit doors, anything of that nature, emergency lighting and stuff. You

will be responsible for that inspection when it comes due. So make sure you're ready for it.

RAFAEL DALUZ: All right.

FIRE CHIEF GERALD REARDON: Do you have an idea when you plan to open?

RAFAEL DALUZ: We talking about middle of December, so 15.

FIRE CHIEF GERALD REARDON: Of December?

FIRE CHIEF GERALD REARDON: Like eight days?

RAFAEL DALUZ: It depends, of course, on the process.

FIRE CHIEF GERALD REARDON: I'm just making sure we're on the right page.

Have you started doing any work in there as far as cleanup or certification at all?

RAFAEL DALUZ: I've been -- you mean like

being working there?

FIRE CHIEF GERALD REARDON: I mean, have you been -- in other words, before you get your inspections, you have to make sure that you can't assume everything is up to date from the previous owner.

RAFAEL DALUZ: I mean, we been negotiating this for the past couple months and we been there. We checked everything --

FIRE CHIEF GERALD REARDON: Okay.

RAFAEL DALUZ: -- the equipment and everything.

FIRE CHIEF GERALD REARDON: All right.

EXECUTIVE DIRECTOR ELIZABETH LINT: They just renewed, so they had to be inspected.

FIRE CHIEF GERALD REARDON: Any questions, Commissioner?

POLICE COMMISSIONER CHRISTOPHER BURKE: None, Chief.

FIRE CHIEF GERALD REARDON: Anyone from

the public wish to be heard on this matter?

(No response.)

So is this the correct hours of operation?

EXECUTIVE DIRECTOR ELIZABETH LINT:

That's what was in their application.

FIRE CHIEF GERALD REARDON: Good afternoon. For the record, state your name and spell it, please.

KEITH POOLER: Good afternoon. My name is Keith Pooler, K-E-I-T-H, P-O-O-L-E-R.

FIRE CHIEF GERALD REARDON: And you're --

KEITH POOLER: I'm a managing partner.

FIRE CHIEF GERALD REARDON: Managing partner?

KEITH POOLER: Yes.

FIRE CHIEF GERALD REARDON: So plead your case.

KEITH POOLER: In all honesty, we were in an arbitration with our contractor, and the contractor -- it went all the way to the beginning of this year, and the LLC was changed. That was the only thing that changed. Nothing -- the operating process and everything else never changed.

Still -- I'm still the predominate shareholder with my business partner.

FIRE CHIEF GERALD REARDON: The majority shareholder?

KEITH POOLER: Yeah, majority. We have equal share.

FIRE CHIEF GERALD REARDON: But you do have the majority?

KEITH POOLER: Well, no.

FIRE CHIEF GERALD REARDON: Then you're not the majority shareholder.

KEITH POOLER: No. I'm one of the two.

And operating-wise, we went through more arbitration, mediation, and all that and it's cost over \$100,000 in lawyer fees, and the only thing that came out of it was the contractor got 20 percent of the business. So that's how it changed. He's silent. He's non-existent.

I would assume my lawyers would have told me to reapply and make everything right, but they never said anything. They never mentioned anything. I would assume they would have done it with a price tag of over \$100,000.

I apologize for taking your time with this, but I didn't know. I would have dotted my Ts and crossed my Is.

Right now, to be truthful, all I do is work for my lawyer. And we had to spend an additional \$50,000, \$60,000 just to get the space up to compliance with the city after the fact, so...

FIRE CHIEF GERALD REARDON: How long was this in -- out of compliance?

really don't know. When we got the renewals, when Nicole was reviewing them, it became apparent that a change had been made that had never been brought before us.

KEITH POOLER: In all honesty, it was probably the beginning of this year that changed.

FIRE CHIEF GERALD REARDON: So it's obviously subsequent to your previous inspection or that location would have been December of 2015?

KEITH POOLER: Yeah.

FIRE CHIEF GERALD REARDON: It just was caught now in December of 2016.

KEITH POOLER: Right. It probably happened anywhere March, April -- is when arbitration -- arbitration happened and we didn't

So, as you mentioned, we applied and were approved for our CV, we got all of our certificate of inspection, our fire sign-off, our health, our CO, but we just failed the oversight.

Let me come down and pay the \$65 and pick up the actual CV.

That manager at the time is no longer with us as well, and so I think things slipped through the cracks.

But we do have all of our paperwork and we're approved for it, we just never came down and paid for it and picked it up.

what we'll need is updated information of who the contact is because we have emails and we send out renewal paperwork and letters and everything else, and we need to know who to send it to.

SAMANTHA STEPHEN: Absolutely. So we would be prepared to do that with the new manager contact information, pay the fees, and pick up our CV.

FIRE CHIEF GERALD REARDON: And during the past year, we have had no issues --

EXECUTIVE DIRECTOR ELIZABETH LINT: No.

FIRE CHIEF GERALD REARDON: -- with this licensee?

EXECUTIVE DIRECTOR ELIZABETH LINT: No. Other than they don't have a license.

FIRE CHIEF GERALD REARDON: So this is a straight violation, or a failure to remove, or both? This is not just a renewal, right?

EXECUTIVE DIRECTOR ELIZABETH LINT: Well, the hearing notice was for operating without being licensed.

FIRE CHIEF GERALD REARDON: Okay.

EXECUTIVE DIRECTOR ELIZABETH LINT: If we don't get renewal paperwork, that would be the next thing.

FIRE CHIEF GERALD REARDON: Okay. So you're prepared to do this in a very short time?

SAMANTHA STEPHEN: Tomorrow. Whenever. Absolutely.

EXECUTIVE DIRECTOR ELIZABETH LINT: Tomorrow is good.

FIRE CHIEF GERALD REARDON: And you'll provide the information.

I would be inclined to approve this

renewal, and issue a letter of warning for not following the rules and regulations as prescribed by the License Commission.

SAMANTHA STEPHEN: I understand.

POLICE COMMISSIONER CHRISTOPHER BURKE: I would agree with you.

FIRE CHIEF GERALD REARDON: Approved.

Anyone wish to be heard on this license?

(No response.)

Hearing none, we'll approve the renewal.

Application: Bennett Street Eatery, LLC doing business as Les Sablons has applied to transfer the common victualler all alcohol license held by Conductors Restaurant, LLC at 112 Mount Auburn Street/2 Bennett Street with hours of 11:30 a.m. to 1:00 a.m. Monday through Wednesday, 11:30 a.m. to 2:00 a.m. Thursday through Friday, and 10:00 a.m. to 2:00 a.m. on Saturday and 10:00 a.m. to 1:00 a.m. on Sunday with seating for 139. John Phillip Shorey Gregory as proposed manager of a premise described as: Restaurant consisting of 8,030 square feet dining area and bar on the first floor with additional dining area and bar on the second floor. Storage in basement. application has also been filed for an entertainment license to include CD/computerized digital media playing music at or above conversation level.

So this one there had been a significant amount of outstanding fees. They have all been paid.

FIRE CHIEF GERALD REARDON: For the record again?

ATTY JAMES RAFFERTY: James Rafferty on behalf of the applicant. The license was inactive and Ms. Lint is correct. So the 2015 fee is -- 2016 fee had not been paid. And that was unknown to the applicant, and obviously, unknown to the licensee. When we arrived at the hearing two weeks ago, that was discovered.

Those payments have since been made as well as the renewal payment for 2017. That was done within a few days of learning of the failure to make payment.

FIRE CHIEF GERALD REARDON: This is the new space that was developed?

ATTY JAMES RAFFERTY: Yes. This is the

former Conductor's Building. This is the restored historic building on the other side of the busway that --

FIRE CHIEF GERALD REARDON: The former MBTA Bennett Street car barn?

ATTY JAMES RAFFERTY: Right. They technically called it the Conductor's Building. It was built to be an area of rest for the conductors when the Boston elevated train was created and horses were used in that location, but it's been abandoned. The T has been working out of a trailer at that site for 20 years. part of the agreement that the new owner made, Mr. Friedman, to gain approval from the Historical Commission, to take down the former Cronin's and Chili's site where they built a new office building, they were required to restore this building.

So if you've had an opportunity to see

it, they have carefully restored, using, you know, skilled masons, the entire facade of the building. It's an exceptionally narrow building. We had the public hearing two weeks. The dimension, I think, is about 15 feet. It's going to be an oyster centric restaurant.

And, as we said, we discovered at the hearing the decision was to defer action until the issue of the fees were addressed.

There were no -- there were no public comments. There was no issue. This is a transfer of --

FIRE CHIEF GERALD REARDON: Was there an allowance made for the MBTA to go back into one of these structures as part of the agreement?

ATTY JAMES RAFFERTY: No. The MBTA has a room in the new building. So they are not going to be in this structure. But under the terms of the --

FIRE CHIEF GERALD REARDON: The former Chili's location, Cronin's location.

ATTY JAMES RAFFERTY: Which is now an office building, and Harvard is the principal and perhaps the only tenant, but there's ground floor space set aside in that building that now will serve that function.

It's all part of an acquisition agreement with the owner and the MBTA because the new structure -- I'm sure the Chief knows -- sits atop the electrical generator for the Red Line that's in the back of the building on Bennett Street. It used to be exposed, and now it's encased in the building.

So the T has easements and rights on the site related to that, plus this new waiting room, if you will -- I don't know what the right term is for it.

FIRE CHIEF GERALD REARDON: So everything

is up to date and paid for, correct?

EXECUTIVE DIRECTOR ELIZABETH LINT: Yep.

FIRE CHIEF GERALD REARDON: Do we need to approve this when it's already been approved?

EXECUTIVE DIRECTOR ELIZABETH LINT: It basically has been approved.

ATTY JAMES RAFFERTY: Well, I don't think
-- was it approved? I guess it was approved, but
not final.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Right. Subject to -- for the fees.

FIRE CHIEF GERALD REARDON: All the hours of operation and everything are correct as listed?

ATTY. JAMES RAFFERTY: Yes, they are.

So why does the application say 7:00 a.m. if it's 10:00 a.m.? Shouldn't it be 10:00 a.m.?

EXECUTIVE DIRECTOR ELIZABETH LINT: He may want to open at 7:00.

ATTY JAMES RAFFERTY: Well, like many -- it's in the retail store, so the store itself is open.

EXECUTIVE DIRECTOR ELIZABETH LINT: The store can be open, but he can't sell alcohol.

ATTY JAMES RAFFERTY: Agreed. So I wonder --

ATTY JAMES RAFFERTY: I think, to be candid, he did this and then told me about it.

I think that the Sunday hours need to be 10:00 a.m.

I don't know why he would have filed them at 7:00.

I think he might have thought that he needed -- because he wanted to open the store earlier, he needed to do that, but this would be like other stores, that the store will be open, but the alcohol sales won't commence, so they need to be --

FIRE CHIEF GERALD REARDON: So Sunday should be --

ATTY JAMES RAFFERTY: 10:00 a.m.

FIRE CHIEF GERALD REARDON: 10:00 a.m.

ATTY JAMES RAFFERTY: That's the change.

FIRE CHIEF GERALD REARDON: Till 8:00

p.m.?

ATTY JAMES RAFFERTY: No. 10:00 p.m.

EXECUTIVE DIRECTOR ELIZABETH LINT:

Sunday he says until 8:00 p.m.

ATTY JAMES RAFFERTY: Oh, I'm sorry.

Yeah. 10:00 p.m. on Saturday, Monday through Saturday.

FIRE CHIEF GERALD REARDON: 8:00 p.m. on Sunday, right? We're talking -- so Sunday it's 8:00 a.m. to 8:00 p.m.?

ATTY JAMES RAFFERTY: Sunday is 10:00 a.m. to 8:00 p.m.

then Monday through Saturday would have to be 8:00 as well, not 7:00.

ATTY JAMES RAFFERTY: That's right.

FIRE CHIEF GERALD REARDON: 8:00 or 9:00?

ATTY JAMES RAFFERTY: 8:00.

FIRE CHIEF GERALD REARDON: 8:00 till --

ATTY JAMES RAFFERTY: 10:00.

EXECUTIVE DIRECTOR ELIZABETH LINT: On Sunday.

ATTY JAMES RAFFERTY: I think he found that most of the grocery stores that sold beer and wine were selling at 8:00 in the morning, so customers who on Saturday morning are in shopping when he opens at 7:00, so he would like to be able to -- like to sell at 8:00.

ATTY JAMES RAFFERTY: Yes. The package store.

FIRE CHIEF GERALD REARDON: The only other question on it is, most of the areas in Central Square and -- where are the areas for

9:00 a.m.? Central Square and Cambridgeport?

EXECUTIVE DIRECTOR ELIZABETH LINT: By statute, they are allowed to be open at 8:00 a.m.

They were given 9:00 a.m. by agreement with the Commission. Since the new chair has been here, several of the package stores have come in to amend their hours and she --

FIRE CHIEF GERALD REARDON: We have had not any real issues on that section at all?

EXECUTIVE DIRECTOR ELIZABETH LINT: Not at all.

FIRE CHIEF GERALD REARDON: And we already have a couple others that opened at 8:00.

ATTY JAMES RAFFERTY: And that was
largely a package store issue and there were
certain areas in the city that have been
