1. Housekeeping

Minutes from January 2022 meeting approved, no amendments.

- Mike announced that Ilana Bebchick has resigned from the committee.
- March meeting will take place on the 16th, not the 9th.

2. City Updates

- Zero Waste Master Plan (ZWMP) Update
 - Cambridge started the process in 2017, working with consultants and collecting community input and feedback, and has been implementing since 2019.
 - Trash reduction goals (based on 2008 data) 30% by 2020, 50% by 2030, 80% reduction by 2050.
 - ZWMP Recommendations met to date: Small Business Recycling Program, Mattress Recycling, Curbside Compost (now eligible to all large buildings on City trash collection program), Small Business Compost Pilot, Textiles Recovery Program
 - Trash specifics In 2008 was 22.8 lbs/household/wk; City met the first goal by 2020 (16lbs/hh/wk). The amount started to climbed again in 2020 as people spent more time at home during the pandemic. If that trend continues, may need to rethink the trash reduction goals.
 - Waste disposal costs for 2021 trash was highest at \$109/ton, followed by compost at \$64/ton, and recycling at \$50/ton
- Next on horizon for ZWMP
 - New Waste Audit in spring (will contract with professional company paid for by grant)
 - o Increase outreach on recycling, compost, and textile programs
 - o Plan for state ban on textiles (begins November 2022)
 - Potential solid waste surveys to residents in spring 2022 based upon previous subcommittee's survey
 - Explore expanding the Small Business Compost Pilot as well as curbside compost collection for large buildings not on City trash collection (some small businesses have found it challenging - not enough employees, not enough organics, etc.)
 - Consider reconfiguring the Recycle Center

- Upcoming release of Circular Cambridge study. How might the DPW assist in that work (good opportunity for interdepartmental action).
- Discussion following the ZWMP presentation
 - City does not currently address issue/requirement of new developments setting up space/system for expanding into organics/compost collection
 - Could there be financial incentives for small businesses to compost? (perhaps go from 3 to 2 trash pickups/wk and then get free composting, for example?)
 - Holden talked about economic strategies for businesses that can reduce costs by diverting trash, giving an example of how Flour Bakery shifted to organics collection and significantly reduced trash pickups
 - Sakiko asked what RAC members can do to support composting in large buildings; Mike talked about a survey to find out more about what people are thinking
 - Mike mentioned that the DPW recently hired a new solid waste program manager, Camilla Elvis. Camilla will be heading up the trash program (new barrels) rollout then moving on to other related projects. There are now 3 solid waste program managers and 2 compliance officers.
 - o In terms of the waste stream, textiles are currently the most lucrative
 - How to encourage more small business composting it's tricky. The City can't favor any particular businesses, so ideas such as giving businesses who participate a shout-out or window stickers, for example, won't work. It was suggested that a self-promotion tool kit might work well.

3. Sub-committee Short Reports and Breakouts

- Communications Chair: Sakiko
 - o Goal is to promote food scraps collection, i.e. educate residents
 - Each month, February to June, has goal in that direction, such as collecting info, figuring out how to distribute it, etc.
- Food Waste Chair: Catrina Damrell
 - Food Waste Reduction continues looking for ways to collaborate with the Communication subcommittee.
 - Planning for food outreach sessions; want to design a sandwich board to support those sessions
 - Looking to create a metric for emissions reduction linked to composting
 - Defining goals for example, how many compost bins to distribute per year?
 - Thinking of audience for next round: off-campus graduate students, high school students, non-English speaking residents (people suggested expanding to include at least middle school students
- Textiles Chair: Leah Beckett
 - Group has been reading articles and reporting back to develop information piece to be included in next newsletter.


Zero Waste Update to RAC

Zero Waste Master Plan

- Process to develop a ZWMP started in 2017.
- Final ZWMP completed in early 2019
- While completing the ZWMP, DPW began implementing some programs, such as the citywide curbside compost program



Zero Waste Master Plan Goals


- Goal: Provide mechanism for achieving the City's trash reduction goals.
- Trash reduction goals (2008 as a baseline):
 - 30% reduction by 2020
 - 50% reduction by 2030
 - 80% reduction by 2050



Zero Waste Master Plan Recommendations Completed

Recommendation	Timing	Status Update
Begin Small Business Recycle Program	Fall 2018	Complete; 123 businesses receive free service
Start Mattress Recycling	Spring 2019	Complete; >400 tons diverted from trash
Improve Recycling through increased diversion and decreased contamination	Ongoing	Ongoing; Goal of reducing contamination rate to 5% was accomplished in 2019
Make Curbside Compost eligible to all large buildings on the City trash collection program	Fall 2019	Complete & Ongoing
Expand Small Business Recycle Program	Fall 2020	Complete; 200 businesses receive free service
Start Small Business Compost Pilot	Fall 2021	Complete; 64 businesses receive free service
Start Textiles recovery & recycling program	Fall 2021	Complete; service began 12/7/21
Continue to support Reduce/Reuse activities in the community	Ongoing	Ongoing process to determine ways to support reduce & reuse

Cambridge Residential Trash




Goals:

- Explore Expanding curbside compost program to all buildings NOT on the City trash collection program in 2023
- Consider reconfiguring Recycle Center
- Upcoming release of Circular Cambridge study and how DPW may assist
