- Although we have students involved, is it true decision-making, advisory, performative, tokenism?
 Where is youth voice missing>
- We have lots of services, but do we know if they are the right ones or enough?
- How do we reach the missing?
- Parks and playgrounds are geared towards younger kids, not as mich as you grow older
- Inaccessible streets
- Lots of construction happening so streets aren't really safe
- More street lights
- Opportunities exist, but children's participation needs to increase and youth voices need to be heard

- General cost more common for youth to have to work. Youth help themselves
- Mental health supports

- Adults talking at kids
- Only some people know how to advocate for social services
- Community Engagement Team goes through parents not directly to young people
- Parks and playgrounds not equitable distributed
- Events aren't always marketed or accessible
- Gallery Walk What did you notice? What questions do you have?
 - A lot of repetition, similarities between different groups' posters.
 - Lots of opportunities, but barriers to accessing them still prevalent
 - When children brought paper flyers home, they would get more excited about things.
 - Grows section housing issues appeared in lots of peoples posters. We are helping families with services while they're here, but we aren't retaining them as they grow because they can't afford to stay here.
 - Not a lot of actual space for high schoolers, while other age groups seem to have more opportunities

- Why aren't people spending time in the streets/outside? That's where they
 used to spend most of their time.
- CFCI examples and benefits
 - Question where is Salem in the process? They are just starting.
- Small Group Activity Should we pursue CFCI? Does it meet our criteria for selecting a Family Policy Council focus area?
- Criteria includes:
 - Advances Equity Address racism and inequities in Cambridge.
 - Is Realistic Can be achieved with the time, resources, and capacity we have.
 - Has Strong Support Has commitment and backing from leaders, partners, and the people doing the work.
 - Focused on Prevention Meet the needs of children, teens, and families in ways that are preventative rather than reactive.
 - Improves Systems Strengthen or coordinate systems across the community, rather than create new stand-alone programs.
 - Needs Collective Effort" Tackle issues that no single organization can solve alone (like Find It Cambridge and Language Justice).
 - Builds on What Exists Align with and support current efforts instead of duplicating them.
 - Includes Accountability Have clear ways to measure progress and success.
 - Allows for Flexibility Are things we're willing to stop or adjust if they're not working

Discussion

- Focus on gaps, don't create something entirely new, aligned with FPC criteria to build off of what exists.
- Did other cities mention anything about children expressing themselves through the arts?
 - Not specifically, but it comes up in Cambridge where we have lots of arts organizations, but they aren't necessarily accessible to everyone.
- Need to improve student involvement.
- Feels like Cambridge is already attempting many of the things that other cities are working on (and that we could highlight/improve).
- Could be an opportunity to highlight things that get overlooked.
- Could be an opportunity to create a shared vision.
- Seems like today's "Cambridge" and especially youth feel more isolated.
- Why are we not taking action right now?

- Point of concern (not dissent) UNICEF could bring lots of support and clout, but we'd still be reaching out to the same groups. In order to work with UNICEF, shouldn't we close some of the gaps first? Wouldn't this set us up for success better?
- Not just a rubber stamp, needs to be truly beneficial to youth and youth led.
- Could serve as a unifying force. Would encourage more communication between groups that want to make this happen.
- Vote Motion that the Family Policy Council pursue the UNICEF Child Friendly City Initiative - Unanimous
