Public Testimony Matters

Matters may have been called in a different order than that listed on the agenda. In addition, some matters may have required a second call.

1. Application #45656 Shake Shack Harvard Square Boston, LLC d/b/a Shake Shack, Common Victualler All Alcohol License #11893, for a Change of Manager to William Hofrichter. [Time Stamp: 1:45]

Present: Attorney Joe Devlin and William Hofrichter, applicant.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Hofrichter is the manager of record at the seaport location and has been with Shake Shack for two years. Mr. Devlin explained that the submitted manager affidavit is incorrect in that Mr. Hofrichter will remain manager at the seaport location. He explained the structure of Shake Shack is to have top tier managers with multiple managers underneath who are all trained. The manager of record typically has two locations close in space, with general managers and assistant general managers under him.

Decision: Granted pending submission of amended affidavit in accordance with representations made at the hearing. Manager of record must submit proof of TIPS or 21 Proof Certification.

2. Application #31871 Verizon, Inc.'s request to extend/amend Special Noise Variance at 10 Ware Street, to test the generator on June 12, 2019, July 10, 2019, and July 23, 2019, per FCC regulation. Also, to test while implementing sound attenuation baffling to be in compliance with Cambridge Municipal Code (CMC) 8.16.060(E). [Time Stamp: 6:40]

Present: For Verizon - Attorney Johanna Schneider, Stan Usovicz, Government Relations, John DeMent, Facilities Engineering and Construction; and Chief Licensing Investigator Andrea Boyer.

Documents Considered: Application and documents attached thereto.

Summary: Verizon has complied with all conditions put in place at the original hearing. Verizon is seeking to extend date for completion as there have been delays with ordering and installation of materials and limited hours of construction from 8:00 a.m. to 4:00 p.m. to mitigate interruption to the neighborhood. They are close to completion and would like two more test runs on July 10 and 23, subject to the same conditions. The July 10, 2019 would be the test required by the FCC. The one on the 23rd would be the final test run for the attenuation. When the test run was done this morning, the turnover mechanism did not function as expected. This should be fixed by July 10. There may need to be another test run prior to July 10. The delay had to do with coordination between manufacturer, vendor and engineering. There were adjustments that had to be made, approved by engineering and then go through the permitting process.

Decision: Special Noise Variance extended through 7/31/19 with the same conditions regarding updates and communication with the residents and Chief Boyer. Testing can be performed at 10:00 a.m. on 7/10/19 and 7/23/19. An additional test may occur during the variance period provided reasonable notification is given to the residents and Chief Boyer and the time of that test should also be 10:00 a.m. (or a time that is agreeable to the residents and Chief Boyer). The matter will be scheduled for a noise violation hearing the first available meeting in August (and if there is a request to extend the variance, it will be heard simultaneously with the violation hearing).

3. Application Amin Yasmine, for a new Cambridge Hackney Driver's License [Time Stamp: 14:45]

Present: Amin Yasmine, applicant; and Officer Benny Szeto.

Documents Considered: Application and documents attached thereto.

Summary: Mr. Yasmine wants to obtain a license to assist his father. His father purchased a medallion and put it in his son's name. Per City Ordinance, medallion owners must have a hackney license regardless of whether they drive the vehicle.

Decision: Granted.

4. Application #47687 Dig Inn Harvard Square, LLC d/b/a Dig Inn, 82 Mount Auburn Street, has applied for a new Common Victualler All Alcoholic Beverages License. The proposed hours of operation are 11:00 a.m. to 11:00 p.m. all days with seating for 49, and an occupancy of 99. Rajesh Pancholi as Proposed Manager of Record of a premise described as: Restaurant containing approximately 1,700 sq. ft., located on ground floor, with kitchen, storage, two dining areas, and one exit and one entrance. Additional 1,100 sq. ft. of storage located in basement. [Time Stamp: 17:33]

Present: Attorney James Rafferty, Rajesh Pancholi, applicant and Samuel Gruber, member of the LLC. Xavier Dietrich, member of the public. Attorney Kim Courtney, as member of the public.

Documents Considered: Application and documents attached thereto; and menus.

Summary: The applicants obtained a zoning variance to open a restaurant in this location as this stretch of Mt. Auburn Street is a residential zone. Dig Inn has four locations in Boston. The company has approximately 28 locations in New York. The alcohol is meant to be a compliment to the food which is meant to be prepared from local and organic products. There is no restaurant in the area similar in offerings or nature. The restaurant will serve food until 11:00 p.m. It is a healthy type of dining that is patronized by younger customers due to the price point. Mr. Pancholi has significant experience in the restaurant industry and has been a manager of record in the past. He has been with the company since 2016. The variance hearing determined this is not a fast food establishment. There are many investors in the company with minimal interests for which a waiver of disclosure was requested. Xavier Dietrich questioned whether a public need for the license was established. Attorney Courtney questioned validity of the application and whether a public need was shown.

Decision: Granted, including the waiver of disclosure. Manager of record must submit proof of TIPS or 21 Proof Certification.

5. Application #43580 Tomiko, Inc., d/b/a Café Sushi, 1105 Massachusetts Avenue, has applied for a new Wine & Malt Package Store License. Sheize Imura as proposed Manager of Record of a premise described as: Approximately 325 square feet of space on the first floor with one entrance/exit. [Time Stamp: 30:50]

Present: Attorney David Lipshutz and Sheizi Imura, chef/manager. Xavier Dietrich, member of the public.

Documents Considered: Application and documents attached thereto; and documents provided at the hearing.

Summary: This application relates to the prior application for an alteration of premise. As takeout is being separated from the restaurant business, it makes sense to add sake to the space as an amenity for the area. The 325 sq. ft. removed from the premise will make up the entire take out/package store area. A door was added to separate the space. The intent is to give a similar experience to takeout customers as that given to dine in customers. The sake sold would be varied and not readily available in the area and ranging in price. The space is going to be reconfigured to ensure that the sake is available to the public regardless of whether they purchase food from the location. There may be some obscure Japanese beers as well. Mr. Imura gave a detailed explanation of the different types and grades of sake. He further explained why the concept presented was different and would provide a need that is not currently served by any other package store in the area, including surrounding cities and towns. Xavier Dietrich questioned whether a public need for the license was established.

Decision: Granted with the condition that the license will not issue without the Board's prior approval of the floor plan showing the specific layout of the location and any material available to show that the licensee is making it clear to the public that the alcohol may be purchased without the purchase of food. Manager of record must provide proof of TIPS or 21 Proof Certification.
