At this public meeting, DCR will present an update on a project to provide improved pedestrian and bicycle access between the Charles River Reservation and adjacent residential neighborhoods at crossings on Soldiers Field Road at Telford Street and Everett Street in Allston. DCR, along with the project team, will present and solicit public comments on design concepts for at-grade crossings at the two locations. The City is developing an Urban Forest Master Plan (UFMP) that will guide the development of the urban forest into the future. The UFMP will include a strategic plan to evaluate, maintain and expand the urban forest canopy enabling it to be more resilient to climate change, reduce the urban heat island effect, mitigate stormwater runoff, reduce nutrient runoff, and contribute to the community well-being. The UFMP will coordinate with the efforts of the citywide comprehensive plan (Envision Cambridge) and the Climate Change Preparedness & Resilience Plan. At this meeting, The consultant team will present a summary of the soils testing results and discuss correlations between soils conditions and tree health. The team will also discuss current climate modeling efforts and also present an initial set of potential strategies to decrease canopy loss and increase canopy cover. More information.



NEW South Massachusetts Avenue Corridor Safety Improvements Project Update

Installation of the <u>South Mass</u>. Avenue <u>Corridor Safety Improvements project</u> continues; the bus lane and separated bicycle lane markings are in! (See photo below.) Signal changes are underway, and the installation of green and other final markings will continue as long as weather permits; pavement markings will not stick if pavement is too cold or wet, but temperatures are expected rise a bit into the weekend. Flex post installation will also begin soon. All elements planned for this fall are scheduled to be completed by the end of next week (weather dependent). Changes will be monitored and adjustments made as needed. NEW Kittie Knox Bike Path Project Update (Sixth Street Bike Path)

The new Sixth Street Bike Path, officially the <u>Kittie Knox Bike Path</u> was opened on Friday, November 2 (photo below). The bike path located along the Sixth Street Walkway (Officer Loughrey Walkway) was a new addition of the Sixth Street Connector Improvement Project. In addition to the new dedicated bike path, other improvements to the Sixth Street Walkway include upgraded benches and picnic tables, new LED lighting, and fixtures, improved draining and concrete along the walkway and enhanced landscaping. The official dedication ceremony for the Kittie Knox Bike Path will be held in the Spring of 2019. The section of Ames Street that will complement the new path is currently under construction and should be completed in the coming weeks.

NEW Study finds improving bike, pedestrian infrastructure cuts driving, CO2 emissions – State Smart Transportation Initiative, November 12, 2018

According to a new study from New Zealand, investing in bike and pedestrian infrastructure reduces driving-related CO2 emissions. The authors found that systematic improvements to walking and biking networks in two New Zealand cities led to a 30 percent increase in active travel, which in turn reduced distance traveled per vehicle by 1 percent and CO2 emissions by 1.6 percent.
