Harvard Law School proposes to install a shed louver dormer at Austin Hall. It is to be located on the building's north side, the least visible and less significant of the building faces, and will face the rear chimney. The proposed dormer will have a low sloped roof to reduce its profile and will be copper clad, so as to eventually match the roof flashings.

This dormer has been designed to accommodate a 12 square feet louver in order to meet the minimum ASHRAE standards for HVAC mechanical equipment to provide building ventilation. The former smaller exhaust in this location was previously closed and therefore cannot be used, and other existing roof vents on the building are already functioning at maximum capacity.

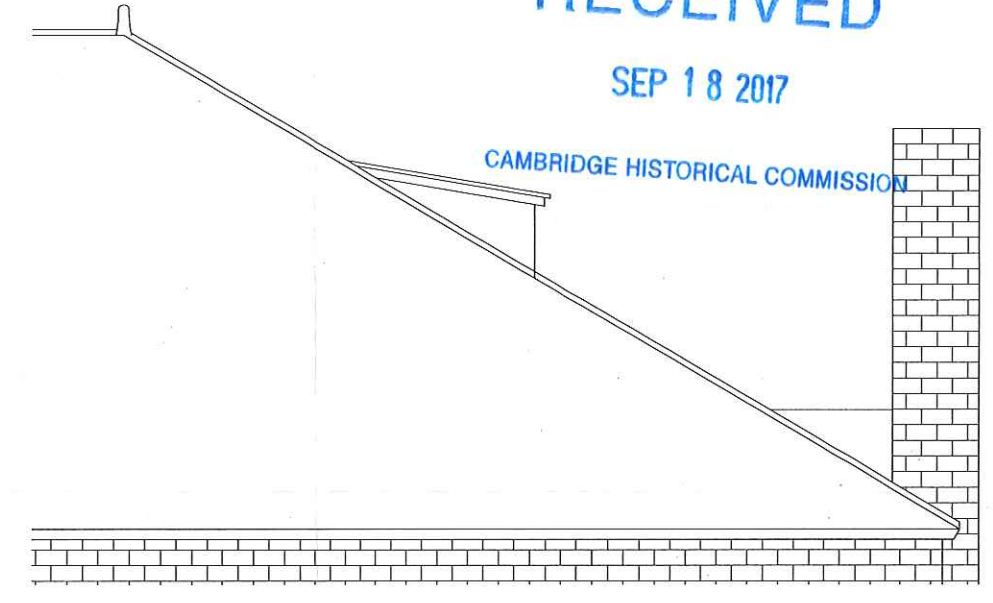

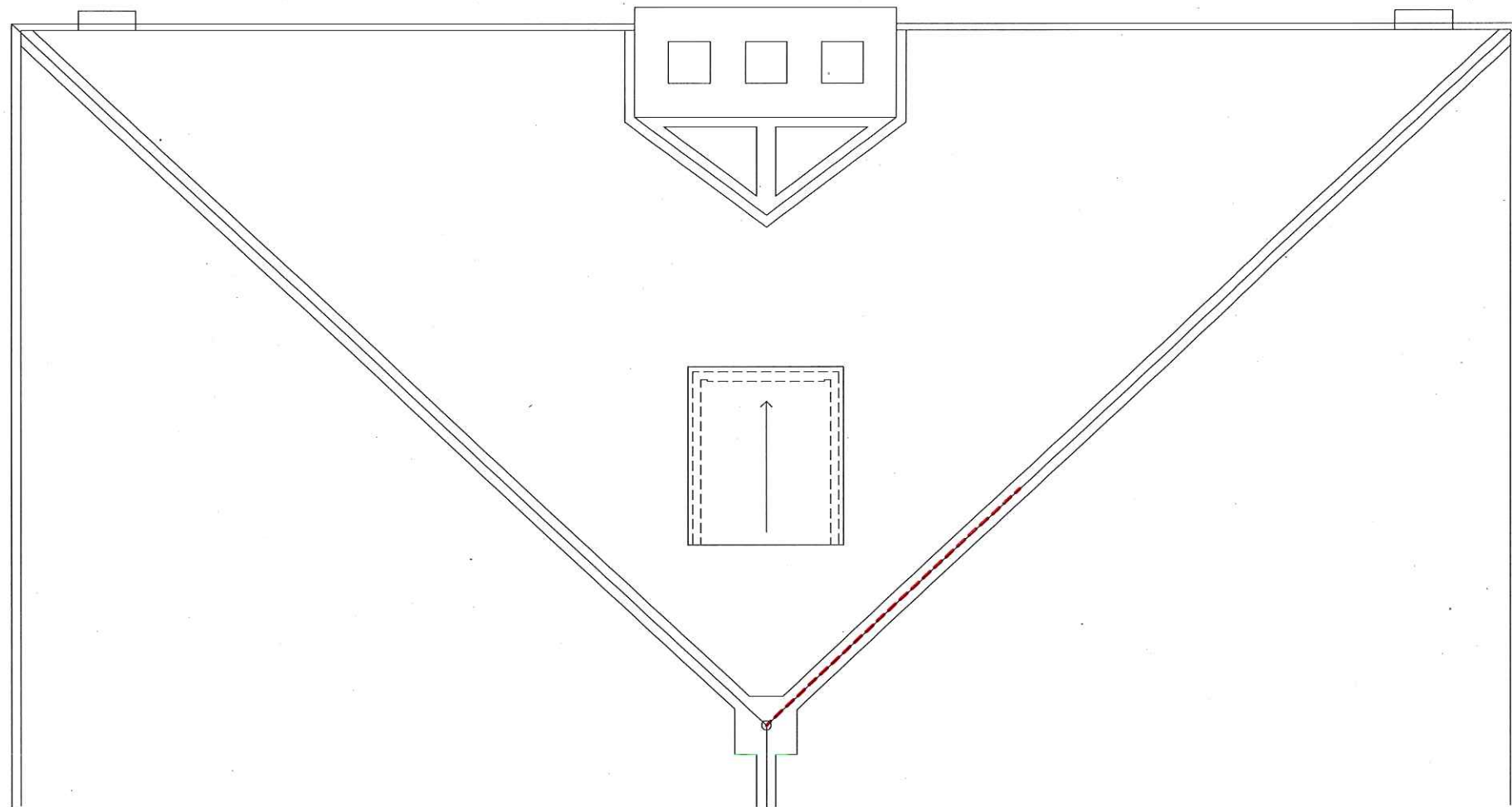

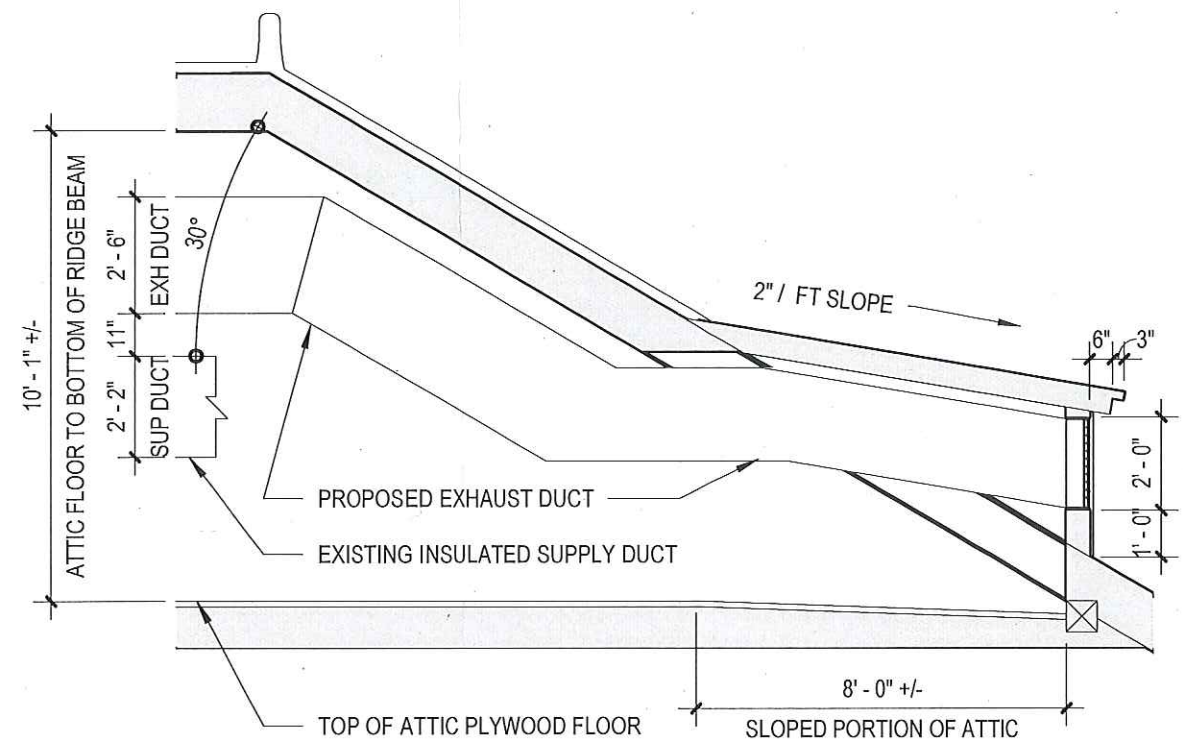
2 North Elevation  
1/8" = 1'-0"



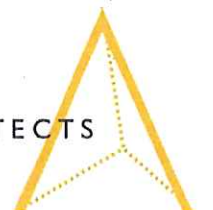
3 East Elevation

1/8" = 1'-0"



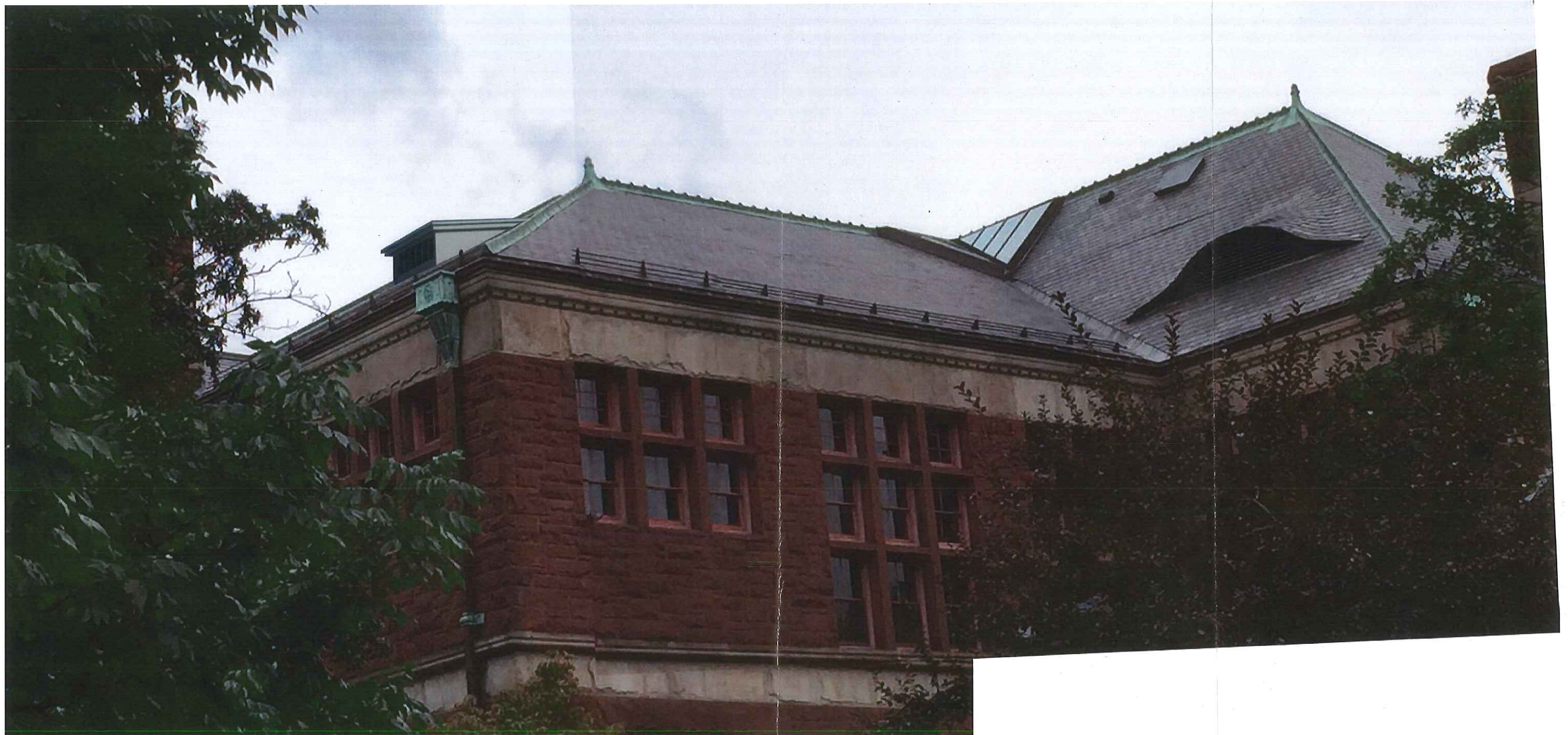
4 Section through Louver
