CHAIR NICOLE MURATI FERRER: So these have been created and reviewed and I say we move forward in adopting them and requiring people to use them when they are applying for entertainment and liquor licenses.

CHIEF GERALD REARDON: So moved.

CHAIR NICOLE MURATI FERRER: Okay. Sounds good. We are done.

Just for the record, I did talk to the Law Department and they say that the City of Cambridge has adopted remote participation, so in the event that there's like five exceptions, two of which I can think of that may apply continuously to our Commission, is geographical location and then some type of illness, and so we can call one of the Commissioners in if one of those applies or the other four and we can proceed with a meeting, if need be. Okay, that's it.
