The Planning Board of the City of Cambridge will hold a public hearing on **June 29, 2021 at 6:30 p.m.**, conducted remotely (see below for directions) on a Zoning Petition by the City Council to amend Article 22.000 of the Zoning Ordinance of the City of Cambridge to add a new section 22.24.4 Emissions Accounting.

The proposed amendments would require applicants of most Green Building Projects to provide an accounting of the emissions generated by construction to the Community Development Department (CDD) before receiving an occupancy permit. This requirement would not apply to any residential buildings that include affordable units. The submission would include information about expected annual emissions, lifetime expected emissions, and total emissions. The Zoning Petition identifies specific types of emissions that shall and shall not be included in each of these calculations. The amendments would also require applicants to present a payment schedule for how to zero out the total emissions of the building, using a social cost of carbon formula approved by CDD, with the outstanding balance acting as a lien on the property in case it is sold and a specified list of acceptable offsets.
