Decision

The Planning Board <u>DENIES</u> the requested Special Permit as the applicant has indicated that any new construction on the site will conform to requirements of the Parkway Overlay District and will not require any waiver from the dimensional requirements of that District. At the public hearing the Planning Board had urged the applicant to consider modifications to the proposal that would bring it more closely into conformance with the spirit of the Overlay District. Nothing in this denial is meant to prohibit the applicant from petitioning the Board in the future should some variation from

the requirements of the Parkway Overlay District be desired.
