## Decision

At the Planning Board meeting of September 20, 2005, the Planning Board found that the applicant had not made an effort to comply with previous Board of Zoning Appeal and Planning Board decisions to install and maintain landscaping as required. They also found that the applicant failed to communicate a request to extend the time for deliberation on the Major Amendment request for the increased signage and canopy size within the Parkway Overlay District.

Voting to deny the Major Amendment were T. Anninger, B. Shaw, H. Russell, P. Winters, T. Carpenter, W. Tibbs, and J. Molinsky, Associate Member appointed to act on this petition, constituting more than two thirds of the membership of the Planning Board.
