

NARRATIVE DESCRIPTION

SPECIAL PERMIT APPLICATION

2440 Massachusetts Avenue North Cambridge MA (Buy-Rite Liquors) 6-30-97

To the Planning Board of the City of Cambridge:

A special permit is requested to install and operate a "water vending unit" at the above referenced address.

Site improvements will include a new concrete pad with landscaping around the immediate area of the pad (Refer to dwg. A1 dated 6-30-97).

A modular (prefabricated) enclosure approximately 10 feet wide, 8 feet deep and 9 feet high will be installed on top of the new pad. The modular unit will not be connected to the existing building.

Power and domestic water will be fed underground to the modular unit from the adjacent building.

A dry well is typically constructed adjacent to the unit to contain the discharge from the water filters, which will only contain impurities currently found within the Cambridge water supply.

The proposed use would be accessory (subordinate and incidental) to the principal retail sale of liquors.

This would be a "self serve" operation with the customer inserting their own container into one of several doors in the front of the unit, inserting the proper change, and removing their container filled with filtered City of Cambridge water.
