


















Existing Site Boundary

Aerial View — Approved Zoning Massing










Aerial View from South Binney Street Corner






Ground Floor Plan




Second Floor Plan






Fifth Floor Plan with Lower Penthouse




Sixth Floor Plan with Lower Penthouse Roof









(a) Short-Term Bicycle Parking:

 $0.06 \times 370,462 \text{ GFA} = 22 \text{ Spaces required}.$

(b) Long-Term Bicycle Parking:

 $0.22 \times 370,462 \text{ GFA} = 82 \text{ Spaces required}.$

(c) Large Long-Term Bicycle Parking:

Where 20 or more bicycle parking spaces are required, at least 5% of the spaces must be 10 feet long instead of 8 feet to allow space for tandems and trailers. These spaces are included in the long term bicycle parking count.
