We are seeking approval to construct a one car garage.

The proposed project is located at the rear of the property which will minimize visibility from Brattle Street. The space is currently being used by two open parking spots, a trash storage shed and a bike/ utility shed. As part of the proposed work the trash and bike sheds will be incorporated into the new structure.

The proposed building responds carefully to its context- the overall height is as low as we can make it and, by working with two visually distinct pieces the overall mass will be lessened.

The exterior will be clad with wood shiplap siding similar to the main house. It will have painted wood cornerboards, a painted wood frieze, eave and soffit. The roof will be flat seam soldered copper.
