Application from First Church of Christ, Scientist, for permission to hang our Thanksgiving banner

Dear Mr. Sullivan and Commissioners:

I am writing as the contact ("proponent") for the efforts of my church, First Church of Christ, Scientist, Cambridge, at 13 Waterhouse Street, to get permission to hang a temporary banner advertising our Thanksgiving Day church service, open to the public. We have displayed this banner before but want to post it for a longer time this year, Monday Nov. 7 through Thanksgiving Day. We also hope that after going through this formal request for permission from the Commission this year, we can apply in following years and have our request handled at the staff level. We have this service every year on Thanksgiving Day, and seek a wider window of time in which to invite the public.

The following documents are attached:

- 1. Application for Certificate, as signed by Mary Gottschalk as clerk of the church, on behalf of the executive board of the church ("owner of record").
- 2. An image of the banner, which measures 6 x 2 ½ feet.
- 3. A detail image of the banner as it was hung a few years ago.
- An image of the whole church, to provide some context. Note that the banner hung over the middle door.

As I mentioned in my conversation with Sarah Burks yesterday, and also note in the application, we are considering installing permanent hardware to make hanging the banner a little simpler. She gave me some useful suggestions on hardware on which I'm sure we'll follow up.


