BLUESTONE PAVERS ON STONEDUST - PEDESTRIAN

NOTE:

1. PROVIDE EXP. JOINT WITH SEALANT WHERE CONC, PAVEMENT ABUTS CURBS, WALLS, OR EXISTING PAVEMENT.

2. INISTALL EXPANSION JOINTS AT 4-50-0° O.C. OR AS SHOWN ON DRAWING.

3. INISTALL EXPANSION JOINTS AT CAST IN PLACE FURNISHINGS, BIKE RACKS, BOLLARDS, SIGN POSTS, LIGHT POSTS, ETC.


4. THICKEN CONCRETE TO 10° AT EDGES WHERE ABUTTING UN-CURBED FUTURE PLANTING OR LAWN AREAS.

5. CONTROL JOINTS TO BE SAWCUT UNLESS NOTED OTHERWISE.


6. MEDIUM BROOM FINISH PERPENDICULAR TO PEDESTRIAN FLOW, NO WINDOW PANING

JOINT SEALANT TO BE RECESSED 1" CONTROL JOINT, SEE 1.5% CROSS SLOPE, TYP. (1.0% MIN, 2% MAX.) CAST IN PLACE CONCRETE PAVEMENT, WITH EXPOSED AGGREGATE BY TRIAD OR APPROVED EQUAL; REINFORCED WITH FIBERMESH ENLARGED PAVING PLAN FOR PATTERN COMPACTED DENSE GRADED CRUSHED STONE BASE 1/2" DIA. STAINLESS STEEL DOWEL 12" LONG 18" O.C. @ EACH EXP. JOINT, TYP SNOW MELT TUBING; REFER TO CIVIL DRAWINGS FOR LAYOUT AND SPECS. PREPARED SUBGRADE


EXPOSED AGGREGATE CONCRETE WITH SNOW MELT- VEHICULAR








