Ms. Nancy Goodwin, Commission Chair, called the meeting to order at 6:11pm. She reviewed the agenda as well as meeting procedures. She designated all alternates present would be voting.

MC-4979: 90 Hancock Street, by Paula Harwood. Alter basement windows.

Ms. Samantha Paull, staff, showed slides, gave an overview of the structure and application.

Ms. Paula Harwood, owner, gave an overview of the application's scope. She directed the Commission to her application packet photographs to show where the proposed window well would be located. She noted that a window well existed on the north elevation and she was proposing to match that.

Ms. Goodwin asked if the applicant would be doing any other alterations to the exterior of the building. Ms. Hardwood replied no, that the other components of the project were only interior.

Mr. Redmon asked if the scope was limited to one opening area with two Windows or if there were other area that would be impacted. Ms. Hardwood replied it was only the one window on the front elevation.

Ms. Goodwin asked if they were doing planting around the area. Ms. Hardwood replied yes, she hoped to. Ms. Goodwin said screening it from the street would be helpful.

Ms. Caroline Burley, abutter, expressed her concern with the safety of the design of the window well and an ongoing concern with open trenches.

Ms. Goodwin said that the proposed plans did not appear to include any additional safety measures. Ms. Harwood said she was happy to address safety issues. Mr. Redmon said that the safety of the well was within the purview of the Building Code regulations and recommended Ms. Harwood follow up with her inspector.

Ms. Paull added that that if a guard rail was added, she would need to return to staff for review.

Ms. Goodwin asked what was proposed for the exterior material of the well. Contractor - isn't certain of the material. Ms. Hardwood said that she was proposing to match the existing well, with cobblestones.
